She is skilled at working within the juvenile justice system and the health and human services systems of the District of Columbia and surrounding areas.

To assist in promoting healthy birth outcomes and decreasing the high infant mortality rates in the District, she became the Director of Family Support Services and Licensed Professional Counselor at Healthy Babies Project, where she managed the Healthy Start program that provided home visitation, case management to pregnant teens & women and their families.

Her passion is working with and advocating for teen clients. She currently is a Forensic Professional Counselor for the Office of Rehabilitation and Development for the Public Defender Service of Washington, DC, as well as an Adjunct Professor for the Georgetown University Juvenile Justice Clinic.

Ms. Brown is committed to tackling the effects of trauma on families, as well as shattering the stigma associated with mental illness. She works with clients from a strength-based, positive, and affirming perspective.
