A bill for an act

1.1 relating to criminal justice; modifying the thresholds for certain controlled
1.2 substance crimes; creating new offenses specific to the possession of marijuana
1.3 plants; creating a new offense for possessing trace amounts of certain controlled
1.4 substances; eliminating mandatory minimum sentences for lower level controlled
1.5 substance crimes; establishing a new account in the state treasury; appropriating
1.6 money while reducing other appropriations; amending Minnesota Statutes 2014,
1.7 sections 152.01, subdivision 16a, by adding a subdivision; 152.021; 152.022;
1.8 152.023; 152.024; 152.025; 152.026; 152.092; 152.18, subdivision 1; 244.0513,

1.17 commission of the offense for which the person is convicted under this chapter, the
1.18 person ~~received a disposition for a felony-level offense under section 152.18, subdivision~~
1.19 ~~1,~~ was convicted in Minnesota of a felony violation of this chapter or a felony-level
1.20 attempt or conspiracy to violate this chapter ~~was convicted of a violation of section~~
1.21 152.021 or 152.022, including an attempt or conspiracy, or was convicted elsewhere ~~for~~
1.22 ~~conduct that would have been a felony under this chapter if committed in Minnesota. An~~
1.23 ~~earlier disposition for a felony-level offense under section 152.18, subdivision 1, or an~~

**244.0513 CONDITIONAL RELEASE OF NONVIOLENT CONTROLLED
SUBSTANCE OFFENDERS; TREATMENT.**

Subd. 6. **Extension of term of imprisonment for offenders who fail in treatment.** When an offender fails to successfully complete the chemical dependency treatment program under this section, the commissioner shall add the time that the offender was participating in the program to the offender's term of imprisonment. However, the offender's term of imprisonment may not be extended beyond the offender's executed sentence.
