AN ACT

To require the Administrator of the Small Business Administration to submit to Congress a report on the entrepreneurial challenges facing entrepreneurs with a disability, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Entrepreneurs with
3 Disabilities Reporting Act of 2024”.

4 **SEC. 2. REPORT ON ENTREPRENEURSHIP CHALLENGES OF**
5 **ENTREPRENEURS WITH DISABILITIES.**

6 (a) IN GENERAL.—Not later than 180 days after the
7 date of the enactment of this Act, the Administrator of
8 the Small Business Administration shall submit to Con-
9 gress a report on the challenges that entrepreneurs with
10 a disability encounter with starting and operating a busi-
11 ness, including—

12 (1) an assessment of the challenges and needs
13 of entrepreneurs with a disability;

14 (2) a description of the resources and support
15 that the Small Business Administration provides to
16 entrepreneurs with a disability;

17 (3) a description of outreach to entrepreneurs
18 with a disability by the Small Business Administra-
19 tion, including by district and regional offices of the
20 Small Business Administration, small business devel-
21 opment centers (as defined in section 3(t) of the
22 Small Business Act (15 U.S.C. 632(t))), and wom-
23 en’s business centers (as defined in section 29(a) of
24 such Act (15 U.S.C. 656(a)));

25 (4) a description of any joint efforts between of-
26 fices of the Small Business Administration or the

1 Small Business Administration and other Federal
2 agencies to advance the goal of supporting the eco-
3 nomic success of entrepreneurs with a disability;

4 (5) any deficiencies in the resources and sup-
5 port described under paragraph (2);

6 (6) a description of the use of, and access to,
7 resources of the Administration by entrepreneurs
8 with a disability; and

9 (7) any recommendations for legislative actions
10 that are necessary to address the challenges or needs
11 of entrepreneurs with a disability that are identified
12 in the report.

13 (b) COMPLIANCE WITH CUTGO.—No additional
14 amounts are authorized to be appropriated to carry out
15 this Act.
