## 2023 SENATE BILL 73

February 21, 2023 - Introduced by Senators JACQUE, TAYLOR and CABRAL-GUEVARA, cosponsored by Representatives BODDEN, BRANDTJEN, ORTIZ-VELEZ, DRAKE, ALLEN, ANDRACA, BEHNKE, DONOVAN, GUNDRUM, MURSAU, PENTERMAN, SINICKI, STUBBS, SUBECK, WICHGERS and BALDEH. Referred to Committee on Judiciary and Public Safety.

1     **AN ACT** *to amend* 20.455 (2) (hd) and 48.48 (19); and *to create* 20.437 (1) (hf),  
2             814.75 (28), 814.76 (21), 944.35 and 973.05 (2m) (fr) of the statutes; **relating**  
3     **to:** prostitution crime surcharge and making an appropriation.

### *Analysis by the Legislative Reference Bureau*

Under current law, the court must impose on a defendant who has been found guilty of a criminal offense certain surcharges, which are in addition to any applicable fines, costs, and fees. For instance, the court must impose a crime victim and witness assistance surcharge in an amount of \$67 for each conviction of a misdemeanor count and in an amount of \$92 for each conviction of a felony count. The surcharge amounts collected reimburse counties for services provided to victims and witnesses of crimes.

This bill creates a \$5,000 surcharge to be imposed on persons who are convicted of patronizing or soliciting prostitutes, pandering, or keeping a place of prostitution. Under the bill, the surcharge amounts collected are used for treatment and services for sex-trafficking victims and for criminal investigative operations and law enforcement relating to Internet crimes against children.

**SENATE BILL 73****SECTION 1**

1           **SECTION 1.** 20.437 (1) (hf) of the statutes is created to read:

2           20.437 (1) (hf) *Sex-trafficking victim services.* All moneys received from the  
3 prostitution crime surcharge as authorized under s. 944.35, for treatment and  
4 services for sex-trafficking victims under s. 48.48 (19).

5           **SECTION 2.** 20.455 (2) (hd) of the statutes is amended to read:

6           20.455 (2) (hd) *Internet crimes against children.* All moneys transferred under  
7 par. (Lp), 2017 Wisconsin Act 59, section 9228 (1p), and 2019 Wisconsin Act 9, section  
8 9227 (1), ~~shall be credited to this appropriation account~~ and all moneys received from  
9 the prostitution crime surcharge as authorized under s. 944.35, for criminal  
10 investigative operations and law enforcement relating to Internet crimes against  
11 children, prosecution of Internet crimes against children, and activities of state and  
12 local Internet crimes against children task forces.

13           **SECTION 3.** 48.48 (19) of the statutes is amended to read:

14           48.48 (19) To purchase or provide treatment and services for children who are  
15 the victims of trafficking, as defined in s. 940.302 (1) (d), for purposes of a commercial  
16 sex act, as defined in s. 940.302 (1) (a). Within the availability of funding under s.  
17 20.437 (1) (e) and (hf), the department shall ensure that that treatment and those  
18 services are available to children in all geographic areas of the state, including both  
19 urban and rural communities.

20           **SECTION 4.** 814.75 (28) of the statutes is created to read:

21           814.75 (28) The prostitution crime surcharge under s. 944.35.
