(a) A person commits the crime of organized 6 theft if the person individually or jointly violates AS 11.46.120 or 11.46.130 in 7 coordination with a group of three or more persons who have committed or attempted 8 to commit two or more violations of AS 11.46.120 or 11.46.130 for the benefit of, at 9 the direction of, or in association with the group. 10 (b) Organized theft is a class A felony.
