Analysis

This bill allows individuals aged 18 through 20 to sell, serve, deliver, or dispense alcoholic beverages on certain licensed premises and removes supervision of individuals aged 18 through 20.

If enacted, the Alcohol and Marijuana Control Office would need to update online licensing systems and case management system in order to permit these activities under this license and endorsement types, as well as amend and notice updated regulations.

One-time services costs in FY2025:
