# FOR AN ACT ENTITLED

### 1 "An Act relating to the crimes of coercion and bribery involving legislators; and 2 providing for an effective date." 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA: 4 \* Section 1. AS 11.41.530(a) is amended to read: 5 (a) A person commits the crime of coercion if, under circumstances not 6 proscribed under AS 11.41.410 - 11.41.427, the person compels another to engage in 7 conduct from which there is a legal right to abstain or abstain from conduct in which 8 there is a legal right to engage, by means of instilling in the person who is compelled a 9 fear that, if the demand is not complied with, the person who makes the demand or 10 another may 11 (1) inflict physical injury on anyone, except under circumstances 12 constituting robbery in any degree, or commit any other crime; 13 (2) accuse anyone of a crime; 14 (3) expose confidential information or a secret, whether true or false,

1	tending to subject a person to hatred, contempt, or ridicule or to impair the person's
2	credit or business repute;
3	(4) take or withhold action as a public servant or cause a public servant
4	to take or withhold action;
5	(5) bring about or continue a strike, boycott, or other collective
