- 5 and lieutenant governor, who are in the exempt service under AS 39.25.110, are not members
- 6 of a collective bargaining unit established under AS 23.40.070 23.40.260 (Public
- 7 Employment Relations Act), and are not otherwise covered by AS 39.27.011(a) are entitled to
- 8 receive salaries comparable to those received by classified and partially exempt employees of
- 9 the executive branch under AS 39.27.011(a), as repealed and reenacted by sec. 1 of this Act,
- and under AS 39.27.011(e) and (f), as amended by secs. 2 and 3 of this Act.

- bargaining unit established under AS 23.40.070 23.40.260 (Public Employment Relations
- Act) and are not otherwise covered by AS 39.27.011(a) are entitled to receive salary
- 18 adjustments comparable to those received by classified and partially exempt employees of the
- executive branch under AS 39.27.011(a), as repealed and reenacted by sec. 1 of this Act, and
