A BILL

FOR AN ACT ENTITLED

1 **"An Act relating to carbon storage on state land; relating to the powers and duties of the**
2 **Alaska Oil and Gas Conservation Commission; relating to deposits into the permanent**
3 **fund; establishing the carbon storage closure trust fund and carbon dioxide storage**
4 **facility administrative fund; relating to geothermal resources; relating to carbon storage**
5 **exploration licenses; relating to carbon storage leases; relating to carbon storage**
6 **operator permits; relating to enhanced oil or gas recovery; relating to long-term**
7 **monitoring and maintenance of storage facilities; relating to carbon oxide sequestration**
8 **tax credits; relating to the Regulatory Commission of Alaska and regulation of the**
9 **service of natural gas storage; relating to the regulation of liquefied natural gas import**
10 **facilities; relating to the oil and gas production tax; relating to the duties of the**
11 **Department of Natural Resources; relating to carbon dioxide pipelines; relating to**
12 **reserve-based state loans for oil and gas development projects in the Cook Inlet**

1 **sedimentary basin; relating to the Alaska Industrial Development and Export**
 2 **Authority; requiring the Alaska Industrial Development and Export Authority to report**
 3 **to the legislature on oil and gas projects with potential to increase oil and gas production**
 4 **from the Cook Inlet sedimentary basin; relating to an audit of carbon storage leases**
 5 **conducted by the legislative audit division; and providing for an effective date."**

6 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

7 * **Section 1.** The uncodified law of the State of Alaska is amended by adding a new section
 8 to read:

9 SHORT TITLE. This Act may be known as the Carbon Capture, Utilization, and
 10 Storage Act.

11 * **Sec. 2.** AS 31.05.027 is amended to read:

12 **Sec. 31.05.027. Land subject to commission's authority.** The authority of the
 13 commission applies to all land in the state lawfully subject to its police powers,
 14 including land of the United States and land subject to the jurisdiction of the United
 15 States. The authority of the commission further applies to all land included in a
 16 voluntary cooperative or unit plan of development or operation entered into in
 17 accordance with AS 38.05.180(p) or 38.05.725.

18 * **Sec. 3.** AS 31.05.030(m) is amended to read:

19 (m) The commission has jurisdiction and authority over all persons and
 20 property, public and private, necessary to carry out the purposes and intent of
 21 AS 41.06, except for provisions in AS 41.06.005 - 41.06.060 and 41.06.305
 22 [AS 41.06] for which the Department of Natural Resources has jurisdiction.

23 * **Sec. 4.** AS 37.05.146(c) is amended by adding new paragraphs to read:

24 (86) carbon dioxide storage facility administrative fund
 25 (AS 41.06.160);

26 (87) carbon storage closure trust fund (AS 37.14.850).

27 * **Sec. 5.** AS 37.13.010(a) is amended to read:

28 (a) Under art. IX, sec. 15, of the state constitution, there is established as a
 29 separate fund the Alaska permanent fund. The Alaska permanent fund consists of

1 (1) 25 percent of all mineral lease rentals, royalties, royalty sale
 2 proceeds, net profit shares under AS 38.05.180(f) and (g), and federal mineral revenue
 3 sharing payments received by the state from mineral leases issued on or before
 4 December 1, 1979, and 25 percent of all bonuses received by the state from mineral
 5 leases issued on or before February 15, 1980;

6 (2) 50 percent of all mineral lease rentals, royalties, royalty sale
 7 proceeds, net profit shares under AS 38.05.180(f) and (g), **carbon storage injection**
 8 **royalties required under AS 38.05.705(c)(3)(B)**, and federal mineral revenue sharing
 9 payments received by the state from mineral leases issued after December 1, 1979, and
 10 50 percent of all bonuses received by the state from mineral leases issued after
 11 February 15, 1980; and

15 **Article 11. Carbon Storage Closure Trust Fund.**

16 **Sec. 37.14.850. Carbon storage closure trust fund.** (a) The carbon storage
 17 closure trust fund is established as a separate trust fund of the state outside and
 18 separate from the general fund. The legislature may appropriate the principal and
 19 earnings of the fund for the purpose of protecting the public interest in maintaining
 20 and closing carbon storage facilities in the state. Money in the fund does not lapse.

21 (b) The carbon storage closure trust fund consists of payments received under
 22 AS 41.06.175 and earnings on the fund. The payments received for each storage
 23 facility shall be separately accounted for under AS 37.05.142. The commissioner of
 24 revenue is a fiduciary of the fund. The commissioner of revenue shall manage and
 25 invest the fund assets as provided in AS 37.10.071.

26 (c) The commissioner of natural resources may make expenditures from the
 27 carbon storage closure trust fund for the purpose of conducting long-term monitoring
 28 and maintenance of a storage facility under AS 41.06.305. If a storage operator is
 29 unable to fulfill the storage operator's duties and the financial assurance provided by
 30 the storage operator under AS 41.06.110(c)(2) is exhausted or insufficient, the Alaska
 31 Oil and Gas Conservation Commission may make expenditures from the fund for the

1 purposes allowed under AS 41.06.105 - 41.06.210.

2 (d) Nothing in this section creates a dedicated fund.

3 (e) In this section,

4 (1) "fund" means the carbon storage closure trust fund;

5 (2) "storage facility" and "storage operator" have the meanings given
6 in AS 41.06.210.

7 * **Sec. 7.** AS 38.05.069(e) is amended to read:

8 (e) Nothing in (c) of this section affects the disposal of minerals under
9 AS 38.05.135 - 38.05.183 **or carbon storage under AS 38.05.700 - 38.05.795.**

10 * **Sec. 8.** AS 38.05.070(a) is amended to read:

11 (a) Land, including tide, submerged, or shoreland, to which the state holds title
12 or to which **the state** [IT] may become entitled, may be leased, except for the
13 extraction of natural resources **and for carbon storage under AS 38.05.700 -**
14 **38.05.795,** in the manner provided in AS 38.05.070 - 38.05.105.

15 * **Sec. 9.** AS 38.05.130 is amended to read:

16 **Sec. 38.05.130. Damages and posting of bond.** Rights may not be exercised
17 by the state, its lessees, successors, or assigns under the reservation as set out in
18 AS 38.05.125 until the state, its lessees, successors, or assigns make provision to pay
19 the owner of the land full payment for all damages sustained by the owner, by reason
20 of entering **onto** [UPON] the land. If the owner for any cause refuses or neglects to
21 settle the damages, the state, its lessees, successors, assigns, or an applicant for a lease
22 or contract from the state for the purpose of prospecting for valuable minerals, or
23 option, contract, or lease for **carbon storage or** mining coal or **a** lease for extracting
24 geothermal resources, petroleum, or natural gas, may enter **onto** [UPON] the land in
25 the exercise of the reserved rights after posting a surety bond determined by the
26 director, after notice and an opportunity to be heard, to be sufficient as to form,
27 amount, and security to secure to the owner payment for damages, and may institute
28 legal proceedings in a court where the land is located, as may be necessary to

31 (a) Except as otherwise provided, valuable mineral deposits in land belonging

1 to the state shall be open to exploration, development, and the extraction of minerals.
 2 All land, together with tide, submerged, or shoreland, to which the state holds title to
 3 or to which the state may become entitled, may be obtained by permit or lease for the
 4 purpose of exploration, development, and the extraction of minerals. Except as
 5 specifically limited by AS 38.05.131 - 38.05.181 and 38.05.700 - 38.05.795, land may
 6 be withheld from lease application on a first-come, first-served basis, and offered only
 7 on a competitive bid basis when determined by the commissioner to be in the best

 7 exclusive right, for a period of **five** [TWO] years, to prospect for geothermal resources
 8 on state land included under the **license** [PERMIT]. The commissioner has discretion
 9 to renew the **license** [PERMIT] for an additional one-year term. A holder of a
 10 prospecting **license** [PERMIT] has the right, **after completion of an agreed-on work**
 11 **commitment** [UPON THE SHOWING OF A DISCOVERY OF GEOTHERMAL

 16 expiration of the **license** [PERMIT]. If the land included within the **license** [PERMIT]
 17 is designated a competitive geothermal area during the **license** [PERMIT] term, the
 18 **licensee** [PERMITTEE] must apply for a noncompetitive lease within 30 days after
 19 notification of the designation or forfeit the conversion privileges and the exclusive
 20 right to prospect.

22 (d) On state land that is designated a competitive geothermal area and is not
 23 subject to an existing prospecting **license** [PERMIT], the commissioner may issue
 24 geothermal leases to the highest bidder by competitive bidding procedures established
 25 by regulations adopted by the commissioner. At the discretion of the commissioner,
 26 competitive lease sales may be by oral or sealed bid, on the basis of a cash bonus,
 27 profit share, or royalty share.

29 (e) Prospecting **licenses** [PERMITS] and geothermal leases granted under this

 14 COMMERCIAL PRODUCTION AND AT 10-YEAR INTERVALS THEREAFTER,

25 **Article 15A. Carbon Storage Exploration Licenses; Leases.**

26 **Sec. 38.05.700. Applicability; regulations.** (a) The provisions of
 27 AS 38.05.700 - 38.05.795 apply to the licensing of state land for carbon storage
 28 exploration and the leasing of state land for carbon storage.

29 (b) The commissioner may adopt regulations necessary to implement
 30 AS 38.05.700 - 38.05.795.

31 **Sec. 38.05.705. Carbon storage exploration licensing.** (a) The commissioner

1 may issue carbon storage exploration licenses on state land.

2 (b) A carbon storage exploration license gives the licensee

3 (1) the exclusive right to explore, for carbon storage purposes, the state
4 land described in the license for a five-year term; and

5 (2) the option to convert the license for all or part of the state land
6 described in the license into a carbon storage lease after the licensee complies with the
7 lease conversion process described in AS 38.05.715.

8 (c) A carbon storage exploration license must

9 (1) be conditioned on the posting of a bond or other security acceptable
10 to the department and in favor of the state;

11 (2) be conditioned on an obligation by the licensee to fulfill a specified
12 work commitment as set out in the license; the work commitment must include
13 mandatory provisions for

14 (A) an annual fee paid by the licensee to the department in an
15 amount that is at least \$20 an acre, subject to the license; and

16 (B) an annual report describing the licensee's exploration
17 activities in the previous calendar year, which the licensee shall provide to the
18 department; and

19 (3) include proposed commercial terms that apply if the license is
20 converted into a carbon storage lease, which must, at a minimum, provide for

21 (A) an annual rent of at least \$20 an acre; and

22 (B) a charge on injected volumes of carbon dioxide of at least
23 \$10 a ton.

24 (d) The commissioner may revoke a carbon storage exploration license before
25 the termination of the five-year term of the license if the licensee fails to comply with
26 the requirements of (c) of this section or applicable regulations.

27 (e) The department may renew a carbon storage exploration license for a term
28 sufficient to determine whether the licensee's permit application will be accepted
29 under AS 41.06.105 - 41.06.210 if the licensee

30 (1) before the expiration of the license, applies for a permit under
31 AS 41.06.120;

1 (2) is in compliance with the conditions of the license;
2 (3) provides documentation acceptable to the department of the
3 pending permit application; and
4 (4) submits to the department an executed renewal form affirming the
5 original terms of the license for the term of the renewed license.

6 (f) A carbon storage exploration license that has been renewed under (e) of
7 this section terminates immediately if the Alaska Oil and Gas Conservation
8 Commission denies the licensee's permit application under AS 41.06.105 - 41.06.210.

9 (g) The dollar amounts in (c) of this section shall increase every five years in
10 proportion to the Consumer Price Index for urban consumers for urban Alaska, as
11 determined by the United States Department of Labor, Bureau of Labor Statistics. The
12 index for January 2024 is the reference base index.

13 (h) A charge on injected volumes of carbon dioxide required under (c)(3)(B)
14 of this section or as altered by the commissioner under AS 38.05.715(c) is a royalty
15 for the purposes of the Alaska permanent fund under AS 37.13.010.

16 **Sec. 38.05.710. License procedures.** (a) To apply for a carbon storage
17 exploration license under AS 38.05.705, an applicant shall submit to the commissioner
18 a proposal that

19 (1) identifies the specific area to be subject to the license;
20 (2) proposes minimum work commitments;
21 (3) proposes commercial terms applicable to a carbon storage lease
22 that satisfy the requirements of AS 38.05.705(c)(3);
23 (4) demonstrates the applicant's ability to assume responsibility of a
24 carbon storage lease;
25 (5) describes how the applicant meets the minimum qualifications for a
26 licensee under applicable regulations; and
27 (6) includes an attestation of the applicant's ability to perform the
28 requirements of (2) - (4) of this subsection.

29 (b) The commissioner shall publish notice of a proposal received under (a) of
30 this section. The notice must include a solicitation for competing proposals. The
31 commissioner shall send a copy of the published notice to each lessee under

1 AS 38.05.135 - 38.05.181 within one-half mile of the area proposed for the
2 exploration license. Any person may submit a competing proposal, including a
3 proposal for the authorization of subsurface storage of oil or gas under
4 AS 38.05.180(u), under the process established by the commissioner in regulation.
5 The regulations must require that a competing proposal be submitted not later than 90
6 days after the commissioner's notice is published.

7 (c) After the period for submission of competing proposals has passed, the
8 commissioner shall issue a written finding determining whether issuance of a carbon
9 storage exploration license is in the best interests of the state. If the commissioner
10 determines that issuance of a carbon storage exploration license is in the best interests
11 of the state, the finding must

12 (1) describe the limitations, stipulations, and conditions of the license
13 and any changes to the conditions detailed in the proposal submitted under (a) of this
14 section, or a competing proposal, that are required before issuance of the exploration
15 license;

16 (2) set out the commercial terms required for the eventual conversion
17 of the exploration license into a carbon storage lease;

18 (3) if there are competing proposals from multiple applicants, identify
19 which applicants are qualified for the issuance of the exploration license and include
20 information about the competitive bid process as set out in (e) of this section; and

21 (4) include a copy of the exploration license to be issued and the form
22 of lease that will be used for any portion of the exploration license area that is later
23 converted to a lease under AS 38.05.715.

24 (d) If the commissioner determines that issuance of a carbon storage
25 exploration license is in the best interests of the state and that only one applicant is
26 qualified for a license, the applicant may accept or reject the exploration license, as
27 limited or conditioned by the terms of the finding made under (c) of this section and in
28 the form of lease attached to the finding, not later than 30 days after the date the
29 finding was issued. The applicant shall accept or reject the issuance of the carbon
30 storage exploration license in writing. If an applicant fails to respond within 30 days
31 after the finding was issued, the commissioner shall consider the applicant's failure to

1 respond as a rejection of the license.

2 (e) If the commissioner determines that issuance of a carbon storage
3 exploration license is in the best interests of the state and that more than one applicant
4 is qualified for a license, the commissioner shall issue a request for competitive sealed
5 bids, under procedures adopted by regulation, to determine which qualified applicants
6 will receive a license. If the commissioner determines that a competitive bid process is
7 necessary, the best interest finding made under (c) of this section must include notice
8 that the commissioner intends to request competitive bids.

9 (f) The commissioner shall establish in regulation the criteria for the
10 assessment of competitive bids under (e) of this section and for the determination of a
11 successful bidder.

12 (g) If a lessee under AS 38.05.135 - 38.05.181 in the area covered by a
13 proposed carbon storage exploration license participates in a competitive bid process
14 under (e) of this section and is not the successful bidder, before issuing the license, the
15 commissioner shall provide the lessee an opportunity to match the successful bid. If
16 the lessee matches the successful bid, the commissioner shall issue a carbon storage
17 exploration license to the lessee.

18 (h) A carbon storage exploration license issued under this section and a carbon
19 storage lease under AS 38.05.715 or 38.05.720 must include

20 (1) a covenant from the licensee or lessee not to unreasonably interfere
21 with the rights of a lessee under AS 38.05.135 - 38.05.181; and

22 (2) a clause by which the licensee or lessee indemnifies the state for
23 any unreasonable interference the licensee or lessee might cause to the rights of a
24 lessee under AS 38.05.135 - 38.05.181.

25 (i) When notice is required under this section, the
26 department shall follow the requirements for notice under
27 AS 38.05.945(b) and (c).

28 **Sec. 38.05.715. Conversion to lease by licensee.** (a) The commissioner may
29 convert a carbon storage exploration license to a carbon storage lease if the licensee
30 complies with (b) of this section.

31 (b) To convert a carbon storage exploration license to a carbon storage lease, a

1 licensee shall provide to the commissioner a copy of the permit obtained under
2 AS 41.06.120. After receiving a copy of the permit, the commissioner may issue a
3 carbon storage lease for those areas of the exploration license approved for carbon
4 storage by the permit if the licensee has

5 (1) fulfilled the work commitments set out in the license;

6 (2) demonstrated the ability to meet the commercial terms for the lease
7 as set out in the license.

8 (c) Notwithstanding (b) of this section, if the commissioner determines that a
9 carbon storage project is in the best interests of the state and would not be
10 economically feasible under the commercial terms set by the license, the
11 commissioner may issue the carbon storage lease under alternative commercial terms.
12 A lease issued under this subsection must be supported by a written finding that
13 contains specific factual details justifying the decision, an explanation of the
14 commissioner's reasons for issuing the lease, and a description of the original terms
15 and the alternative terms of the lease. The finding must be published on the
16 commissioner's publicly available Internet website.

17 (d) A lease issued under this section must include

18 (1) commercial terms for the lease;

19 (2) the agreements required under AS 38.05.710(h); and

20 (3) any other condition or obligation the commissioner considers
21 necessary or that is required by regulation.

23 **carbon storage operations.** (a) A lessee under AS 38.05.180 shall acquire a carbon
24 storage lease before engaging in carbon storage activity that is not associated with
25 enhanced oil or gas recovery.

26 (b) At the commissioner's discretion, the commissioner may issue a carbon
