3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

- * **Section 1.** AS 42.05.141 is amended by adding new subsections to read:
- 5 (g) Except as provided in AS 42.05.711(q) and (s), the commission shall regulate under this chapter the service of natural gas storage and the service of liquefied natural gas storage, including storage furnished by operating a natural gas storage facility that is part of a
 - (1) pipeline facility operated by a pipeline carrier; or
- 10 (2) natural gas pipeline facility operated by a natural gas pipeline

- 12 (h) In (g) of this section, "natural gas pipeline carrier," "natural gas pipeline
- facility," "pipeline carrier," and "pipeline facility" have the meanings given in

2	(q) The service of natural gas storage furnished by operating a natural gas
3	storage facility that is [(1) PART OF A PIPELINE FACILITY OPERATED BY A
