9 A BILL
10 TO BE ENTITLED
11 AN ACT
12

13 Relating to the City of Jacksonville in Calhoun
14 County; to amend Act 2015-332, HB512 of the 2015 Regular
15 Session, altering, rearranging, and extending the corporate
16 limits of the city; to correct and restate the description of
17 the corporate limits to make technical corrections.

18 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

19 Section 1. Section 1 of Act 2015-332, HB512 of the
20 2015 Regular Session, is amended to read as follows:

21 "(a) Beginning at the NE corner of the SW1/4 of
22 Section 6, Township 14 South, Range 9 East, Calhoun County,
23 Alabama; thence ~~East~~ West along the north line of said quarter
24 to the NW corner of ~~NW1/4~~ NE1/4 of the said SW1/4; thence
25 S00°37'53''E along the West line of said quarter-quarter

1 thence S00°36'23''E 660.51 ft. to a point on the South line of
2 said forty; thence S00°37'54''E 447.11 ft. to a point; thence
3 S89°35'19''W 674.56 ft. to a point on the West forty line of
4 the SE1/4 of the SW1/4 of said section; thence S00°37'53''E
5 877.79 feet along said forty line to the SW corner of said
6 forty and also the SE corner ~~of the SW1/4~~ of the SW1/4 of the
7 SW1/4 of said Section 6; thence West along the South line of
8 said Section 6 and the South line of Section 1, Township 14
9 South, Range 8 East, to the SW corner of the SE1/4 of the
10 SE1/4 of said Section 1; thence North along the West line of
11 said SE1/4 of the SE1/4 to the NW corner thereof; thence East
12 along the North line of said SE1/4 of the SE1/4 to the NE
13 corner thereof; thence North along the East line of the NE1/4
14 of the SE1/4 of Section 1 to the NE corner of the SE1/4 of
15 said Section 1; thence West along the north line of SE1/4 and
16 of the SW1/4 of said Section 1 to the NE corner of the SE1/4
17 of Section 2, Township 14 South, Range 8 East; thence along
18 the north line of said SE1/4 to a point on the West ROW line
19 of Alabama Highway No. 21; thence North along said West ROW
20 line of Alabama Highway No. 21 to a point on said West ROW,
21 said point being S57°43.9'E of the SE corner of the Federal
22 Mogul Corporation property as described in Deed Book 3005,
23 Page 380, Probate Office, Calhoun County, Alabama; thence
24 N57°43.9'W across to a point on the West line of the Chief
25 Ladiga Trail (formerly the Norfolk Southern Railroad ROW),
26 said point being the SE corner of the Federal Mogul property;
27 thence continue N57°43.9'W along the South line of said

1 Federal Mogul property 995.37 ft. to a point on the East ROW
2 line of Calhoun County Road Project S.A.C.P.-A, known as Roy
3 Webb Road (said ROW being 40 ft. each side of a centerline);
4 thence Southerly along said East ROW of said road to its
5 intersection with the West line of the above cited Chief
6 Ladiga Trail at the intersection of Roy Webb Road and Alabama
7 Highway No. 21; thence South along the west line of the Chief
8 Ladiga Trail (formerly the Norfolk Southern Railroad ROW) to
9 its intersection with the North line of Section 11, Township
10 14 South, Range 8 East; thence West along said North line of
11 said Section 11 a distance of 740 feet, more or less, to the
12 NE corner of the NW1/4 of said Section 11; thence West along
13 the North line of the said NW1/4 to its intersection with the
14 original (and present) one and one-half mile circular city
15 limit boundary; thence Southwesterly along the arc of said
16 city limit boundary to its intersection with the North line of
17 the SW1/4 of the NW1/4 of said Section 11; thence West along
18 the North line of said SW1/4 of the NW1/4 and the North line
19 of the South 1/2 of the NE1/4 of Section 10, Township 14
20 South, Range 8 East to the NW corner of the SW1/4 of said
21 NE1/4; thence South along the north-south center line of said
22 Section 10 to its intersection with the North bank of the
23 Little Tallasseehatchee Creek; thence Easterly along said
24 North bank of said creek to its intersection with the North
25 ROW line of Alabama Highway 204; thence easterly along said
26 North ROW line of said highway to a point, said point being
27 N29°36'W 2625.6 feet from the SE corner of Section 10,

1 Township 14 South, Range 8 East; thence Southeasterly across
2 said Alabama Highway 204 to a point of the South ROW of said
3 highway, said point's location being described as commencing
4 at the SE corner of Section 10, T-14-S, R-8-E; thence
5 N-22°-49'-17"-W 1756.37 ft. to a point on the north line of
6 the Old Gadsden Road; thence along said north line of said
7 Road N-65°25'52"W 300.3 ft.; thence N-67°37'24"W 100.0 ft.;
8 thence N04°20'42"E 527.34 feet to the subject point; thence,
9 leaving said Alabama Highway 204, run S04°20'42"W 527.34 ft.
10 to a point on the North ROW line of Old Gadsden Road; thence
11 continue S04°20'42"W 25 feet, more or less, to the center of
12 said Old Gadsden Road; thence westerly along the center line
13 of said Road to the NW corner of Lot 1 of Hedgepath
14 Subdivision as recorded in Plat Book DD, Page 31, Probate
15 Office, Calhoun County, Alabama; thence Southeasterly along
16 the western line of said Hedgepath Subdivision to its
17 intersection with the original (and present) one and one-half
18 mile circular city limit boundary; thence Southwesterly along
19 the arc of said city limit boundary to its intersection with
20 the North line of the NE1/4 of Sec. 15, T14S, R8E; thence West
21 along said North line of said quarter to the NW corner of the
22 NW1/4 of the NE1/4 of said Section 15; thence South along the
23 West line of said 1/4-1/4 to the SW corner thereof; thence
24 East along the South line of said 1/4-1/4 to its intersection
25 with the original (and present) one and one-half mile circular
26 city limit boundary; thence Southeasterly along the arc of
27 said city limit boundary to its intersection with the West

1 line of the Chief Ladiga Trail (formerly the Norfolk Southern
2 Railroad ROW); thence South along said West line of said Trail
3 to its intersection with the West line of the NE1/4 of Sec.27,
4 T-14-S, R-8-E; thence South along said West line of 1/4 to its
5 intersection with the East line of said Trail, said point
6 being the rear corner of Lot 14, Addition No. 1 of Kaitlyn
7 Court as recorded in Plat Book GG, Page 46, Probate Office,
8 Calhoun County, Alabama; thence S01°41'11"E 1,042.32 ft.;
9 thence S78°11'03"-E 129.43 ft. to the SW corner of Lot 2,
10 Morris Addition as recorded in Plat Book y, Page 21, Probate
11 Office, Calhoun County, Alabama; thence SW along the West line
12 of said Morris Addition to the SW corner of Lot 1 of said
13 Morris Addition; thence turning left at an interior angle of
14 76°42" and along the South line of said Morris Addition to a
15 point on the West ROW line of Jacksonville-Weaver Road; thence
16 South along said West ROW of said road to a point which is
17 N82°41'W of the SE corner of the intersection of said road
18 with Valley Brook Drive SW as shown of the plat of First
19 Addition to Stoney Brook Subdivision recorded in Plat Book S,
20 Page 6, Probate Office, Calhoun County, Alabama; thence
21 S82°41'E across said Jacksonville-Weaver Road to the SE corner
22 of said intersection; thence ~~Southeasterly~~ Southwesterly along
23 the East ROW of said Road to its intersection with the west
24 ~~section~~ line of the ~~NE1/4 of SW1/4~~ SE1/4 of Section 27,
25 Township 14 South, Range 8 East; thence South along said west
26 ~~section~~ line to a point on the north property line of that
27 certain property conveyed to the H. Scott Stewart Trust in

1 Deed Book 1983, Page 1042, Probate Office, Calhoun County,
2 Alabama; thence Southeasterly along said north line of said
3 Stewart Trust property 100.0 feet; thence north and parallel
4 with said west ~~section~~ line to the SE corner of the property
5 deeded to Theodore J. Klimasewski, Jr., by deed dated August
6 13, 1982, and recorded in book 1564, Page 721, Probate Office,
7 Calhoun County, Alabama; thence Northeasterly and parallel
8 with the south ROW of said Jacksonville-Weaver Road to the
9 center of the Little Tallasseehatchee Creek; thence Easterly
10 along the meandering center line of said Creek to its
11 intersection with the ~~East section~~ North-South center line of
12 the NE1/4 of SE1/4 of Section 27, Township 14 South, Range 8
13 East; thence South along said ~~East~~ center line to the south
14 line of said quarter-quarter ~~to the SW corner thereof~~; thence

18 Section 25, Township 14 South, Range 8 East; thence East along
19 said South line of said NE1/4 of the NE1/4 of Section 25 and
20 the South line of the NW1/4 of the NW1/4 of Section 30,
21 Township ~~30, Township~~ 14 South, Range 9 East, to the ~~SW~~ SE
22 corner of Lot No. 6, Block A, according to the plat of Whites
23 Gap Estates Subdivision, First Addition, recorded in Plat Book
24 AA, Page 97, Probate Office, Calhoun County, Alabama; thence
25 Northeasterly along the East lot lines of said Lot No. 6 and
26 of Lot No. 7 in Block A of said subdivision to the NE corner
27 of said Lot No. 7; thence ~~Easterly~~ Westerly along the North

14 Northerly and parallel with the East line of said Lot 1 a

16 Dorothy Drive, so named on the plat of said subdivision;
17 thence East ~~182.74~~ 210.00 ft. along the South ROW line of said
18 Dorothy Drive to the NW corner of Lot 4, Block D, Whites Gap
19 Estates, 3rd Addition, as record in Plat Book BB, Page 39,
20 Probate Office, Calhoun County, Alabama; thence South ~~25.41~~
21 29.47 ft. to the ~~SE~~ SW corner of said Lot 4; thence
22 Southeasterly ~~335~~ 339.56 ft. along the south line of said Lot

17 quarter-quarter; thence West and parallel with the S line of
18 the NW1/4 of the NW1/4 of said Section a distance of ~~330~~ 267
19 feet; thence North and parallel with the E line of said
20 quarter-quarter ~~198~~ 239 ft.; thence West and parallel with the
21 S line of said quarter-quarter to the north-south center line
22 of said quarter-quarter; thence North along said center line

7 "(b) Subsection (a) shall not be operative until 90
8 days after ~~the effective date of this act~~ September 1, 2015.
9 During the 90-day period, the owner or owners of property that
10 is included in the description in subsection (a) to be annexed
11 may request in writing to the city clerk to be excluded from
12 the annexation if the property is classified for ad valorem
13 tax purposes as Class III property and not in a platted
14 subdivision."

15 Section 2. The provisions of this act are curative
16 to make technical corrections in the description in Act
17 2015-332.

18 Section 3. In accordance with Section 11-42-6(b) of
19 the Code of Alabama 1975, a map showing what territory is
20 proposed to be annexed to the City of Jacksonville is on file
21 in the office of the Judge of Probate in Calhoun County,
22 Alabama, and the map is open to the inspection of the public.

23 Section 4. This act shall become effective
24 immediately following its passage and approval by the
25 Governor, or its otherwise becoming law.
