 - (e) Upon ratification of this constitutional amendment and contingent upon the ratification of the

Constitution of Alabama of 2022, the Code Commissioner shall number and place this amendment as appropriate in the constitution based upon a logical sequence and the particular subject or topic of the amendment. In this amendment, the Code Commissioner may change capitalization, spelling, and punctuation for the purpose of style and uniformity; correct manifest grammatical, clerical, and typographical errors; and correct incorrect cross-references. The Code Commissioner, during publication, may also omit this instructional paragraph.

Section 2. An election upon the proposed amendment shall be held at the general election in November 2022 in accordance with Section 284.01 of the Constitution of Alabama of 1901, now appearing as Section 284.01 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, and the election laws of this state.

Section 3. The appropriate election official shall assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the following description of the substance or subject matter of the proposed constitutional amendment:

"Relating to Baldwin County, proposing an amendment to the Constitution of Alabama of 1901, to define the White House Fork Landmark District within the county and to prohibit the annexation by local law of any property within the district into any municipality except under certain conditions.
