13 Relating to Jefferson County; to amend Act 99-594 of
14 the 1999 Regular Session (Acts 1999, p. 1363), relating to the
15 pistol permit fee the sheriff is required to charge, to
16 provide that the distribution of the fee to the Jefferson
17 County Legislative Delegation Office would be distributed to
18 the county general fund; to provide that any current balance
19 distributed to the delegation office would be transferred to
20 the county general fund for law enforcement purposes; and to
21 repeal any conflicting laws.

22 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

23 Section 1. Section 2 of Act 99-594 of the 1999
24 Regular Session, (Acts 1999, p. 1363), is amended to read as
25 follows:

26 "Section 2. In Jefferson County, the total fee for
27 issuance of a permit to carry a pistol as provided by Section

1 13A-11-75, Code of Alabama 1975, shall be seven dollars and
2 fifty cents (\$7.50) per year. The fee shall be paid by the
3 sheriff to the county treasurer and the county treasurer shall
4 distribute the seven dollars and fifty cents (\$7.50) as
5 follows:

6 "(1) Four dollars and fifty cents (\$4.50) shall be
7 distributed to the retirement system established by Act 551 of
8 the 1953 Regular Session.

9 "(2) Fifty cents (\$.50) shall be distributed to the
10 Jefferson County Sheriff's Fund.

11 "(3) Two dollars and fifty cents (\$2.50) shall be
12 distributed to the ~~Jefferson County Legislative Delegation~~
13 ~~Office. Of this amount two dollars (\$2) or the portion needed~~
14 ~~thereof shall be spent for the operation of the legislative~~
15 ~~office located in Birmingham, and fifty cents (\$.50) shall be~~
16 ~~used for the operation of the legislative office located in~~
17 ~~Bessemer county general fund earmarked for law enforcement~~
18 ~~purposes."~~

19 Section 2. Any funds distributed or held by the
20 county treasurer for the Jefferson County Legislative
21 Delegation Office pursuant to Act 99-594 on the effective date
22 of this act shall be transferred or distributed to the county
23 general fund earmarked for law enforcement purposes.

24 Section 3. All laws or parts of laws which conflict
25 with this act are repealed. Act 323, 1963 Regular Session
26 (Acts 1963, p. 803) and Act 97-280 of the 1997 Regular Session
27 (Acts 1997, p. 500), as amended, are expressly repealed.

1 Section 4. This act shall become effective
2 immediately following its passage and approval by the
3 Governor, or its otherwise becoming law.
