- 7 (1) An operations plan for the fiscal year 8 2013-2014, including goals and measurable performance 9 indicators, shall be submitted to and approved by the Director 10 of Finance, as provided for state agencies in Code of Alabama 11 1975, Section 41-19-10.
 - (2) An audited financial statement for all operations during the fiscal year 2011-2012.
 - (b) It is the intent that funds appropriated for fiscal year 2013-2014 shall be released by the Director of Finance following receipt of the above reports.
 - (c) In addition, quarterly reports shall be made to the Director of Finance relating actual expenditures and accomplishments to planned expenditures and accomplishments.

 An end of year performance report for the fiscal year 2013-2014 shall be made to the Director of Finance stating the work accomplished and the services provided and the costs of accomplishing the work and providing the services, citing meaningful measures of program effectiveness and costs, as is required for state agencies in Code of Alabama 1975, Section 41-19-11.
