8 SYNOPSIS: This bill makes appropriations for the
9 support, maintenance and development of public
10 education in Alabama, for debt service, and for
11 capital outlay for the fiscal year ending September
12 30, 2018.

16 AN ACT

18 To make appropriations for the support, maintenance
19 and development of public education in Alabama, for debt
20 service, and for capital outlay for the fiscal year ending
21 September 30, 2018.

22 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

23 Section 1. There is hereby appropriated for the
24 support of public education in Alabama for the fiscal year
25 ending September 30, 2018, for debt service, and for capital
26 outlay to be paid out of funds specified in subsection (a) of
27 Section 2 of this act, the amounts specified in subsections

1 (a), (b), (c), (d), and (e) of Section 3 of this act. For the
2 purpose specified in subsection (b) of Section 2 of this act,
3 amounts are shown by programmatic area and the total for all
4 programs is shown so as to include estimated sources of funds
5 other than those listed in subsection (a) of Section 2 of this
6 act. For the purpose of this act, "ETF" shall mean the
7 Education Trust Fund and "Federal and Local Funds" shall mean
8 all gifts, grants, contributions, or entitlements, including
9 grants by the Congress of the United States, municipalities or
10 counties.

11 Section 2. (a) The appropriations provided for in
12 this act shall be paid from funds in the State Treasury to the
13 credit of the Education Trust Fund, Alabama Peace Officers'
14 Standards and Training Fund, Impaired Drivers Trust Fund,
15 Driver Education and Training Fund, Special Education
16 Catastrophic Fund, Public School Fund and other listed funds
17 and are hereby made for the support of public education in
18 Alabama for the fiscal year ending September 30, 2018, and the
19 appropriations herein made shall be subject to the provisions,
20 terms, conditions and limitations of the Budget and Financial
21 Control Act (Code of Alabama 1975, Sections 41-4-80 et seq.),
22 the provisions of the Budget Management Act of 1976 (Code of
23 Alabama 1975, Sections 41-19-1 et seq.), and shall be in the
24 amounts hereinafter specified.

25 (b) Amounts shown hereinunder the columns "Earmarked
26 Funds" and "Appropriation Total" are as set forth for the
27 purpose of establishing amounts estimated to be available by

1 programmatic area from sources other than those listed in
 2 subsection (a) of this Section 2, in order, upon consideration
 3 of such other funds so estimated to be available, to promote
 4 the accountability for an efficient use of funds available,
 5 and the same are hereby appropriated by the Legislature.
 6 Provided, however, that regardless of the ending date of any
 7 pay period which has been or may be established by the
 8 Legislature for the payment of salaries of state employees,
 9 the entire payment due shall be made from the fiscal year's
 10 appropriation in which the pay date falls.

6 The funds appropriated for
7 Workforce Development are to
8 be expended for those costs
9 incurred by the State in hon-
10 oring commitments to pay
11 workforce development costs,
12 including services and other
13 assistance and expenses of
14 recruitment and training of a
15 company's workforce, that are
16 undertaken to induce companies
17 to locate and expand their
18 operations in Alabama (de-
19 scribed hereinafter as a "Pro-
20 ject") and to develop and im-
21 plement training, placement
22 and recruitment programs that
23 will improve development and
24 expand the State's workforce.
25 Such costs include, but are
26 not limited to: (i) AIDT oper-
27 ating costs directly related
28 to a Project; (ii) wages and
29 benefits for trainers engaged
30 by AIDT for the purpose of a
31 Project; (iii) costs which the
32 State has agreed to pay under
33 the terms of a Project Agree-
34 ment with a company that are

(1) The allocations as set forth above shall be distributed by the Alabama Community College System Board of Trustees through the Office of the Chancellor.

(2) The above appropriation from the Education Trust Fund for Operations and Maintenance shall be distributed as follows: \$200,000 shall be distributed to Enterprise State Community College Aeronautics School in Albertville; \$370,000 shall be distributed to the Alabama Aviation College of which \$120,000 shall be for the Andalusia Program; \$100,000 shall be distributed to Shelton State Community College for distance support; \$80,000 shall be distributed to Bishop State Community College for the welding program at the Carver Campus; \$145,000 shall be distributed to Central Alabama Community College for economic development; \$125,000 shall be distributed to Lawson State Community College for career training; \$147,000 shall be distributed to Gadsden State Community College for economic development; \$100,000 shall be distributed to Gadsden State Community College for the Poultry Technology Center in partnership with Auburn University; \$250,000 shall be distributed to Trenholm State Technical College for a building trade program and campus security; \$450,000 shall be distributed to Northwest-Shoals Community College for an industrial maintenance program; \$250,000 shall be distributed to Shelton State Community College for facility modification; \$250,000 shall be distributed to Beville State Community College to be distributed equally between the Hamilton, Sumiton and Jasper campuses in the amount of \$83,333 for each campus; \$450,000 shall be distributed to Faulkner State Community College for the technology and manufacturing program; \$275,000 shall be distributed to Jefferson State Community College for nursing program; \$250,000 shall be distributed to Wallace State Community College - Dothan for the Center for Economic and Workforce Development; \$385,000 shall be distributed to Wallace State Community College - Hanceville for the Incubator Program, the Aviation Center and the Welding Center in Blount County; \$350,000 shall be distributed to Calhoun Community College for the Innovation Center Project; \$200,000 shall be distributed to Northeast Community College; and the remainder shall be distributed to each of the colleges, except Marion Military Institute.

(3) The allocation of Adult Education funds appropriated herein is restricted to the provision of services to individuals who are receiving benefits under the Adult Education and Family Literacy Act, Title II of the federal Workforce Innovation and Opportunity Act of 2014.

(4) The Chancellor of the Alabama Community College System shall report quarterly to the Chairs of the Senate Committee on Finance and Taxation - Education and the House Ways and Means - Education Committee and the Legislative Fiscal Officer any funds expended for the Alabama Technology Network.

4 Section 4. In addition to the appropriations herein
5 made, all gifts, grants, contributions, insurance proceeds or
6 entitlements, in excess of the amount carried in this act,
7 including grants by the Congress of the United States,
8 municipalities or counties, to any department, division,
9 board, bureau, commission, agency, institution, office or
10 officer of the State of Alabama are hereby appropriated and,
11 in the event the same are recurring, are reappropriated to
12 such department, division, board, bureau, commission, agency,
13 institution, office or officer to be used only for the purpose
14 or purposes for which the grant or contribution was or shall
15 be made. Further, all state, county, municipal and educational
16 entities are authorized to disburse such sums as deemed
17 necessary by mutual agreement between said entities and the
18 State of Alabama, Department of Examiners of Public Accounts
19 to partially defray the cost of auditing services performed by
20 said agency. All such sums are hereby appropriated and
21 reappropriated if necessary to the Department of Examiners of
22 Public Accounts for audit services, to be expended through the
23 fund established by Section 41-5-24, Code of Alabama 1975.

1 Section 5. The State Superintendent of Education
2 shall make requisitions to the State Comptroller in favor of
3 the proper beneficiary in accordance with the law and rules
4 and regulations governing the expenditure or disbursement of
5 any and all funds appropriated to the State Department of
6 Education and/or the State Board of Education in this act,
7 whereupon the Comptroller shall issue his warrant therefor.
8 All other appropriations in this act shall be paid after
9 proper requisitions are made to the State Comptroller in the
10 manner now provided by law.

11 Section 6. Nothing in this act shall be construed to
12 affect or repeal any law authorizing or permitting any
13 college, school or other education or eleemosynary institution
14 of the State to receive, collect or disburse any fees,
15 tuitions, charges, sales, endowments, trusts or income
16 therefrom, which are now or may hereafter be authorized to
17 receive, collect or disburse. The receiving college, school or
18 institution shall further maintain separate accounts for such
19 receipts or shall maintain a system of accounting which will
20 show a cash flow of such receipts received under the provision
21 of this appropriation.

22 Section 7. The appropriations made herein to the
23 departments, boards, offices, commissions, and agencies
24 include the amounts necessary and said departments, boards,
25 offices, commissions, and agencies are hereby directed to make
26 the transfer of funds to the State Personnel Department in the
27 amounts enumerated in the general appropriations act for the

1 fiscal year ending September 30, 2018. All agencies and
2 institutions enumerated in this act that receive services from
3 other governmental agencies enumerated in this act or the
4 general appropriations act shall make full payment in a timely
5 manner (as determined by the Department of Finance) for such
6 services.

7 Section 8. All encumbered balances of a previous
8 fiscal year appropriation other than the exclusions authorized
9 by the Code of Alabama 1975, Section 41-4-93, shall lapse no
10 later than September 30 of the fiscal year immediately
11 following the fiscal year for which the appropriation was made
12 and shall revert to the credit of the Education Trust Fund or
13 earmarked fund from which the appropriation or appropriations
14 were made.

15 Section 9. Upon certification to the Director of
16 Finance by the State Attorney General that a federal court has
17 ordered the State of Alabama to pay claims, attorney fees, or
18 other costs relating to said court order, funds are hereby
19 appropriated to the affected department, board, bureau, or
20 commission in the amount necessary to satisfy that court
21 order. Such appropriations are in addition to any other
22 appropriation heretofore or hereafter made in this
23 appropriation act. Such appropriations are conditioned upon
24 the availability of funds and a determination by the Director
25 of Finance that other current appropriations are not available
26 for court-ordered payments.

1 Section 10. For FY 2018, local boards of education
2 may exercise flexibility among line item expenditures, not to
3 create a reduction of earned teacher units and/or local board
4 of education support personnel.

5 Section 11. The State Superintendent of Education
6 may approve a request by a local board of education for
7 redirecting Other Current Expense funds designated for
8 pass-through calculations to their local Child Nutrition
9 Program if the redirected funds do not prevent the Child
10 Nutrition Program of that local board of education from
11 maintaining a positive fund balance.

12 Section 12. The appropriations made herein to the
13 departments, boards, offices, commissions and agencies include
14 the amounts necessary to pay the State Employees' Insurance
15 Board (SEIB). The SEIB rate shall be \$930 per month for each
16 full-time employee for the fiscal year ending September 30,
17 2018. The State Employees' Insurance Board will adjust the
18 insurance program wherever appropriate to maintain the
19 aforementioned fixed rate.

20 Section 13. In addition to the amounts otherwise
21 appropriated in this act, there is hereby appropriated from
22 the several funds in the State Treasury, and in the same
23 proportion as the salaries of the several State officials and
24 employees are paid, such additional amounts as may be
25 necessary to pay for a four percent (4.0%) salary increase for
26 state employees enacted in the 2017 Regular Session. The
27 additional amounts appropriated in this section from the

1 Education Trust Fund shall not exceed \$3,800,000 for the
2 fiscal year ending September 30, 2018. The Director of Finance
3 shall ensure that first priority shall be given to all
4 Education Trust Fund payrolls, including the payroll of the
5 Legislature. State agencies shall receive additional
6 allocations from the appropriation made in this section from
7 the Education Trust Fund in amounts necessary to increase
8 total state employee salaries paid from the Education Trust
9 Fund by four percent. The remainder of this appropriation from
10 the Education Trust Fund may be allotted by the Director of
11 Finance to those agencies which receive transfers from the
12 Education Trust Fund.

13 Section 14. Notwithstanding any other provisions of
14 this act or any other act, any amount from appropriations for
15 the fiscal year ending September 30, 2017 to the various state
16 agencies and institutions in this act, except appropriations
17 from the Education Trust Fund, which are unexpended and
18 reverted on September 30, 2017 are hereby reappropriated to
19 the respective state agencies, offices and institutions for
20 the fiscal year beginning October 1, 2017.

21 Section 15. If any section, paragraph, sentence,
22 clause, provision or portion of this act or all or any portion
23 of the appropriations herein made is held unconstitutional or
24 invalid, it shall not affect any other section, paragraph,
25 sentence, clause, provision or portion of this act or any
26 other appropriation or appropriations or portion thereof
27 hereby made not in and of itself unconstitutional or invalid.

1 Section 16. All laws or parts of laws, general,
2 special, private or local in conflict with or inconsistent
3 with the provisions of this act are hereby expressly repealed.

4 Section 17. This act shall become effective on
5 October 1, 2017.
