13 Relating to Jackson and DeKalb Counties; to amend
14 Act 2010-728 of the 2010 Regular Session (Acts 2010, p. 1833)
15 to further provide for the members of the Jackson/DeKalb
16 Counties Industrial Development Authority.

17 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

18 Section 1. Section 1 of Act 2010-728 of the 2010
19 Regular Session (Acts 2010, p. 1833) is amended to read as
20 follows:

21 "Section 1. (a) There is established the
22 Jackson/DeKalb Counties Industrial Development Authority. The
23 purpose of the authority shall be to market and develop the
24 Northeast Alabama Technology Park on the Campbell site near
25 the Northeast Alabama Community College and other sites that
26 may be suitable for economic development in the future in the
27 vicinity of the college.

1 "(b) The members of the authority shall consist of
2 the following:

3 "(1) The President of the Northeast Alabama
4 Community College (NACC) who shall serve as chair of the
5 authority.

6 "(2) One member appointed by the Jackson County
7 Commission who shall reside within the NACC service area.

8 "(3) One member appointed by the DeKalb County
9 Commission who shall reside within the NACC service area.

10 "(4) One member from Jackson County appointed by the
11 local state legislative delegation representing Jackson and
12 DeKalb Counties who shall reside within the NACC service area.

13 "(5) One member from DeKalb County appointed by the
14 local state legislative delegation representing Jackson and
15 DeKalb Counties who shall reside within the NACC service area.

16 "(6) One member of the Section/Dutton Water
17 Authority Board appointed by the Section/Dutton Water
18 Authority Board.

19 "(7) The CEO of the Sand Mountain Electric Co-op, or
20 his or her designee.

21 "(8) The CEO of the Farmers Telecommunication
22 Cooperative, or his or her designee.

23 "(9) The Chair of the DeKalb County Economic
24 Development Authority or his or her designee.

25 "(10) The Chair of the Jackson County Economic
26 Development Authority or his or her designee.

1 "(11) The Chair of the Northeast Alabama Community
2 College Advisory Board.

3 "(b) The President/CEO of the Jackson County
4 Economic Development Authority shall serve as an ex officio
5 member. The Executive Director of the DeKalb County Economic
6 Development Authority shall serve as an ex officio member.

7 "(c) The appointed members of the authority shall
8 serve for a term of four years and shall serve until a
9 successor is appointed.

10 "(d) The authority shall have its first meeting at
11 the Northeast Alabama Community College at the call of the
12 chair. The college shall provide clerical assistance to the
13 authority. The authority may receive funding from any public
14 or private source."

15 Section 2. This act shall become effective on the
16 first day of the third month following its passage and
17 approval by the Governor, or its otherwise becoming law.
