1 Enrolled, An Act,

4 Relating to Chambers County; to further provide for the
5 expense allowance and salary of the Revenue Commissioner of
6 Chambers County.

7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

8 Section 1. (a) Effective beginning on the first day of
9 the month following the effective date of this act, the
10 Revenue Commissioner of Chambers County shall receive an
11 additional expense allowance so that the expense allowance and
12 the salary of the revenue commissioner is equal to eighty-four
13 thousand dollars (\$84,000) per year payable in equal monthly
14 installments. This expense allowance shall be in addition to
15 any other salary, expense allowance, or compensation the
16 revenue commissioner is receiving. The expense allowance
17 provided by this subsection shall be treated as salary for
18 retirement purposes.

19 (b) Effective beginning the next term of office after
20 the effective date of this act, the annual salary of the
21 revenue commissioner shall be eighty-four thousand dollars
22 (\$84,000) per year and at that time subsection (a) shall be
23 void.

24 (c) Notwithstanding the provisions of Section 11-2A-4,
25 Code of Alabama 1975, or any other law to the contrary,
26 effective beginning October 1, 2024, and thereafter, pursuant
27 to the provisions of this act, the revenue commissioner shall
28 be entitled to the same uniform increases in compensation,

29 such as cost-of-living increases, received by any other
30 elected county officer. The uniform increases shall be paid to
31 the revenue commissioner as expense allowances during the term
32 of the revenue commissioner and shall be treated as salary for
33 retirement purposes. At the end of each term, the amount of
34 any uniform increases during the term shall be added to the
35 permanent salary of the revenue commissioner effective
36 beginning the next term of the revenue commissioner.

37 (d) The expense allowance and salary provided by this
38 section shall be paid from any fund or funds from which the
39 salary of the revenue commissioner is currently paid.

40 Section 2. All laws or parts of laws which conflict
41 with this act are repealed.

42 Section 3. This act shall become effective immediately
43 following its passage and approval by the Governor, or its
44 otherwise becoming law.
