SYNOPSIS:

Under existing law, a district attorney's salary may only be increased after the completion of the term of office he or she is serving.

This bill would remove any restrictions on when a district attorney's salary may be increased.

A BILL
TO BE ENTITLED
AN ACT

Relating to district attorneys; to amend Section 12-17-182, Code of Alabama 1975, to further provide for the salaries of district attorneys.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 12-17-182, Code of Alabama 1975, is amended to read as follows:

"§12-17-182

(a) ~~(1) Subject to subdivision (2), district~~ District attorneys for each judicial circuit in the state serving on October 1, 2021, until the end of his or her service, shall be paid by the state an annual salary of an amount equal to one thousand dollars (\$1,000) less than the salary paid by the state to the highest paid circuit judge of the state, payable

29 as the salaries of other state officers are paid. District
30 attorneys holding office on October 1, 2021, are exempt from

32 ~~(2) A district attorney's salary may only increase~~

36 (b) (1) Notwithstanding subsection (a), any district
37 attorney newly appointed or elected after October 1, 2021,
38 shall receive an initial salary of one hundred forty thousand
39 dollars (\$140,000).

40 (2) The salary of district attorneys shall be increased
41 by 7.5 percent for the term commencing after the completion of
42 the first term for which he or she was appointed or elected as
43 district attorney. The salary shall be increased by an
44 additional 7.5 percent for the term commencing after the
45 completion of his or her second term as district attorney. The
46 salary shall be increased by an additional 7.5 percent for the
47 term commencing after the completion of his or her third term
48 as district attorney.

49 (c) The compensation paid by the state to any district
50 attorney in service on October 1, 2021, may not be diminished
51 pursuant to Act 2021-441."

52 Section 2. This act shall become effective immediately
53 upon the ratification of the amendment to the Constitution of
54 Alabama of 2022, to provide that the salary of a district
55 attorney may be increased during his or her term of office as
56 proposed in HB_____ of the 2024 Regular Session.
