- Section 1. (a) As used in this section, the following terms have the following meanings:
- 28 (1) ENVIRONMENTAL. Energy efficiency, carbon footprint,

- 29 greenhouse gas emissions, deforestation, biodiversity, climate
- 30 change and pollution mitigation, waste management, and water

- 32 (2) ESG CRITERIA. Environmental, social, and governance
- 33 standards.
- 34 (3) ESG RATING. A measurement of an individual's ESG
- 35 criteria based on an assessment of their quality, standard, or
- 36 performance.
- 37 (4) GOVERNANCE. Corporate board diversity, composition
- 38 and structure, strategic sustainability and compliance,
- 39 executive compensation, political contributions and lobbying,

- (c) Before a public awarding authority may award a
- 59 public contract to a responsible bidder, the responsible
- 60 bidder shall certify, under penalty of perjury, that its
- 61 employees will not be subject to a personal ESG rating as a
- 62 basis of hiring, firing, or evaluation.
- Section 2. This act shall become effective January 1,
- 64 2025.
