ENROLLED, An Act,

To make an appropriation of \$198,000 from the State General Fund to the Alabama Kidney Foundation, Inc. for the support and operations of the Alabama Kidney Foundation, Inc. Program for the fiscal year ending September 30, 2011, to provide that the appropriation is subject to certain provisions of the Code of Alabama 1975, to require an operations plan and an audited financial statement prior to the release of any funds, and to require quarterly and end of year performance reports.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. There is hereby appropriated the sum of \$198,000 from the State General Fund to the Alabama Kidney Foundation, Inc. for the support and operations of the Alabama Kidney Foundation, Inc. Program for the fiscal year ending September 30, 2011.

Section 2. The above appropriation shall be subject to the provisions, terms, conditions, and limitations of the Budget and Financial Control Act, Code of Alabama 1975, Sections 41-4-80 et seq.; the provisions of The Budget Management Act of 1976, Code of Alabama 1975, Sections 41-19-1 et seq.; and any other provisions of this act.

1           Section 3. (a) Prior to the release of any funds  
2 appropriated under this act the following reports shall be submitted:

3           (1) An operations plan for the fiscal year  
4 2010-2011, including goals and measurable performance  
5 indicators, shall be submitted to and approved by the Director  
6 of Finance, as provided for state agencies in Code of Alabama  
7 1975, Section 41-19-10.

8           (2) An audited financial statement for all  
9 operations during the fiscal year 2008-2009.

10          (b) It is the intent of the Legislature that funds  
11 appropriated for fiscal year 2010-2011 shall be released by  
12 the Director of Finance following receipt of the above  
13 reports.

14          (c) In addition, quarterly reports for fiscal year  
15 2010-2011 shall be made to the Director of Finance relating  
16 actual expenditures and accomplishments to planned  
17 expenditures and accomplishments. An end of year performance  
18 report for the fiscal year 2010-2011 shall be made to the  
19 Director of Finance stating the work accomplished and the  
20 services provided and the costs of accomplishing the work and  
21 providing the services, citing meaningful measures of program  
22 effectiveness and costs, as is required for state agencies in  
23 Code of Alabama 1975, Section 41-19-11.

1                   (d) The Director of Finance shall forward a copy of  
2 all required reports to the Joint Fiscal Committee in a timely  
3 manner.

4                   Section 4. This act shall become effective October  
5 1, 2010.
