9	POLICE DEPARTMENT AS A NOMINEE FOR THE 2013 ALABAMA
10	LEGISLATIVE MEDAL OF HONOR FOR LAW ENFORCEMENT.

12	WHEREAS, it is with highest commendation that we
13	recognize Officer Calvin Crow of the Birmingham Police
14	Department as a nominee for the 2013 Alabama Legislative Medal
15	of Honor for Law Enforcement, Alabama's highest law
16	enforcement award for extraordinary courage in the line of
17	duty; and
18	WHEREAS, Officer Crow is a 15-year veteran of the
19	Birmingham Police Department; and
20	WHEREAS, on December 15, 2012, in the early morning
21	hours, an armed suspect entered St. Vincent's Hospital, taking
22	an on-duty security guard hostage, and began to terrorize
23	hospital staff and patients as he made his way through the
24	hospital; and
25	WHEREAS, Officer Crow was one of five officers
26	assigned to the South Precinct who arrived on the scene and
27	instantly realized that they were dealing with an active

shooter situation; without hesitation, he and the other

officers made their way to the 5th Floor, where they believed

the suspect to be; as they neared a bank of elevators, they

came face to face with him, and he immediately began firing on

them; and

WHEREAS, in the hail of gunfire that ensued, two hospital employees and one of the officers were wounded by the suspect; fortunately, the officers were able to stop the actions of the suspect without any additional officers or innocent persons being injured; and

WHEREAS, less than 24 hours previous to this event, the nation had witnessed the very worst that man can do, with the tragic results of an active shooter at the Shady Hook Elementary School in Connecticut; however, in Birmingham, Alabama, the nation bore witness to what everyday heroes are capable of doing; and

WHEREAS, the five professional police officers in Birmingham knew that there was an active shooter in the hospital; they knew that with active shooters, there was a high probability they could be injured; they also knew that if they did not take immediate action, innocent people could be killed; and

WHEREAS, these five brave police officers stood between danger and the helpless, knowingly putting themselves in the line of fire and averting a tragedy that could have claimed many lives; each displayed determination and courage in the face of an extremely dangerous situation and together

their quick actions and disregard for their personal safety saved the lives of untold innocent people; and

WHEREAS, Officer Crow is a worthy exemplar of those caring and dedicated men and women who stand ever ready to provide prompt and professional response in times of crisis, and he is highly deserving of this distinguished nomination for the Legislative Medal of Honor for Law Enforcement; now therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF
THE LEGISLATURE OF ALABAMA, That we hereby recognize and honor
Officer Calvin Crow of the Birmingham Police Department as a
