11 To amend Act 2010-553 in order to reduce the  
12 absolute appropriation from the State General Fund to the  
13 Alabama Department of Corrections in the amount of \$6,331,271  
14 for the fiscal year ending September 30, 2011; to make a  
15 supplemental appropriation from the DOC Miscellaneous and  
16 Federal Funds (Bonus), Estimated to the Alabama Department of  
17 Corrections in the amount of \$54,965,407 for the fiscal year  
18 ending September 30, 2011; to make a supplemental  
19 appropriation from the State General Fund to the Alabama  
20 Medicaid Agency in the amount of \$125,615,631 for the fiscal  
21 year ending September 30, 2011; to make a supplemental  
22 appropriation from the State General Fund to the Alabama  
23 Department of Senior Services in the amount of \$527,348 for  
24 the fiscal year ending September 30, 2011; to make a  
25 supplemental appropriation from the State General Fund to the  
26 Alabama Department of Human Resources in the amount of  
27 \$1,423,711 for the fiscal year ending September 30, 2011; to

1 make a supplemental appropriation from the State General Fund  
2 to the Department of Mental Health in the amount of \$6,620,000  
3 for the fiscal year ending September 30, 2011; to make a  
4 supplemental appropriation from the State General Fund to the  
5 Alabama Department of Public Health in the amount of  
6 \$12,798,452 for the fiscal year ending September 30, 2011; to  
7 make a supplemental appropriation from the State General Fund  
8 to the Alabama Department of Rehabilitation Services in the  
9 amount of \$392,402 for the fiscal year ending September 30,  
10 2011; to make a supplemental appropriation from the State  
11 General Fund to the Alabama Department of Youth Services in  
12 the amount of \$219,304 for the fiscal year ending September  
13 30, 2011; to make a supplemental appropriation from the State  
14 General Fund to the Alabama Board of Pardons and Paroles in  
15 the amount of \$7,844,462 for the fiscal year ending September  
16 30, 2011; to make a supplemental appropriation from the State  
17 General Fund to the Alabama Ethics Commission in the amount of  
18 \$867,537 for the fiscal year ending September 30, 2011; to  
19 make a supplemental appropriation from the State General Fund  
20 to the Office of the State Auditor in the amount of \$159,002  
21 for the fiscal year ending September 30, 2011; to make a  
22 supplemental appropriation from the State General Fund to the  
23 State Military Department in the amount of \$993,000 for the  
24 fiscal year ending September 30, 2011; to make a supplemental  
25 appropriation from the State General Fund to the Departmental  
26 Emergency Fund in the amount of \$4,500,000 for the fiscal year  
27 ending September 30, 2011; and to make a supplemental

1 appropriation from the Archives Services Fund to the  
2 Department of Archives and History in the amount of \$120,000  
3 for the fiscal year ending September 30, 2011; and to delete  
4 certain unexpended line-item appropriations in the Department  
5 of Agriculture and Industries; and to make a supplemental  
6 appropriation from the State General Fund to the Alabama  
7 District Attorneys in the amount of \$630,000 for the fiscal  
8 year ending September 30, 2011.

9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

10 Section 1. Amend Act 2010-553, Section 2C, at the  
11 end of Subsection 35 entitled "Corrections, Department of:" by  
12 adding the following language: "The above appropriation to the  
13 Alabama Department of Corrections from the State General Fund  
14 shall be reduced by \$6,331,271."

15 Section 2. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$54,965,407 from the DOC Miscellaneous and Federal Funds  
18 (Bonus), Estimated to the Alabama Department of Corrections  
19 for the fiscal year ending September 30, 2011.

20 Section 3. In addition to all other appropriations  
21 heretofore or hereafter made, there is hereby appropriated  
22 \$125,615,631 from the State General Fund to the Alabama  
23 Medicaid Agency for the fiscal year ending September 30, 2011.

24 Section 4. In addition to all other appropriations  
25 heretofore or hereafter made, there is hereby appropriated  
26 \$527,348 from the State General Fund to the Alabama Department

1 of Senior Services for the fiscal year ending September 30,  
2 2011.

3 Section 5. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$1,423,711 from the State General Fund to the Alabama  
6 Department of Human Resources for the fiscal year ending  
7 September 30, 2011.

8 Section 6. In addition to all other appropriations  
9 heretofore or hereafter made, there is hereby appropriated  
10 \$6,620,000 from the State General Fund to the Alabama  
11 Department of Mental Health for the fiscal year ending  
12 September 30, 2011.

13 Section 7. In addition to all other appropriations  
14 heretofore or hereafter made, there is hereby appropriated  
15 \$12,798,452 from the State General Fund to the Alabama  
16 Department of Public Health for the fiscal year ending  
17 September 30, 2011.

18 Section 8. In addition to all other appropriations  
19 heretofore or hereafter made, there is hereby appropriated  
20 \$392,402 from the State General Fund to the Alabama Department  
21 of Rehabilitation Services for the fiscal year ending  
22 September 30, 2011.

23 Section 9. In addition to all other appropriations  
24 heretofore or hereafter made, there is hereby appropriated  
25 \$219,304 from the State General Fund to the Alabama Department  
26 of Youth Services for the fiscal year ending September 30,  
27 2011.

1           Section 10. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$7,844,462 from the State General Fund to the Alabama Board of  
4 Pardons and Paroles for the fiscal year ending September 30,  
5 2011.

6           Section 11. In addition to all other appropriations  
7 heretofore or hereafter made, there is hereby appropriated  
8 \$867,537 from the State General Fund to the Alabama Ethics  
9 Commission for the fiscal year ending September 30, 2011.

10          Section 12. In addition to all other appropriations  
11 heretofore or hereafter made, there is hereby appropriated  
12 \$159,002 from the State General Fund to the Office of the  
13 State Auditor for the fiscal year ending September 30, 2011.

14          Section 13. In addition to all other appropriations  
15 heretofore or hereafter made, there is hereby appropriated  
16 \$993,000 from the State General Fund to the State Military  
17 Department for the fiscal year ending September 30, 2011.

18          Section 14. In addition to all other appropriations  
19 heretofore or hereafter made, there is hereby appropriated  
20 \$4,500,000 from the State General Fund to the Departmental  
21 Emergency Fund for the fiscal year ending September 30, 2011.

22          Section 15. In addition to all other appropriations  
23 heretofore or hereafter made, there is hereby appropriated  
24 \$630,000 from the State General Fund to the Alabama District  
25 Attorneys for the fiscal year ending September 30, 2011.

26          Section 16. On the effective date of this act, any  
27 unexpended funds from line-item appropriations under the

1 Department of Agriculture and Industries for the following  
2 shall be reverted to the Administrative Services Program of  
3 the Department of Agriculture and Industries: Farm and Ranch  
4 Lands Protection Program; expenses and awarding of prizes for  
5 fairs as provided in Section 2-7-21, Code of Alabama 1975, and  
6 other livestock shows exhibits and the Livestock Coliseum and  
7 other activities as deemed necessary by the Agricultural  
8 Center Board; Treasure Forest Program; Center for Alternative  
9 Fuels; rabbit production and promotion; and the North Alabama  
10 Agriplex.

11 Section 17. In addition to all other appropriations  
12 heretofore or hereafter made, there is hereby appropriated  
13 \$120,000 from the Archives Services Fund to the Department of  
14 Archives and History for the fiscal year ending September 30,  
15 2011.

16 Section 18. This act shall become effective  
17 immediately upon its passage and approval by the Governor, or  
18 upon its otherwise becoming law.
