7 Relating to Cullman County; to amend Section
8 45-22-90, Code of Alabama 1975, to change the membership of
9 the Cullman County Community Development Commission.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. Section 45-22-90, Code of Alabama 1975,
12 is amended to read as follows:

13 "§45-22-90.

14 "(a) There is created the Cullman County Community
15 Development Commission which may receive, except as provided
16 in subdivision (2) of subsection (c), and by majority vote may
17 distribute any funds in the Community Development Fund created
18 herein for the purposes of promoting economic and community
19 development, education, conservation, and fire protection. The
20 commission shall be comprised of the following members:

21 "(1) A person appointed by the Senator representing
22 Cullman County and whose term will coincide with the term of
23 the Senator or until replacement.

24 "(2) A person appointed by each of the three members
25 of the House of Representatives who represent Cullman County

1 and whose term will coincide with the term of the appointing
2 representative or until replacement.

3 ~~"(3) a. For the first two years of the legislative~~
4 ~~quadrennium, the mayor of the second largest municipality in~~
5 ~~Cullman County.~~

6 ~~"b. For the last two years of the legislative~~
7 ~~quadrennium, the mayor of the largest municipality in Cullman~~
8 ~~County. A person appointed by the members of the legislative~~
9 ~~delegation from Cullman County, who shall serve as chair and~~
10 ~~shall serve at the discretion of the legislative delegation.~~

11 ~~"(b) No member of the commission shall be an elected~~
12 ~~official.~~

13 ~~"(b)(c) The commission may promulgate rules related~~
14 ~~to its operations and procedures for the awarding of grants~~
15 ~~within the community for the above mentioned purposes.~~

16 ~~"(c)(d) There is hereby created the Community~~
17 ~~Development Fund within the Cullman County Treasury. The fund~~
18 ~~shall be comprised of the following moneys received by the~~
19 ~~county:~~

20 ~~"(1) The additional three percent of TVA~~
21 ~~in-lieu-of-taxes payments received pursuant to Section~~
22 ~~40-28-2.~~

23 ~~"(2) The net proceeds of the state beer tax payable~~
24 ~~to Cullman County pursuant to Section 28-3-184, which shall be~~
25 ~~distributed as follows:~~

1 "a. Fifty percent to the commission to be used for
2 the purposes set out in subsection (a).

3 "b. Fifty percent to the municipalities in Cullman
4 County to be divided pro-rata based on the population of each
5 municipality to be used at the discretion of the governing
6 body of the municipality receiving the funds.

7 "~~(d)~~ (e) The funds collected pursuant to subsection
8 ~~(c)~~ (d) may be expended on order of the Cullman County
9 Community Development Commission.

10 "(f) The commission may spend up to three hundred
11 dollars (\$300) per year for office supplies necessary to
12 operate the commission.

13 "~~(e)~~ (g) Any payments from the additional three
14 percent received pursuant to Section 40-28-2, which were made
15 before April 21, 2009, are ratified and confirmed."

16 Section 2. This act shall become effective on the
17 first day of the third month following its passage and
18 approval by the Governor, or its otherwise becoming law.
