1 Section I. The Legislature shall convene in 2 organizational session as provided for in Amendment 57 to the Constitution of Alabama of 1901, now appearing as Section 3 4 48.01 of Article IV of the Official Recompilation of the Constitution of Alabama of 1901, as amended. Beginning with 5 the first regular session after January 1, 2015, the annual 6 7 regular session of the Legislature shall commence on the first Tuesday in March of the first year of the term of office of 8 legislators, on the first Tuesday of February of the second 9 10 and third years of the term, and on the second Tuesday in January of the fourth year of the term, or on such other day 11 as may be prescribed by law, and shall be limited to 60 12 13 calendar days and 20 legislative days. During the annual 14 regular session, legislation of any nature may be considered 15 by the Legislature with the exception of the following: General appropriation bills for the ordinary expenses of the 16 17 executive, legislative, and judicial departments of the state; bills whose primary purpose is to increase or decrease 18 revenues; bills for interest on the public debt; bills 19 authorizing bond issues; appropriation bills for the support 20 21 and maintenance of public education; nonstate and other 22 appropriation bills; and any other appropriation bills. On the 23 second Tuesday after the final adjournment of the annual 24 regular session of the Legislature, the annual budget session of the Legislature shall commence, and shall be limited to 45 25 26 calendar days and 10 legislative days. During the budget 27 session, only bills whose primary purpose is to increase or

1 decrease revenues; general appropriation bills for the 2 ordinary expenses of the executive, legislative, and judicial departments of the state; bills for interest on the public 3 4 debt; bills authorizing bond issues; bills for the support and maintenance of public education; nonstate and other 5 6 appropriation bills; any other legislation dealing with 7 emergency financial needs of the state; or local legislation may be considered by the Legislature. When the Legislature 8 shall be convened in special session, there shall be no 9 10 legislation upon subjects other than those designated in the proclamation of the Governor calling the session, except by 11 12 vote of two-thirds of each house. Special sessions of the 13 Legislature convened in the manner provided by this 14 constitution shall be limited to 12 legislative days and 30 15 calendar days.

Section II. On or before the first legislative day of each annual regular session of the Legislature, the Governor shall transmit to the Legislature the proposed budget plans of the state for consideration by the Legislature in the next ensuing budget session.

21 Section III. This amendment shall be self-executing. 22 Amendment 339 to the Constitution of Alabama of 1901, now 23 appearing as Section 76 of Article IV of the Official 24 Recompilation of the Constitution of Alabama of 1901, as 25 amended, and Amendment 448 to the Constitution of Alabama of 26 1901, now appearing as Section 71.01 of Article IV of the Official Recompilation of the Constitution of Alabama of 1901,
as amended, are repealed.

3 Section 2. An election upon the proposed amendment 4 shall be held in accordance with Sections 284 and 285 of the 5 Constitution of Alabama of 1901, now appearing as Sections 284 6 and 285 of the Official Recompilation of the Constitution of 7 Alabama of 1901, as amended, and the election laws of this 8 state.

9 Section 3. The appropriate election official shall 10 assign a ballot number for the proposed constitutional 11 amendment on the election ballot and shall set forth the 12 following description of the substance or subject matter of 13 the proposed constitutional amendment:
