14 AN ACT FOR THE INSTITUTIONS OF HIGHER
15 EDUCATION REAPPROPRIATION.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19
20 SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
21 hereby appropriated, to the Arkansas Northeastern College, to be payable from
22 the Development and Enhancement Fund, for the Arkansas Northeastern College
23 the following:

24 (A) Effective July 1, 2020, the balance of the appropriation provided
25 in Item (A) of Section 1 of Act 403 of 2019, for construction, renovation,
26 maintenance, critical maintenance, equipment, security enhancements,
27 technology upgrades/equipment and library resources of a Center for Science
28 and Technology, in a sum not to exceed\$1,850,000.

29 (B) Effective July 1, 2020, the balance of the appropriation provided
30 in Item (B) of Section 1 of Act 403 of 2019, for critical maintenance, in a
31 sum not to exceed\$290,000.

32 (C) Effective July 1, 2020, the balance of the appropriation provided
33 in Item (C) of Section 1 of Act 403 of 2019, for deferred maintenance, in a
34 sum not to exceed\$390,000.

35 (D) Effective July 1, 2020, the balance of the appropriation provided
36 in Item (D) of Section 1 of Act 403 of 2019, for repair or replacement of



1 equipment and library holdings, in a sum not to exceed\$140,140.

2
3 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There
4 is hereby appropriated, to the Arkansas State University - Beebe, to be
5 payable from the Development and Enhancement Fund, for the Arkansas State
6 University - Beebe the following:

7 (A) Effective July 1, 2020, the balance of the appropriation provided
8 in Item (A) of Section 2 of Act 403 of 2019, for renovations of State Hall,
9 in a sum not to exceed\$1,375,000.

10 (B) Effective July 1, 2020, the balance of the appropriation provided
11 in Item (B) of Section 2 of Act 403 of 2019, for renovations of Owen Center,
12 in a sum not to exceed\$2,000,000.

13 (C) Effective July 1, 2020, the balance of the appropriation provided
14 in Item (C) of Section 2 of Act 403 of 2019, for critical maintenance, in a
15 sum not to exceed\$120,000.

16 (D) Effective July 1, 2020, the balance of the appropriation provided
17 in Item (D) of Section 2 of Act 403 of 2019, for deferred maintenance, in a
18 sum not to exceed\$1,050,000.

19 (E) Effective July 1, 2020, the balance of the appropriation provided
20 in Item (E) of Section 2 of Act 403 of 2019, for repair or replacement of
21 equipment and library holdings, in a sum not to exceed\$412,685.

22
23 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH.
24 There is hereby appropriated, to the Arkansas State University - Mid-South,
25 to be payable from the Development and Enhancement Fund, for the Arkansas
26 State University - Mid-South the following:

27 (A) Effective July 1, 2020, the balance of the appropriation provided
28 in Item (A) of Section 5 of Act 403 of 2019, for upgrade and replacement of
29 Classroom Instructional Technology Equipment, in a sum not to exceed
30\$100,000.

31 (B) Effective July 1, 2020, the balance of the appropriation provided
32 in Item (B) of Section 5 of Act 403 of 2019, for critical maintenance, in a
33 sum not to exceed\$180,000.

34 (C) Effective July 1, 2020, the balance of the appropriation provided
35 in Item (C) of Section 5 of Act 403 of 2019, for deferred maintenance, in a
36 sum not to exceed\$470,000.

1 (D) Effective July 1, 2020, the balance of the appropriation provided
2 in Item (D) of Section 5 of Act 403 of 2019, for repair or replacement of
3 equipment and library holdings, in a sum not to exceed\$140,250.
4

5 SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

6 There is hereby appropriated, to the Arkansas State University - Mountain
7 Home, to be payable from the Development and Enhancement Fund, for the
8 Arkansas State University - Mountain Home the following:

9 (A) Effective July 1, 2020, the balance of the appropriation provided
10 in Item (A) of Section 3 of Act 403 of 2019, for replacing critical
11 maintenance equipment, in a sum not to exceed\$1,000,000.

12 (B) Effective July 1, 2020, the balance of the appropriation provided
13 in Item (B) of Section 3 of Act 403 of 2019, for acquisition and renovation
14 of an Occupational Technical Center, in a sum not to exceed\$1,000,000.

15 (C) Effective July 1, 2020, the balance of the appropriation provided
16 in Item (C) of Section 3 of Act 403 of 2019, for construction, renovation,
17 maintenance, critical maintenance, equipment, security enhancements,
18 technology upgrades/equipment and library resources of a Health and Wellness
19 Center, in a sum not to exceed\$850,000.

20 (D) Effective July 1, 2020, the balance of the appropriation provided
21 in Item (D) of Section 3 of Act 403 of 2019, for deferred maintenance, in a
22 sum not to exceed\$260,000.

23 (E) Effective July 1, 2020, the balance of the appropriation provided
24 in Item (E) of Section 3 of Act 403 of 2019, for repair or replacement of
25 equipment and library holdings, in a sum not to exceed\$147,040.
26

27 SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

28 There is hereby appropriated, to the Arkansas State University - Newport, to
29 be payable from the Development and Enhancement Fund, for the Arkansas State
30 University - Newport the following:

31 (A) Effective July 1, 2020, the balance of the appropriation provided
32 in Item (A) of Section 4 of Act 403 of 2019, for construction, renovation,
33 maintenance, critical maintenance, equipment, security enhancements,
34 technology upgrades/equipment and library resources of a Classroom/Student
35 Services Building on the Jonesboro Campus, in a sum not to exceed
36\$1,000,000.

1 (B) Effective July 1, 2020, the balance of the appropriation provided
2 in Item (B) of Section 4 of Act 403 of 2019, for construction, renovation,
3 maintenance, critical maintenance, equipment, security enhancements,
4 technology upgrades/equipment and library resources of an Administration
5 Building on the Newport Campus, in a sum not to exceed\$1,000,000.

6 (C) Effective July 1, 2020, the balance of the appropriation provided
7 in Item (C) of Section 4 of Act 403 of 2019, for renovation and remodel of
8 the Main Building on the Jonesboro Campus, in a sum not to exceed ..\$850,000.

9 (D) Effective July 1, 2020, the balance of the appropriation provided
10 in Item (D) of Section 4 of Act 403 of 2019, for deferred maintenance, in a
11 sum not to exceed\$350,000.

12 (E) Effective July 1, 2020, the balance of the appropriation provided
13 in Item (E) of Section 4 of Act 403 of 2019, for repair or replacement of
14 equipment and library holdings, in a sum not to exceed\$279,520.
15

16 SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is
17 hereby appropriated, to the Black River Technical College, to be payable from
18 the Development and Enhancement Fund, for the Black River Technical College
19 the following:

20 (A) Effective July 1, 2020, the balance of the appropriation provided
21 in Item (A) of Section 6 of Act 403 of 2019, for the renovation of the "A"
22 and "B" Buildings, in a sum not to exceed\$157,500.

23 (B) Effective July 1, 2020, the balance of the appropriation provided
24 in Item (B) of Section 6 of Act 403 of 2019, for the construction of a
25 storage building for Fire Science Program truck and equipment, in a sum not
26 to exceed\$157,500.

27 (C) Effective July 1, 2020, the balance of the appropriation provided
28 in Item (C) of Section 6 of Act 403 of 2019, for equipment replacement in the
29 Academic Complex/Library, in a sum not to exceed\$54,000.

30 (D) Effective July 1, 2020, the balance of the appropriation provided
31 in Item (D) of Section 6 of Act 403 of 2019, for construction of a storage
32 building for Grounds Maintenance tractors and equipment, in a sum not to
33 exceed\$90,000.

34 (E) Effective July 1, 2020, the balance of the appropriation provided
35 in Item (E) of Section 6 of Act 403 of 2019, for construction, renovation,
36 maintenance, critical maintenance, equipment, security enhancements,

1 technology upgrades/equipment and library resources of a Technical Education
2 Building, in a sum not to exceed\$2,319,000.

3 (F) Effective July 1, 2020, the balance of the appropriation provided
4 in Item (F) of Section 6 of Act 403 of 2019, for heating, ventilation, and
5 air conditioning replacement in the "B" Building, in a sum not to exceed
6\$72,000.

7 (G) Effective July 1, 2020, the balance of the appropriation provided
8 in Item (G) of Section 6 of Act 403 of 2019, for critical maintenance, in a
9 sum not to exceed\$20,000.

10 (H) Effective July 1, 2020, the balance of the appropriation provided
11 in Item (H) of Section 6 of Act 403 of 2019, for deferred maintenance, in a
12 sum not to exceed\$400,000.

13 (I) Effective July 1, 2020, the balance of the appropriation provided
14 in Item (I) of Section 6 of Act 403 of 2019, for repair or replacement of
15 equipment and library holdings, in a sum not to exceed\$184,330.

17 SECTION 7. REAPPROPRIATION - COLLEGE OF THE OUACHITAS. There is hereby
18 appropriated, to the College of The Ouachitas, to be payable from the
19 Development and Enhancement Fund, for the College of The Ouachitas the
20 following:

21 (A) Effective July 1, 2020, the balance of the appropriation provided
22 in Item (A) of Section 7 of Act 403 of 2019, for construction, renovation,
23 maintenance, critical maintenance, equipment, security enhancements,
24 technology upgrades/equipment and library resources of the Health/Science
25 Technology Building, in a sum not to exceed\$1,850,000.

26 (B) Effective July 1, 2020, the balance of the appropriation provided
27 in Item (B) of Section 7 of Act 403 of 2019, for construction, renovation,
28 maintenance, critical maintenance, equipment, security enhancements,
29 technology upgrades/equipment and library resources of the Conference and
30 Student Center, in a sum not to exceed\$1,000,000.

31 (C) Effective July 1, 2020, the balance of the appropriation provided
32 in Item (C) of Section 7 of Act 403 of 2019, for deferred maintenance, in a
33 sum not to exceed\$210,000.

34 (D) Effective July 1, 2020, the balance of the appropriation provided
35 in Item (D) of Section 7 of Act 403 of 2019, for repair or replacement of
36 equipment and library holdings, in a sum not to exceed\$117,495.

1 SECTION 8. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE
2 UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot
3 Community College of the University of Arkansas, to be payable from the
4 Development and Enhancement Fund, for the Cossatot Community College of the
5 University of Arkansas the following:

6 (A) Effective July 1, 2020, the balance of the appropriation provided
7 in Item (A) of Section 8 of Act 403 of 2019, for upgrades to network
8 technology infrastructure, in a sum not to exceed\$600,000.

9 (B) Effective July 1, 2020, the balance of the appropriation provided
10 in Item (B) of Section 8 of Act 403 of 2019, for disaster recovery/business
11 continuity technology infrastructure, in a sum not to exceed\$60,000.

12 (C) Effective July 1, 2020, the balance of the appropriation provided
13 in Item (C) of Section 8 of Act 403 of 2019, for generator/backup power
14 source technology infrastructure, in a sum not to exceed\$40,000.

15 (D) Effective July 1, 2020, the balance of the appropriation provided
16 in Item (D) of Section 8 of Act 403 of 2019, for maintenance related to
17 heating, ventilation, and air conditioning for building system failure, in a
18 sum not to exceed\$60,000.

19 (E) Effective July 1, 2020, the balance of the appropriation provided
20 in Item (E) of Section 8 of Act 403 of 2019, for critical maintenance, in a
21 sum not to exceed\$50,000.

22 (F) Effective July 1, 2020, the balance of the appropriation provided
23 in Item (F) of Section 8 of Act 403 of 2019, for deferred maintenance, in a
24 sum not to exceed\$300,000.

25 (G) Effective July 1, 2020, the balance of the appropriation provided
26 in Item (G) of Section 8 of Act 403 of 2019, for repair or replacement of
27 equipment and library holdings, in a sum not to exceed\$136,975.

28
29 SECTION 9. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE. There is
30 hereby appropriated, to the East Arkansas Community College, to be payable
31 from the Development and Enhancement Fund, for the East Arkansas Community
32 College the following:

33 (A) Effective July 1, 2020, the balance of the appropriation provided
34 in Item (A) of Section 9 of Act 223 of 2019, for construction, renovation,
35 maintenance, critical maintenance, equipment, security enhancements,
36 technology upgrades/equipment and library resources, in a sum not to exceed

1\$250,000.

2 (B) Effective July 1, 2020, the balance of the appropriation provided
3 in Item (B) of Section 9 of Act 223 of 2019, for deferred maintenance, in a
4 sum not to exceed\$150,000.

5 (C) Effective July 1, 2020, the balance of the appropriation provided
6 in Item (L) of Section 9 of Act 223 of 2019, for transfers of or refund to
7 expenditures for capital balances for construction, renovation, major
8 maintenance, and purchase of equipment for various capital projects or
9 facility improvements, in a sum not to exceed\$534,237.

10 (D) Effective July 1, 2020, the balance of the appropriation provided
11 in Item (A) of Section 9 of Act 403 of 2019, for renovation of technology
12 infrastructure and systems, in a sum not to exceed\$363,500.

13 (E) Effective July 1, 2020, the balance of the appropriation provided
14 in Item (B) of Section 9 of Act 403 of 2019, for renovation and expansion of
15 the Maintenance Building, in a sum not to exceed\$280,950.

16 (F) Effective July 1, 2020, the balance of the appropriation provided

1 upgrades, in a sum not to exceed\$734,400.

2 (B) Effective July 1, 2020, the balance of the appropriation provided
3 in Item (B) of Section 10 of Act 403 of 2019, for upgrades to technology
4 infrastructure, in a sum not to exceed\$1,591,000.

5 (C) Effective July 1, 2020, the balance of the appropriation provided
6 in Item (C) of Section 10 of Act 403 of 2019, for renovation of the Gerald
7 Fisher Center, in a sum not to exceed\$1,049,600.

8 (D) Effective July 1, 2020, the balance of the appropriation provided
9 in Item (D) of Section 10 of Act 403 of 2019, for critical maintenance, in a
10 sum not to exceed\$110,000.

11 (E) Effective July 1, 2020, the balance of the appropriation provided

24 equipment, acquisition, furnishing, personal services, maintenance and
25 operations expenses of the Searcy County campuses, in a sum not to exceed
26\$23,800.

27 (B) Effective July 1, 2020, the balance of the appropriation provided
28 in Item (A) of Section 11 of Act 403 of 2019, for renovation and replacement
29 of sliding glass doors, in a sum not to exceed\$100,000.

30 (C) Effective July 1, 2020, the balance of the appropriation provided
31 in Item (B) of Section 11 of Act 403 of 2019, for renovation of tiered
32 classrooms to comply with the Americans with Disabilities Act, in a sum not
33 to exceed\$75,000.

25 (A) Effective July 1, 2020, the balance of the appropriation provided
26 in Item (A) of Section 12 of Act 403 of 2019, for construction, renovation,
27 maintenance, critical maintenance, equipment, security enhancements,
28 technology upgrades/equipment and library resources of the Washington County
29 Center, in a sum not to exceed\$1,000,000.

30 (B) Effective July 1, 2020, the balance of the appropriation provided
31 in Item (B) of Section 12 of Act 403 of 2019, for construction, renovation,
32 maintenance, critical maintenance, equipment, security enhancements,
33 technology upgrades/equipment and library resources of the new Physical Plant
34 facility, in a sum not to exceed\$1,000,000.

35 (C) Effective July 1, 2020, the balance of the appropriation provided
36 in Item (C) of Section 12 of Act 403 of 2019, for purchase of the former

1 railroad property, in a sum not to exceed\$621,000.

2 (D) Effective July 1, 2020, the balance of the appropriation provided
3 in Item (D) of Section 12 of Act 403 of 2019, for the construction of storm
4 drainage, leveling and replanting for the grounds covered by the railroad
5 spur after removal, in a sum not to exceed\$190,000.

8 maintenance, critical maintenance, equipment, security enhancements, and

25 Center, in a sum not to exceed\$1,850,000.

26 (B) Effective July 1, 2020, the balance of the appropriation provided
27 in Item (B) of Section 13 of Act 403 of 2019, for construction, renovation,
28 maintenance, critical maintenance, equipment, security enhancements,
29 technology upgrades/equipment and library resources of an Information
30 Technology Center, in a sum not to exceed\$1,000,000.

31 (C) Effective July 1, 2020, the balance of the appropriation provided
32 in Item (C) of Section 13 of Act 403 of 2019, for critical maintenance, in a
33 sum not to exceed\$10,000.

34 (D) Effective July 1, 2020, the balance of the appropriation provided

10 (A) Effective July 1, 2020, the balance of the appropriation provided
11 in Item (A) of Section 14 of Act 403 of 2019, for campus security upgrades,
12 in a sum not to exceed\$100,000.

13 (B) Effective July 1, 2020, the balance of the appropriation provided
14 in Item (B) of Section 14 of Act 403 of 2019, for Americans with Disabilities
15 Act improvements to various buildings on the Helena-West Helena Campus, in a
16 sum not to exceed\$280,000.

17 (C) Effective July 1, 2020, the balance of the appropriation provided
18 in Item (C) of Section 14 of Act 403 of 2019, for roof repair or roof
19 replacement for four (4) buildings on the Helena-West Helena Campus and the
20 Training Center - Dewitt Campus, in a sum not to exceed\$1,000,000.

6 SECTION 28. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
7 obligations otherwise incurred in relation to the project or projects
8 described herein in excess of the State Treasury funds actually available
9 therefor as provided by law. Provided, however, that institutions and
10 agencies listed herein shall have the authority to accept and use grants and
11 donations including Federal funds, and to use its unobligated cash income or
12 funds, or both available to it, for the purpose of supplementing the State
13 Treasury funds for financing the entire costs of the project or projects
14 enumerated herein. Provided further, that the appropriations and funds
15 otherwise provided by the General Assembly for Maintenance and General
16 Operations of the agency or institutions receiving appropriation herein shall
17 not be used for any of the purposes as appropriated in this act.

18 (B) The restrictions of any applicable provisions of the State
19 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
20 Revenue Stabilization Law and any other applicable fiscal control laws of
21 this State and regulations promulgated by the Department of Finance and
22 Administration, as authorized by law, shall be strictly complied with in
23 disbursement of any funds provided by this act unless specifically provided
24 otherwise by law.
25

26 SECTION 29. LEGISLATIVE INTENT. It is the intent of the General
27 Assembly that any funds disbursed under the authority of the appropriations
28 contained in this act shall be in compliance with the stated reasons for
29 which this act was adopted, as evidenced by the Agency Requests, Executive
30 Recommendations and Legislative Recommendations contained in the budget
31 manuals prepared by the Department of Finance and Administration, letters, or
32 summarized oral testimony in the official minutes of the Arkansas Legislative
33 Council or Joint Budget Committee which relate to its passage and adoption.
34

35 SECTION 30. EMERGENCY CLAUSE. It is found and determined by the
36 General Assembly, that the Constitution of the State of Arkansas prohibits

1 the appropriation of funds for more than a one (1) year period; that the
2 effectiveness of this Act on July 1, 2020 is essential to the operation of
3 the agency for which the appropriations in this Act are provided, and that in
4 the event of an extension of the legislative session, the delay in the
5 effective date of this Act beyond July 1, 2020 could work irreparable harm
6 upon the proper administration and provision of essential governmental
7 programs. Therefore, an emergency is hereby declared to exist and this Act
8 being necessary for the immediate preservation of the public peace, health
9 and safety shall be in full force and effect from and after July 1, 2020.
