28	28-65-802. Defin	itions.	
29	As used in this s		
30		"Adult" means an individual:	
31		(A) Eighteen (18) years of ag	ge or older; or
32		(B) Under eighteen (18) years	s of age who has been
33	emancipated;		_
34	<u>(2)</u>	"Disability" means a physical of	or mental impairment
35	that substantially limi	ts one (1) or more activities of	of daily living;
36	(3)	"Supported decision-making" mea	ans a process of

1	supporting and accommodating an adult with a disability to enable him or her
2	to make life decisions without impeding the self-determination of the adult
3	with a disability, including without limitation decisions related to:
4	(A) Where the adult with a disability wants to live;
5	(B) The services, supports, and medical care the
6	adult with a disability wants to receive;
7	(C) With whom the adult with a disability wants to
8	live; and
9	(D) Where the adult with a disability wants to work;
10	(4) "Supported decision-making agreement" means an
11	agreement between an adult with a disability and a supporter entered into
12	under this subchapter; and
13	(5) "Supporter" means an adult who has entered into a
14	supported decision-making agreement with an adult with a disability.
15	
16	28-65-803. Purpose.
17	The purpose of this subchapter is to recognize a less restrictive
18	alternative to guardianship for an adult with a disability who needs
19	assistance with decisions regarding daily living but who is not considered an
20	incapacitated person for purposes of establishing a guardianship under this
21	<u>chapter.</u>
22	
23	28-65-804. Scope of supported decision-making agreement.
24	An adult with a disability, without undue influence or coercion, may
25	voluntarily enter into a supported decision-making agreement with a supporter
26	under which the adult with a disability authorizes the supporter to do one
27	(1) or more of the following:
28	(1) Provide supported decision-making, including without
29	limitation assistance in understanding the options, responsibilities, and
30	consequences of the life decisions of the adult with a disability, without
31	making the life decision on behalf of the adult with a disability;
32	(2) Assist the adult with a disability in accessing, collecting,
33	and obtaining information that is relevant to a life decision, including
34	without limitation information from the adult with a disability's medical,
35	psychological, financial, educational, and treatment records;
36	(3) Assist the adult with a disability in understanding the

1	information described in subdivision (2) of this section; and
2	(4) Assist the adult with a disability in communicating the life
3	decision of the adult with a disability to the appropriate person.
4	
5	28-65-805. Authority of supporter - Nature of relationship.
6	(a) A supporter may exercise the authority granted to the supporter in
7	the supported decision-making agreement.
8	(b) The supporter owes to the adult with a disability the fiduciary
9	duties listed in the form provided under § 28-65-812, regardless of whether
10	that form is used for the supported decision-making agreement.
11	(c) The relationship between an adult with a disability and the
12	supporter with whom the adult with a disability has entered into a supported
13	decision-making agreement:
14	(1) Is one of trust and confidence; and
15	(2) Does not undermine the decision-making authority of the
16	adult with a disability.
17	
18	28-65-806. Designation of alternate supporter in certain
19	circumstances.
20	In order to prevent a conflict of interest, if an adult with a
21	disability determines that the supporter with whom the adult with a
22	disability has entered into a supported decision-making agreement is the most
23	appropriate person to provide supports and services to the adult with a
24	disability for which the supporter will be compensated, the adult with a
25	disability may amend the supported decision-making agreement to designate an
26	alternate person to act as the supporter of the adult with a disability for
27	the limited purpose of participating in person-centered planning related to
28	the provision of those supports and services.
29	
30	28-65-807. Term of agreement.
31	(a) Except as provided by subsection (b) of this section, the
32	supported decision-making agreement extends until terminated by either party
33	or by the terms of the agreement.
34	(b) The supported decision-making agreement is terminated if:
35	(1) The Adult Protective Services Unit of the Department of

Human Services finds that the adult with a disability has been abused,

1 neglected, or exploited by the supporter; 2 (2) The supporter is found criminally liable for conduct 3 described in subdivision (b)(1) of this section; or 4 (3)(A) A temporary or permanent guardian of the person or 5 guardian of the estate is appointed for the adult with a disability. 6 (B) The termination of a supported decision-making 7 agreement under subdivision (b)(3)(A) of this section does not prohibit an 8 adult with a disability from executing another supported decision-making 9 agreement if the guardianship is terminated. 10 11 28-65-808. Access to personal information. 12 (a) A supporter is only authorized to assist the adult with a 13 disability in accessing, collecting, or obtaining information that is 14 relevant to a life decision covered under the supported decision-making 15 agreement. 16 (b) If a supporter assists an adult with a disability in accessing, 17 collecting, or obtaining the adult with a disability's personal information, 18 including protected health information under the Health Insurance Portability 19 and Accountability Act of 1996, Pub. L. No. 104-191, or educational records 20 under the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g, as it existed on January 1, 2021, the supporter shall ensure the 21 22 information is kept privileged and confidential, as applicable, and protected 23 from unauthorized access, use, or disclosure. 24 (c) The existence of a supported decision-making agreement does not 25 preclude an adult with a disability from seeking personal information without 26 the assistance of a supporter. 27 28-65-809. Authorizing and witnessing of supported decision-making 28 29 agreement. 30 (a) A supported decision-making agreement shall be signed voluntarily, 31 without coercion or undue influence, by the adult with a disability and the 32 supporter in the presence of two (2) or more attesting witnesses or a notary 33 public. 34 (b) If the supported decision-making agreement is signed before two 35 (2) or more attesting witnesses, the attesting witnesses are required to be

at least fourteen (14) years of age.

2	28-65-810. Reliance on supported decision-making agreement —
3	Limitation of liability.
4	(a) A person who receives the original or a copy of a supported
5	decision-making agreement shall rely on the agreement.
6	(b) A person is not subject to criminal or civil liability and has not
7	engaged in professional misconduct for an act or omission if the act or
8	omission is done in good faith and in reliance on a supported decision-making
9	agreement.
10	
11	28-65-811. Reporting of suspected abuse, neglect, or exploitation.
12	If a person who receives a copy of a supported decision-making
13	agreement or is otherwise aware of the existence of a supported decision-
14	making agreement has cause to believe that the adult with a disability is
15	being abused, neglected, or exploited by the supporter, the person shall
16	report the alleged abuse, neglect, or exploitation to the Adult Protective
17	Services Unit of the Department of Human Services.
18	
19	28-65-812. Form of supported decision-making agreement.
20	(a) Except as provided in subsection (b) of this section, a supported
21	decision-making agreement is valid only if it is in substantially the
22	following form:
23	"SUPPORTED DECISION-MAKING AGREEMENT
24	
25	IMPORTANT INFORMATION FOR SUPPORTER: DUTIES
26	
27	When you agree to provide support to an adult with a disability under
28	this supported decision-making agreement, you have a duty to:
29	(1) Act in good faith;
30	(2) Act within the authority granted in this agreement;
31	(3) Act loyally and without self-interest; and
32	(4) Avoid conflicts of interest.
33	
34	APPOINTMENT OF SUPPORTER

24	() A release allowing my supporter to see educational records under	
25	the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g, as	
26	it existed on January 1, 2021, is attached.

28	EFFECTIVE DATE OF SUPPORTED DECISION-MAKING AGREEMENT

6	DISABILITY IS BEING ABUSED, NEGLECTED, OR EXPLOITED BY THE SUPPORTER, THE
7	PERSON SHALL REPORT THE ALLEGED ABUSE, NEGLECT, OR EXPLOITATION TO THE ADULT
8	PROTECTIVE SERVICES UNIT OF THE DEPARTMENT OF HUMAN SERVICES."

11	of this subchapter.
