 36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS

1 STATE BOARD OF PUBLIC ACCOUNTANCY - PROMOTIONAL ITEMS. Upon approval of the
2 Chief Fiscal Officer of the State, the Arkansas State Board of Public
3 Accountancy is hereby authorized to transfer appropriation from Operating
4 Expenses to Promotional Items in the appropriation authorized by the Arkansas
5 State Board of Public Accountancy - Operations Appropriation in this Act in
6 an amount not to exceed five hundred dollars (\$500) each fiscal year to meet
7 the Board's educational needs.

8 The provisions of this section shall be in effect only from July 1, ~~2021~~
9 2022 through June 30, ~~2022~~ 2023.

11 SECTION 54. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
13 PROFESSIONAL BAIL BONDS COMPANY AND PROFESSIONAL BAIL BONDSMAN LICENSING
14 BOARD - FUND TRANSFER. The Professional Bail Bonds Company and Professional
15 Bail Bondsman Licensing Board shall deposit as special revenues sufficient
16 fees and penalties directly into the Bail Bondsman Board fund to provide for
17 personal services and operating expenses for the board. At the end of each
18 fiscal year, the Professional Bail Bondsman Licensing Board shall be allowed
19 to retain a fund balance sufficient to cover the personal services and
20 operating expenses of the board for the following fiscal year. Seventy-five
21 percent (75%) of any funds remaining in excess of this balance shall be
22 transferred to the General Revenue Fund Account in the State Treasury.

23 The provisions of this section shall be in effect only from July 1, ~~2021~~

26 SECTION 55. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE
28 BOARD OF BARBER EXAMINERS - APPLICANT PROXIMITY TO EXISTING BARBER COLLEGES.
29 Notwithstanding any other provisions under Arkansas Law, the State Board of
30 Barber Examiners shall not deny any application for the establishment of a
31 new barber college on the basis of geographic proximity to an existing barber
32 college.

33 The provisions of this section shall be in effect only from July 1, ~~2021~~
34 2022 through June 30, ~~2022~~ 2023.

35
36 SECTION 56. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

1 authorized by this act shall be limited to the appropriation for such agency
2 and funds made available by law for the support of such appropriations; and
3 the restrictions of the State Procurement Law, the General Accounting and
4 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
5 Procedures and Restrictions Act, or their successors, and other fiscal
6 control laws of this State, where applicable, and regulations promulgated by
7 the Department of Finance and Administration, as authorized by law, shall be
8 strictly complied with in disbursement of said funds.

9
10 SECTION 57. LEGISLATIVE INTENT. It is the intent of the General
11 Assembly that any funds disbursed under the authority of the appropriations
12 contained in this act shall be in compliance with the stated reasons for
13 which this act was adopted, as evidenced by the Agency Requests, Executive
14 Recommendations and Legislative Recommendations contained in the budget
15 manuals prepared by the Department of Finance and Administration, letters, or
16 summarized oral testimony in the official minutes of the Arkansas Legislative
17 Council or Joint Budget Committee which relate to its passage and adoption.

18
19 SECTION 58. EFFECTIVE DATE. This act is effective on and after July 1,
20 2022.
