18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
21 hereby appropriated, to the Arkansas Northeastern College, to be payable from
22 the General Improvement Fund or its successor fund or fund accounts, for the
23 Arkansas Northeastern College the following:

24 (A) Effective July 1, 2014, the balance of the appropriation provided
25 in Item (A) Section 1 of Act 254 of 2013, for construction of a Nursing and
26 Allied Health building at the Paragould campus, in a sum not to
27 exceed.....\$2,650,000.

28 (B) Effective July 1, 2014, the balance of the appropriation provided
29 in Item (B) Section 1 of Act 254 of 2013, for deferred maintenance, in a sum
30 not to exceed.....\$290,000.

31 (C) Effective July 1, 2014, the balance of the appropriation provided
32 in Item (C) Section 1 of Act 254 of 2013, for repair or replacement of
33 equipment and library holdings, in a sum not to exceed.....\$184,130.

34 (D) Effective July 1, 2014, the balance of the appropriation provided
35 in Item (D) Section 1 of Act 254 of 2013, for personal services, operating
36 expenses and grants to support the continuation of the Arkansas Delta



1 Training and Education Consortium University Center initiatives, in a sum not
2 to exceed.....\$240,000.

3 (E) Effective July 1, 2014, the balance of the appropriation provided
4 in Item (E) Section 1 of Act 254 of 2013, for personal services, operating
5 expenses and economic development grants to support the continuation of
6 Arkansas Delta Training and Education Consortium initiatives, in a sum not to
7 exceed.....\$415,681.

8 (F) Effective July 1, 2014, the balance of the appropriation provided
9 in Item (A) Section 1 of Act 370 of 2013, for construction, renovation,
10 maintenance, critical maintenance, equipment, security enhancements,
11 technology upgrades/equipment and library resources, in a sum not to
12 exceed.....\$1,000,000.

13 (G) Effective July 1, 2014, the balance of the appropriation provided
14 in Item (A) Section 12 of Act 629 of 2013, for construction, renovation,
15 maintenance, critical maintenance, equipment, security enhancements,
16 technology upgrades/equipment and library resources, in a sum not to
17 exceed.....\$10,000,000.

18
19 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There
20 is hereby appropriated, to the Arkansas State University - Beebe, to be
21 payable from the General Improvement Fund or its successor fund or fund
22 accounts, for the Arkansas State University - Beebe the following:

23 (A) Effective July 1, 2014, the balance of the appropriation provided
24 in Item (A) Section 2 of Act 254 of 2013, for expansion of the Heber Springs
25 Academic Center, in a sum not to exceed.....\$1,500,000.

26 (B) Effective July 1, 2014, the balance of the appropriation provided
27 in Item (B) Section 2 of Act 254 of 2013, for renovations of State Hall, in a
28 sum not to exceed.....\$1,500,000.

29 (C) Effective July 1, 2014, the balance of the appropriation provided
30 in Item (C) Section 2 of Act 254 of 2013, for deferred maintenance, in a sum
31 not to exceed.....\$850,000.

32 (D) Effective July 1, 2014, the balance of the appropriation provided
33 in Item (D) Section 2 of Act 254 of 2013, for repair or replacement of

35 (E) Effective July 1, 2014, the balance of the appropriation provided

2 - Heber Springs Campus Academic Building addition, in a sum not to exceed
3\$2,250,000.

4 (F) Effective July 1, 2014, the balance of the appropriation provided
5 in Item (A) Section 13 of Act 629 of 2013, for construction, renovation,
6 maintenance, critical maintenance, equipment, security enhancements,
7 technology upgrades/equipment and library resources, in a sum not to exceed
8\$10,000,000.

9
10 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

11 There is hereby appropriated, to the Arkansas State University - Mountain
12 Home, to be payable from the General Improvement Fund or its successor fund
13 or fund accounts, for the Arkansas State University - Mountain Home the
14 following:

15 (A) Effective July 1, 2014, the balance of the appropriation provided
16 in Item (A) Section 3 of Act 254 of 2013, for construction of the Vada Sheid
17 Community Development Center, in a sum not to exceed.....\$1,500,000.

18 (B) Effective July 1, 2014, the balance of the appropriation provided
19 in Item (B) Section 3 of Act 254 of 2013, for upgrades to technology
20 infrastructure, in a sum not to exceed.....\$900,000.

21 (C) Effective July 1, 2014, the balance of the appropriation provided
22 in Item (C) Section 3 of Act 254 of 2013, for expansion of the campus
23 security system, in a sum not to exceed.....\$200,000.

24 (D) Effective July 1, 2014, the balance of the appropriation provided
25 in Item (D) Section 3 of Act 254 of 2013, for deferred maintenance, in a sum
26 not to exceed.....\$120,000.

27 (E) Effective July 1, 2014, the balance of the appropriation provided
28 in Item (E) Section 3 of Act 254 of 2013, for repair or replacement of
29 equipment and library holdings, in a sum not to exceed.....\$160,010.

30 (F) Effective July 1, 2014, the balance of the appropriation provided
31 in Item (A) Section 1 of Act 372 of 2013, for technology infrastructure
32 upgrade and renovation expenses, in a sum not to exceed.....\$900,000.

33 (G) Effective July 1, 2014, the balance of the appropriation provided
34 in Item (A) Section 14 of Act 629 of 2013, for construction, renovation,
35 maintenance, critical maintenance, equipment, security enhancements,
36 technology upgrades/equipment and library resources, in a sum not to exceed

1\$10,000,000.

3 SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

4 There is hereby appropriated, to the Arkansas State University - Newport, to
5 be payable from the General Improvement Fund or its successor fund or fund
6 accounts, for the Arkansas State University - Newport the following:

7 (A) Effective July 1, 2014, the balance of the appropriation provided
8 in Item (A) Section 4 of Act 254 of 2013, for construction of a
9 Classroom/Laboratory building on the Jonesboro campus, in a sum not to exceed
10\$500,000.

11 (B) Effective July 1, 2014, the balance of the appropriation provided
12 in Item (B) Section 4 of Act 254 of 2013, for construction of a
13 Workforce/Administration building on the Marked Tree campus, in a sum not to
14 exceed.....\$1,500,000.

15 (C) Effective July 1, 2014, the balance of the appropriation provided
16 in Item (C) Section 4 of Act 254 of 2013, for construction of a Classroom
17 building for the Technical Center on the Jonesboro campus, in a sum not to
18 exceed.....\$325,000.

19 (D) Effective July 1, 2014, the balance of the appropriation provided
20 in Item (D) Section 4 of Act 254 of 2013, for construction of a Classroom
21 building on the Newport campus, in a sum not to exceed.....\$325,000.

22 (E) Effective July 1, 2014, the balance of the appropriation provided

24 not to exceed.....\$260,000.

25 (F) Effective July 1, 2014, the balance of the appropriation provided

28 (G) Effective July 1, 2014, the balance of the appropriation provided

32 to exceed.....\$103,612.

33 (H) Effective July 1, 2014, the balance of the appropriation provided

35 expenses and economic development grants to support the continuation of
36 Arkansas Delta Training and Education Consortium initiatives, in a sum not to

2 (I) Effective July 1, 2014, the balance of the appropriation provided
3 in Item (A) Section 1 of Act 357 of 2013, for parking lot renovations,
4 resurfacing, paving, landscaping, painting, operating expenses, equipment,
5 and lighting expenses of the Marked Tree campus, in a sum not to exceed
6\$150,000.

7 (J) Effective July 1, 2014, the balance of the appropriation provided
8 in Item (A) Section 1 of Act 360 of 2013, for supplies, materials, utilities,
9 infrastructure, furnishing, personal services, and operating expenses, in a
10 sum not to exceed.....\$500,000.

11 (K) Effective July 1, 2014, the balance of the appropriation provided
12 in Item (A) Section 15 of Act 629 of 2013, for construction, renovation,
13 maintenance, critical maintenance, equipment, security enhancements,
14 technology upgrades/equipment and library resources, in a sum not to exceed
15\$10,000,000.

17 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As
19 referenced in Section 3(c) of Act 1518 of 2013 and Section 3(c) of Act 1519
20 of 2013, the authorized funding for the Arkansas State University - Newport
21 for parking lot renovations, resurfacing, paving, landscaping, painting, and
22 lighting expenses of the Marked Tree campus shall be deemed to also include
23 operating expenses and equipment.

24
25 SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE - GENERAL
26 IMPROVEMENT. There is hereby appropriated, to the Black River Technical
27 College, to be payable from the General Improvement Fund or its successor
28 fund or fund accounts, for the Black River Technical College the following:

29 (A) Effective July 1, 2014, the balance of the appropriation provided
30 in Item (A) Section 5 of Act 254 of 2013, for expansion of existing academic
31 facilities on the Paragould campus, in a sum not to exceed.....\$1,500,000.

32 (B) Effective July 1, 2014, the balance of the appropriation provided
33 in Item (B) Section 5 of Act 254 of 2013, for renovations to the "A" and "B"
34 buildings, in a sum not to exceed.....\$1,200,000.

35 (C) Effective July 1, 2014, the balance of the appropriation provided
36 in Item (C) Section 5 of Act 254 of 2013, for deferred maintenance, in a sum

1 not to exceed.....\$310,000.

2 (D) Effective July 1, 2014, the balance of the appropriation provided
3 in Item (D) Section 5 of Act 254 of 2013, for repair or replacement of
4 equipment and library holdings, in a sum not to exceed.....\$280,070.

5 (E) Effective July 1, 2014, the balance of the appropriation provided

8 technology upgrades/equipment and library resources at the Pocahontas campus,
9 in a sum not to exceed.....\$300,000.

10 (F) Effective July 1, 2014, the balance of the appropriation provided
11 in Item (A) Section 16 of Act 629 of 2013, for construction, renovation,
12 maintenance, critical maintenance, equipment, security enhancements,
13 technology upgrades/equipment and library resources, in a sum not to exceed
14\$10,000,000.

16 SECTION 7. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE - TRUST -
17 REACH PHASE III. There is hereby appropriated, to the Black River Technical
18 College, to be payable from the Arkansas Natural and Cultural Resources Grant
19 and Trust Fund, for the Black River Technical College the following:

20 (A) Effective July 1, 2014, the balance of the appropriation provided
21 in Item (01) Section 31 of Act 932 of 2013, for the acquisition, management,
22 stewardship or preservation of state owned lands, historic sites, buildings,
23 structures or objects, in a sum not to exceed.....\$250,000.

24
25 SECTION 8. REAPPROPRIATION - COLLEGE OF THE OUACHITAS. There is hereby
26 appropriated, to the College of The Ouachitas, to be payable from the General
27 Improvement Fund or its successor fund or fund accounts, for the College of
28 The Ouachitas the following:

29 (A) Effective July 1, 2014, the balance of the appropriation provided
30 in Item (E) Section 6 of Act 245 of 2013, for course materials, operations
31 and programmatic costs for the Nursing Program, in a sum not to exceed

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 33 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 845 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$1,000,000.

SECTION 29. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State

1 and regulations promulgated by the Department of Finance and Administration,
2 as authorized by law, shall be strictly complied with in disbursement of any
3 funds provided by this act unless specifically provided otherwise by law.
4

5 SECTION 30. LEGISLATIVE INTENT. It is the intent of the General
6 Assembly that any funds disbursed under the authority of the appropriations
7 contained in this act shall be in compliance with the stated reasons for
8 which this act was adopted, as evidenced by the Agency Requests, Executive
9 Recommendations and Legislative Recommendations contained in the budget
10 manuals prepared by the Department of Finance and Administration, letters, or
11 summarized oral testimony in the official minutes of the Arkansas Legislative
12 Council or Joint Budget Committee which relate to its passage and adoption.
13

14 SECTION 31. EMERGENCY CLAUSE. It is found and determined by the
15 General Assembly, that the Constitution of the State of Arkansas prohibits
16 the appropriation of funds for more than a one (1) year period; that the
17 effectiveness of this Act on July 1, 2014 is essential to the operation of
18 the agency for which the appropriations in this Act are provided, and that in
19 the event of an extension of the legislative session, the delay in the
20 effective date of this Act beyond July 1, 2014 could work irreparable harm
21 upon the proper administration and provision of essential governmental
22 programs. Therefore, an emergency is hereby declared to exist and this Act
23 being necessary for the immediate preservation of the public peace, health
24 and safety shall be in full force and effect from and after July 1, 2014.
