9 AND OPERATING EXPENSES AND FOR GRANTS AND AID TO

11 DEPARTMENT OF CAREER EDUCATION FOR THE FISCAL YEAR

 35 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FEDERAL  
 36 MATCHING. The funds appropriated in Sections for Adult Basic and General

1 Adult Education, Coordinated Career Education Services, Vocational Center Aid  
2 and Vocational Start-up Grants and Aid of this Act may also be used to match  
3 any available federal funds from any agency in order to provide the maximum  
4 amount of money possible for the purposes enumerated in such Section.

8 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

10 VOCATIONAL START-UP. The funds and appropriations contained herein for  
11 Vocational Start-Up shall be allocated in accordance with rules ~~and~~

13 Board, after the rules ~~and regulations~~ have undergone a ~~prior~~ review and

21 EDUCATIONAL TRAINING/RETRAINING. Of the funds and appropriation authorized by  
22 Item (01) in the Section of this Act for Adult Basic and General Adult  
23 Education, a sum of \$300,000 each fiscal year shall be made available to  
24 eligible entities approved by the Career Education and Workforce Development  
25 Board, in order to expand the vocational education and training opportunities  
26 available to area citizens in need of adult educational training or  
27 retraining due to changing technology.

28 Further, if the appropriation is not fully funded due to a decrease in  
29 the official revenue forecast or the available carryover balance of the  
30 Department of Career Education Public School Fund Account, the Department of  
31 Career Education may reduce proportionally the amount made available to  
32 eligible entities approved by the Career Education and Workforce Development  
33 Board in order to expand the vocational education and training opportunities  
34 to area citizens in need of adult educational training or retraining due to  
35 changing technology.

36 The provisions of this section shall be in effect only from July 1, ~~2015~~

1 2016 through June 30, ~~2016~~ 2017.

3 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ADULT  
5 EDUCATION DISTRIBUTION. All funds that become available for Adult Education  
6 shall be distributed to those administrative units determined to be operating  
7 efficient and effective adult education programs, under criteria established  
8 by the Career Education and Workforce Development Board. The criteria shall  
9 include the relative efficiency of administration of the program in the  
10 counties served and achievement of federal performance indicators. The Career  
11 Education and Workforce Development Board shall promulgate rules and  
12 regulations for the distribution of funds in accordance with criteria to be  
13 determined by the Board. In the distribution of funds to local units the  
14 Board shall consider performance in meeting state and federal performance  
15 indicators. Unallocated funds will be redistributed based upon need as  
16 determined by the Career Education and Workforce Development Board.

17 The provisions of this section shall be in effect only from July 1, ~~2015~~  
18 2016 through June 30, ~~2016~~ 2017.

19  
20 SECTION 28. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
22 OF FUNDS – PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall  
23 establish, upon request from the Department of Career Education, a special  
24 appropriation line item to be used in the acquisition of promotional items.  
25 When the Department of Career Education wishes to transfer monies from its  
26 operating expenses appropriation to the Promotional Items line, the Career  
27 Education and Workforce Development Board shall approve the request and  
28 forward it after receiving prior review and approval by the Arkansas  
29 Legislative Council or Joint Budget Committee, to the Chief Fiscal Officer of  
30 the State for processing.

31 Determining the maximum number of employees and the maximum amount of  
32 appropriation and general revenue funding for a state agency each fiscal year  
33 is the prerogative of the General Assembly. This is usually accomplished by  
34 delineating such maximums in the appropriation act(s) for a state agency and  
35 the general revenue allocations authorized for each fund and fund account by  
36 amendment to the Revenue Stabilization law. Further, the General Assembly

1 has determined that the Department of Career Education may operate more  
2 efficiently if some flexibility is provided to the Department of Career  
3 Education authorizing broad powers under this Section. Therefore, it is both  
4 necessary and appropriate that the General Assembly maintain oversight by  
5 requiring prior approval of the Legislative Council or Joint Budget Committee  
6 as provided by this section. The requirement of approval by the Legislative  
7 Council or Joint Budget Committee is not a severable part of this section.  
8 If the requirement of approval by the Legislative Council or Joint Budget  
9 Committee is ruled unconstitutional by a court of competent jurisdiction,  
10 this entire section is void.

11 The provisions of this section shall be in effect only from July 1, ~~2015~~  
12 2016 through June 30, ~~2016~~ 2017.

13

14 SECTION 29. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
15 authorized by this act shall be limited to the appropriation for such agency  
16 and funds made available by law for the support of such appropriations; and  
17 the restrictions of the State Procurement Law, the General Accounting and  
18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
19 Procedures and Restrictions Act, or their successors, and other fiscal  
20 control laws of this State, where applicable, and regulations promulgated by  
21 the Department of Finance and Administration, as authorized by law, shall be  
22 strictly complied with in disbursement of said funds.

23

24 SECTION 30. LEGISLATIVE INTENT. It is the intent of the General  
25 Assembly that any funds disbursed under the authority of the appropriations  
26 contained in this act shall be in compliance with the stated reasons for  
27 which this act was adopted, as evidenced by the Agency Requests, Executive  
28 Recommendations and Legislative Recommendations contained in the budget  
29 manuals prepared by the Department of Finance and Administration, letters, or  
30 summarized oral testimony in the official minutes of the Arkansas Legislative  
31 Council or Joint Budget Committee which relate to its passage and adoption.

32

33 SECTION 31. EMERGENCY CLAUSE. It is found and determined by the  
34 General Assembly, that the Constitution of the State of Arkansas prohibits  
35 the appropriation of funds for more than a one (1) year period; that the  
36 effectiveness of this Act on July 1, 2016 is essential to the operation of

1 the agency for which the appropriations in this Act are provided, and that in  
2 the event of an extension of the legislative session, the delay in the  
3 effective date of this Act beyond July 1, 2016 could work irreparable harm  
4 upon the proper administration and provision of essential governmental  
5 programs. Therefore, an emergency is hereby declared to exist and this Act  
6 being necessary for the immediate preservation of the public peace, health  
7 and safety shall be in full force and effect from and after July 1, 2016.
