11 FUNDS APPROPRIATED BY ACT 122 OF 2021; AND FOR OTHER

15 AN ACT FOR THE EAST ARKANSAS COMMUNITY
16 COLLEGE SUPPLEMENTAL APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
23 appropriated, to the East Arkansas Community College, to be payable from the
24 East Arkansas Community College Fund, for operating expenses of the East
25 Arkansas Community College which shall be supplemental and in addition to
26 those funds appropriated in Section 3 of Act 122 of 2021, the following:

 3 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 4 authorized by this act shall be limited to the appropriation for such agency
 5 and funds made available by law for the support of such appropriations; and
 6 the restrictions of the State Procurement Law, the General Accounting and
 7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 8 Procedures and Restrictions Act, or their successors, and other fiscal
 9 control laws of this State, where applicable, and regulations promulgated by
 10 the Department of Finance and Administration, as authorized by law, shall be
 11 strictly complied with in disbursement of said funds.

 13 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
 14 Assembly that any funds disbursed under the authority of the appropriations
 15 contained in this act shall be in compliance with the stated reasons for
 16 which this act was adopted, as evidenced by the Agency Requests, Executive
 17 Recommendations and Legislative Recommendations contained in the budget
 18 manuals prepared by the Department of Finance and Administration, letters, or
 19 summarized oral testimony in the official minutes of the Arkansas Legislative
 20 Council or Joint Budget Committee which relate to its passage and adoption.

 22 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
 23 Assembly, that funds provided by the General Assembly for the operations of
 24 the East Arkansas Community College are, due to unforeseen circumstances,
 25 insufficient for the East Arkansas Community College to continue to provide
 26 essential governmental services; that the provisions of this act will provide
 27 the necessary monies for the East Arkansas Community College to continue such
 28 services; and that a delay in the effective date of this Act could work
 29 irreparable harm upon the proper administration and provision of essential
 30 governmental programs. Therefore, an emergency is hereby declared to exist
 31 and this Act being necessary for the immediate preservation of the public
 32 peace, health and safety shall be in full force and effect from and after the
 33 date of its passage and approval.

34 If the bill is neither approved nor vetoed by the Governor, it shall
 35 become effective on the expiration of the period of time during which the
 36 Governor may veto the bill. If the bill is vetoed by the Governor and the

1 veto is overridden, it shall become effective on the date the last house
2 overrides the veto.
