18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
21 hereby appropriated, to the Arkansas Northeastern College, to be payable from
22 the General Improvement Fund or its successor fund or fund accounts, for the
23 Arkansas Northeastern College the following:

24 (A) Effective July 1, 2018, the balance of the appropriation provided
25 in Item (A) of Section 1 of Act 904 of 2017, for construction, renovation,
26 maintenance, critical maintenance, equipment, security enhancements,
27 technology upgrades/equipment and library resources of a Workforce Training
28 Building, in a sum not to exceed\$1,850,000.

29 (B) Effective July 1, 2018, the balance of the appropriation provided
30 in Item (B) of Section 1 of Act 904 of 2017, for construction, renovation,
31 maintenance, critical maintenance, equipment, security enhancements,
32 technology upgrades/equipment and library resources of a Nursing and Allied
33 Health Building in Paragould, in a sum not to exceed\$1,000,000.

34 (C) Effective July 1, 2018, the balance of the appropriation provided
35 in Item (C) of Section 1 of Act 904 of 2017, for critical maintenance, in a
36 sum not to exceed\$350,000.



1 (D) Effective July 1, 2018, the balance of the appropriation provided
2 in Item (D) of Section 1 of Act 904 of 2017, for deferred maintenance, in a
3 sum not to exceed\$360,000.

4 (E) Effective July 1, 2018, the balance of the appropriation provided
5 in Item (E) of Section 1 of Act 904 of 2017, for repair or replacement of
6 equipment and library holdings, in a sum not to exceed\$138,225.

7
8 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There
9 is hereby appropriated, to the Arkansas State University - Beebe, to be
10 payable from the General Improvement Fund or its successor fund or fund
11 accounts, for the Arkansas State University - Beebe the following:

12 (A) Effective July 1, 2018, the balance of the appropriation provided
13 in Item (A) of Section 2 of Act 674 of 2017, for construction, renovation,
14 equipment, maintenance, personal services and operating expenses of the ASU -
15 Heber Springs Campus Academic Building, in a sum not to exceed\$20,000.

16 (B) Effective July 1, 2018, the balance of the appropriation provided
17 in Item (A) of Section 2 of Act 904 of 2017, for construction, renovation,
18 maintenance, critical maintenance, equipment, security enhancements,
19 technology upgrades/equipment and library resources of an IT Services Data
20 Center, in a sum not to exceed\$2,000,000.

21 (C) Effective July 1, 2018, the balance of the appropriation provided
22 in Item (B) of Section 2 of Act 904 of 2017, for renovations of State Hall,
23 in a sum not to exceed\$1,375,000.

24 (D) Effective July 1, 2018, the balance of the appropriation provided
25 in Item (C) of Section 2 of Act 904 of 2017, for critical maintenance, in a
26 sum not to exceed\$110,000.

27 (E) Effective July 1, 2018, the balance of the appropriation provided
28 in Item (D) of Section 2 of Act 904 of 2017, for deferred maintenance, in a
29 sum not to exceed\$1,070,000.

30 (F) Effective July 1, 2018, the balance of the appropriation provided
31 in Item (E) of Section 2 of Act 904 of 2017, for repair or replacement of
32 equipment and library holdings, in a sum not to exceed\$445,250.

33
34 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH.
35 There is hereby appropriated, to the Arkansas State University - Mid-South,
36 to be payable from the General Improvement Fund or its successor fund or fund

1 accounts, for the Arkansas State University - Mid-South the following:

2 (A) Effective July 1, 2018, the balance of the appropriation provided
3 in Item (A) of Section 3 of Act 674 of 2017, for deferred maintenance,
4 construction, renovation, maintenance, equipment, personal services and
5 operating expenses, in a sum not to exceed\$268,072.

6 (B) Effective July 1, 2018, the balance of the appropriation provided
7 in Item (A) of Section 5 of Act 904 of 2017, for upgrade and replacement of
8 Classroom Instructional Technology Equipment, in a sum not to exceed
9\$102,000.

10 (C) Effective July 1, 2018, the balance of the appropriation provided
11 in Item (B) of Section 5 of Act 904 of 2017, for critical maintenance, in a
12 sum not to exceed\$20,000.

13 (D) Effective July 1, 2018, the balance of the appropriation provided
14 in Item (C) of Section 5 of Act 904 of 2017, for deferred maintenance, in a
15 sum not to exceed\$460,000.

16 (E) Effective July 1, 2018, the balance of the appropriation provided
17 in Item (D) of Section 5 of Act 904 of 2017, for repair or replacement of
18 equipment and library holdings, in a sum not to exceed\$159,060.

19

20 SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

21 There is hereby appropriated, to the Arkansas State University - Mountain
22 Home, to be payable from the General Improvement Fund or its successor fund
23 or fund accounts, for the Arkansas State University - Mountain Home the
24 following:

25 (A) Effective July 1, 2018, the balance of the appropriation provided
26 in Item (A) of Section 3 of Act 904 of 2017, for acquisition and renovation
27 of an Occupational Technical Center, in a sum not to exceed\$1,850,000.

28 (B) Effective July 1, 2018, the balance of the appropriation provided
29 in Item (B) of Section 3 of Act 904 of 2017, for construction, renovation,
30 maintenance, critical maintenance, equipment, security enhancements,
31 technology upgrades/equipment and library resources of a Health and Wellness
32 Center, in a sum not to exceed\$1,000,000.

33 (C) Effective July 1, 2018, the balance of the appropriation provided
34 in Item (C) of Section 3 of Act 904 of 2017, for critical maintenance, in a
35 sum not to exceed\$90,000.

36 (D) Effective July 1, 2018, the balance of the appropriation provided

1 in Item (D) of Section 3 of Act 904 of 2017, for deferred maintenance, in a
2 sum not to exceed\$220,000.

3 (E) Effective July 1, 2018, the balance of the appropriation provided
4 in Item (E) of Section 3 of Act 904 of 2017, for repair or replacement of
5 equipment and library holdings, in a sum not to exceed\$162,705.
6

7 SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

8 There is hereby appropriated, to the Arkansas State University - Newport, to
9 be payable from the General Improvement Fund or its successor fund or fund
10 accounts, for the Arkansas State University - Newport the following:

11 (A) Effective July 1, 2018, the balance of the appropriation provided
12 in Item (A) of Section 4 of Act 904 of 2017, for construction, renovation,
13 maintenance, critical maintenance, equipment, security enhancements,
14 technology upgrades/equipment and library resources of a STEM Classroom/Lab
15 Building on the Jonesboro Campus, in a sum not to exceed\$1,000,000.

16 (B) Effective July 1, 2018, the balance of the appropriation provided
17 in Item (B) of Section 4 of Act 904 of 2017, for construction, renovation,
18 maintenance, critical maintenance, equipment, security enhancements,
19 technology upgrades/equipment and library resources of an Administration
20 Building on the Newport Campus, in a sum not to exceed\$750,000.

21 (C) Effective July 1, 2018, the balance of the appropriation provided
22 in Item (C) of Section 4 of Act 904 of 2017, for renovation of a classroom
23 building to provide a Transportation Tech Building on the Newport Campus, in
24 a sum not to exceed\$547,500.

25 (D) Effective July 1, 2018, the balance of the appropriation provided
26 in Item (D) of Section 4 of Act 904 of 2017, for remodel of the Main Building
27 on the Jonesboro Campus, in a sum not to exceed\$552,500.

28 (E) Effective July 1, 2018, the balance of the appropriation provided
29 in Item (E) of Section 4 of Act 904 of 2017, for critical maintenance, in a
30 sum not to exceed\$20,000.

31 (F) Effective July 1, 2018, the balance of the appropriation provided

33 sum not to exceed\$340,000.

34 (G) Effective July 1, 2018, the balance of the appropriation provided
35 in Item (G) of Section 4 of Act 904 of 2017, for repair or replacement of
36 equipment and library holdings, in a sum not to exceed\$264,730.

SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is hereby appropriated, to the Black River Technical College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Black River Technical College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 6 of Act 904 of 2017, for Student Information System upgrades, in a sum not to exceed\$1,062,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 6 of Act 904 of 2017, for the renovation of the "A" and "B" Buildings, in a sum not to exceed\$157,500.

11 maintenance, critical maintenance, equipment, security enhancements,
12 technology upgrades/equipment and library resources of the Health/Science
13 Technology Building, in a sum not to exceed\$1,600,000.

14 (B) Effective July 1, 2018, the balance of the appropriation provided
15 in Item (B) of Section 7 of Act 904 of 2017, for improvements in technology
16 infrastructure, in a sum not to exceed\$250,000.

17 (C) Effective July 1, 2018, the balance of the appropriation provided
18 in Item (C) of Section 7 of Act 904 of 2017, for construction, renovation,
19 maintenance, critical maintenance, equipment, security enhancements,
20 technology upgrades/equipment and library resources of the Conference and

2 in Item (A) of Section 8 of Act 904 of 2017, for technology upgrades, in a
3 sum not to exceed\$600,000.

4 (B) Effective July 1, 2018, the balance of the appropriation provided
5 in Item (B) of Section 8 of Act 904 of 2017, for Heating, Ventilation, and
6 Air Conditioning replacement for the Leeper Building, in a sum not to exceed
7\$58,000.

8 (C) Effective July 1, 2018, the balance of the appropriation provided

10 maintenance, critical maintenance, equipment, security enhancements,

34 (A) Effective July 1, 2018, the balance of the appropriation provided
35 in Section 23 of Act 234 of 2017, for the acquisition, management,
36 stewardship or preservation of state owned lands, historic sites, buildings,

1 structures or objects, in a sum not to exceed\$225,000.

12 (B) Effective July 1, 2018, the balance of the appropriation provided
13 in Item (H) of Section 10 of Act 674 of 2017, for deferred maintenance, in a
14 sum not to exceed\$150,000.

15 (C) Effective July 1, 2018, the balance of the appropriation provided
16 in Item (A) of Section 9 of Act 904 of 2017, for renovation of technology

15 laboratory facility's construction and equipment costs, in a sum not to
16 exceed\$894,375.

17 (C) Effective July 1, 2018, the balance of the appropriation provided

19 of facilities, in a sum not to exceed\$957,000.

36 in Item (B) of Section 10 of Act 904 of 2017, for technology infrastructure

1 improvements, in a sum not to exceed\$1,605,000.

2 (C) Effective July 1, 2018, the balance of the appropriation provided
3 in Item (C) of Section 10 of Act 904 of 2017, for classroom technology, in a
4 sum not to exceed\$720,000.

5 (D) Effective July 1, 2018, the balance of the appropriation provided

22 operations expenses of the Searcy County campuses, in a sum not to exceed
23\$25,000.

24 (B) Effective July 1, 2018, the balance of the appropriation provided
25 in Item (A) of Section 11 of Act 904 of 2017, for an upgrade and replacement
26 of the Administrative ERP and SIS Software System, in a sum not to exceed
27\$1,300,000.

28 (C) Effective July 1, 2018, the balance of the appropriation provided
29 in Item (B) of Section 11 of Act 904 of 2017, for roof renovations for the
30 Durand Center and Library, in a sum not to exceed\$1,000,000.

31 (D) Effective July 1, 2018, the balance of the appropriation provided

33 Campus Student Resource Area, in a sum not to exceed\$100,000.

20 requirements for workforce training in response to the needs of the local
21 business community and the state, in a sum not to exceed\$10,000.

22 (B) Effective July 1, 2018, the balance of the appropriation provided
23 in Item (A) of Section 12 of Act 904 of 2017, for construction of a
24 Washington County Center, in a sum not to exceed\$961,325.

25 (C) Effective July 1, 2018, the balance of the appropriation provided

12 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
13 Revenue Stabilization Law and any other applicable fiscal control laws of
14 this State and regulations promulgated by the Department of Finance and
15 Administration, as authorized by law, shall be strictly complied with in
16 disbursement of any funds provided by this act unless specifically provided
17 otherwise by law.

18
19 SECTION 29. LEGISLATIVE INTENT. It is the intent of the General
20 Assembly that any funds disbursed under the authority of the appropriations
21 contained in this act shall be in compliance with the stated reasons for
22 which this act was adopted, as evidenced by the Agency Requests, Executive
23 Recommendations and Legislative Recommendations contained in the budget
24 manuals prepared by the Department of Finance and Administration, letters, or
25 summarized oral testimony in the official minutes of the Arkansas Legislative
26 Council or Joint Budget Committee which relate to its passage and adoption.

27
28 SECTION 30. EFFECTIVE DATE. This act is effective on and after July 1,
29 2018.
