9 SERVICES AND OPERATING EXPENSES FOR THE ARKANSAS  
10 WATERWAYS COMMISSION FOR THE FISCAL YEAR ENDING  
11 JUNE 30, 2012; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT FOR THE ARKANSAS WATERWAYS  
15 COMMISSION APPROPRIATION FOR THE 2011-2012  
16 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the  
23 Arkansas Waterways Commission for the 2011-2012 fiscal year, the following  
24 maximum number of regular employees.

34 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
35 to the Arkansas Waterways Commission, to be payable from the Miscellaneous  
36 Agencies Fund Account, for personal services and operating expenses of the



1 Arkansas Waterways Commission for the fiscal year ending June 30, 2012, the

 17 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
 19 ASSOCIATION DUES. Of the amounts appropriated for regional contributions by  
 20 item (04) in Section 2 of this Act, three thousand dollars (\$3,000.00), or  
 21 three-sevenths (3/7) whichever is less of the appropriated or funded amount,  
 22 each fiscal year shall be allocated for membership dues for the Lower  
 23 Mississippi Valley Flood Control Association and one thousand dollars  
 24 (\$1,000.00), or one-seventh (1/7) whichever is less of the appropriated or  
 25 funded amount, each fiscal year shall be allocated for membership dues for  
 26 each of the following associations: Ouachita River Valley Association, Red  
 27 River Valley Association, Arkansas Basin Association, and White River Valley  
 28 Coalition.

29 The provisions of this section shall be in effect only from July 1, ~~2010~~  
 30 2011 through June 30, ~~2011~~ 2012.

31  
 32 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 33 authorized by this act shall be limited to the appropriation for such agency  
 34 and funds made available by law for the support of such appropriations; and  
 35 the restrictions of the State Procurement Law, the General Accounting and  
 36 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

1 Procedures and Restrictions Act, or their successors, and other fiscal  
2 control laws of this State, where applicable, and regulations promulgated by  
3 the Department of Finance and Administration, as authorized by law, shall be  
4 strictly complied with in disbursement of said funds.

5  
6 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General  
7 Assembly that any funds disbursed under the authority of the appropriations  
8 contained in this act shall be in compliance with the stated reasons for  
9 which this act was adopted, as evidenced by the Agency Requests, Executive  
10 Recommendations and Legislative Recommendations contained in the budget  
11 manuals prepared by the Department of Finance and Administration, letters, or  
12 summarized oral testimony in the official minutes of the Arkansas Legislative  
13 Council or Joint Budget Committee which relate to its passage and adoption.

15 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General  
16 Assembly, that the Constitution of the State of Arkansas prohibits the  
17 appropriation of funds for more than a one (1) year period; that the  
18 effectiveness of this Act on July 1, 2011 is essential to the operation of  
19 the agency for which the appropriations in this Act are provided, and that in  
20 the event of an extension of the legislative session, the delay in the  
21 effective date of this Act beyond July 1, 2011 could work irreparable harm  
22 upon the proper administration and provision of essential governmental  
23 programs. Therefore, an emergency is hereby declared to exist and this Act  
24 being necessary for the immediate preservation of the public peace, health  
25 and safety shall be in full force and effect from and after July 1, 2011.
