18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is
21 hereby appropriated, to the Henderson State University, to be payable from
22 the General Improvement Fund or its successor fund or fund accounts, for the
23 Henderson State University the following:

24 (A) Effective July 1, 2013, the balance of the appropriation provided
25 in Item (B) Section 1 of Act 71 of 2012, for Phase I campus renovations, in a
26 sum not to exceed.....\$2,200,000.

27 (B) Effective July 1, 2013, the balance of the appropriation provided
28 in Item (C) Section 1 of Act 71 of 2012, for local area network
29 infrastructure, in a sum not to exceed.....\$800,000.

30 (C) Effective July 1, 2013, the balance of the appropriation provided
31 in Item (D) Section 1 of Act 71 of 2012, for deferred maintenance, in a sum
32 not to exceed.....\$1,330,000.

33 (D) Effective July 1, 2013, the balance of the appropriation provided
34 in Item (E) Section 1 of Act 71 of 2012, for replacement and renewal of
35 equipment and library holdings, in a sum not to exceed.....\$620,000.

1 SECTION 2. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - GENERAL
2 IMPROVEMENT. There is hereby appropriated, to the Southern Arkansas
3 University, to be payable from the General Improvement Fund or its successor

33 in Item (F) Section 20 of Act 71 of 2012, for campus renovations and repair,
34 in a sum not to exceed.....\$2,000,000.

35 (B) Effective July 1, 2013, the balance of the appropriation provided
36 in Item (G) Section 20 of Act 71 of 2012, for technology upgrades, in a sum

1 not to exceed.....\$500,000.

2 (C) Effective July 1, 2013, the balance of the appropriation provided
3 in Item (H) Section 20 of Act 71 of 2012, for deferred maintenance, in a sum
4 not to exceed.....\$1,080,000.

5 (D) Effective July 1, 2013, the balance of the appropriation provided

9 SECTION 23. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH.

10 There is hereby appropriated, to the University of Arkansas - Fort Smith, to
11 be payable from the General Improvement Fund or its successor fund or fund
12 accounts, for the University of Arkansas - Fort Smith the following:

13 (A) Effective July 1, 2013, the balance of the appropriation provided
14 in Item (B) Section 23 of Act 71 of 2012, for the expansion and upgrade of
15 the library, in a sum not to exceed.....\$2,750,000.

16 (B) Effective July 1, 2013, the balance of the appropriation provided
17 in Item (C) Section 23 of Act 71 of 2012, for deferred maintenance, in a sum
18 not to exceed.....\$1,150,000.

19 (C) Effective July 1, 2013, the balance of the appropriation provided
20 in Item (D) Section 23 of Act 71 of 2012, for replacement and renewal of
21 equipment and library holdings, in a sum not to exceed.....\$870,000.

22 (D) Effective July 1, 2013, the balance of the appropriation provided
23 in Item (E) Section 23 of Act 71 of 2012, for personal services, operating
24 expenses, and grants to support the continuation of the Arkansas Delta
25 Training and Education Consortium University Center initiatives, in a sum not
26 to exceed.....\$116,981.

27
28 SECTION 24. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
29 obligations otherwise incurred in relation to the project or projects
30 described herein in excess of the State Treasury funds actually available
31 therefor as provided by law. Provided, however, that institutions and
32 agencies listed herein shall have the authority to accept and use grants and
33 donations including Federal funds, and to use its unobligated cash income or
34 funds, or both available to it, for the purpose of supplementing the State
35 Treasury funds for financing the entire costs of the project or projects
36 enumerated herein. Provided further, that the appropriations and funds

1 otherwise provided by the General Assembly for Maintenance and General
2 Operations of the agency or institutions receiving appropriation herein shall
3 not be used for any of the purposes as appropriated in this act.

4 (B) The restrictions of any applicable provisions of the State Purchasing
5 Law, the General Accounting and Budgetary Procedures Law, the Revenue
6 Stabilization Law and any other applicable fiscal control laws of this State
7 and regulations promulgated by the Department of Finance and Administration,
8 as authorized by law, shall be strictly complied with in disbursement of any
9 funds provided by this act unless specifically provided otherwise by law.

10
11 SECTION 25. LEGISLATIVE INTENT. It is the intent of the General
12 Assembly that any funds disbursed under the authority of the appropriations
13 contained in this act shall be in compliance with the stated reasons for
14 which this act was adopted, as evidenced by the Agency Requests, Executive
15 Recommendations and Legislative Recommendations contained in the budget
16 manuals prepared by the Department of Finance and Administration, letters, or
17 summarized oral testimony in the official minutes of the Arkansas Legislative
18 Council or Joint Budget Committee which relate to its passage and adoption.

19
20 SECTION 26. EMERGENCY CLAUSE. It is found and determined by the
21 General Assembly, that the Constitution of the State of Arkansas prohibits
22 the appropriation of funds for more than a one (1) year period; that the
23 effectiveness of this Act on July 1, 2013 is essential to the operation of
24 the agency for which the appropriations in this Act are provided, and that in
25 the event of an extension of the legislative session, the delay in the
26 effective date of this Act beyond July 1, 2013 could work irreparable harm
27 upon the proper administration and provision of essential governmental
28 programs. Therefore, an emergency is hereby declared to exist and this Act
29 being necessary for the immediate preservation of the public peace, health
30 and safety shall be in full force and effect from and after July 1, 2013.
