8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES
9 AND OPERATING EXPENSES FOR THE DEPARTMENT OF LABOR
10 AND LICENSING - WORKERS' COMPENSATION COMMISSION FOR
11 THE FISCAL YEAR ENDING JUNE 30, 2023; AND FOR OTHER
12 PURPOSES.

16 AN ACT FOR THE DEPARTMENT OF LABOR AND
17 LICENSING - WORKERS' COMPENSATION
18 COMMISSION APPROPRIATION FOR THE 2022-
19 2023 FISCAL YEAR.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES. There is hereby established for the
25 Department of Labor and Licensing - Workers' Compensation Commission for the
26 2022-2023 fiscal year, the following maximum number of regular employees.

33 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department
 34 of Labor and Licensing - Workers' Compensation Commission for the 2022-2023
 35 fiscal year, the following maximum number of part-time or temporary
 36 employees, to be known as "Extra Help", payable from funds appropriated

1 herein for such purposes: two (2) temporary or part-time employees, when
 2 needed, at rates of pay not to exceed those provided in the Uniform
 3 Classification and Compensation Act, or its successor, or this act for the
 4 appropriate classification.

6 SECTION 3. APPROPRIATION - WCC ADMINISTRATION. There is hereby
 7 appropriated, to the Department of Labor and Licensing, to be payable from
 8 the Workers' Compensation Fund, for personal services and operating expenses
 9 of the Department of Labor and Licensing - Workers' Compensation Commission -
 10 Administration for the fiscal year ending June 30, 2023, the following:

35 SECTION 7. APPROPRIATION - WORKERS' COMPENSATION COMMISSION BUILDING.

36 There is hereby appropriated, to the Department of Labor and Licensing, to be

1 payable from the Workers' Compensation Fund, for maintenance, renovation,
2 equipping, construction, improvement, upgrade and repair projects for the
3 Department of Labor and Licensing - Workers' Compensation Commission Building
4 for the fiscal year ending June 30, 2023, the following:

10 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORKERS'
12 COMPENSATION COMMISSION - INVESTMENTS. All such funds as are held at any
13 time in the Death and Permanent Total Disability Trust Fund, Second Injury
14 Trust Fund, and the Workers' Compensation Fund shall be invested and
15 reinvested to the extent feasible, all such investments as authorized for use
16 by the Office of the Treasurer shall be available to the listed funds. The
17 movement of these funds into and out of investments shall be by fund
18 transfers as directed by the Chief Executive Officer of the Workers'
19 Compensation Commission.

20 The provisions of this section shall be in effect only from July 1, ~~2021~~
21 2022 through June 30, ~~2022~~ 2023.

23 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORKERS'
25 COMPENSATION COMMISSION - REFUND TO EXPENDITURE. The proceeds from the
26 reimbursement of travel expenses received by the Arkansas Workers'
27 Compensation Commission shall be deposited into the same State Treasury Fund
28 or Fund Account from which the original travel expenditures was incurred as a
29 refund to expenditure to the credit of the appropriation from which the
30 original expenditure was made.

31 The provisions of this section shall be in effect only from July 1, ~~2021~~
32 2022 through June 30, ~~2022~~ 2023.

33
34 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
35 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORKERS'
36 COMPENSATION COMMISSION - FUND TRANSFERS. After receiving approval from the

1 Chief Fiscal Officer of the State, the Director of the Arkansas Workers'
2 Compensation Commission is authorized to transfer funds from the Second
3 Injury Trust Fund to the Death and Permanent Total Disability Trust Fund
4 and/or the Workers' Compensation Trust Fund.

5 The provisions of this section shall be in effect only from July 1, ~~2021~~
6 2022 through June 30, ~~2022~~ 2023.

7
8 SECTION 11. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
9 authorized by this act shall be limited to the appropriation for such agency
10 and funds made available by law for the support of such appropriations; and
11 the restrictions of the State Procurement Law, the General Accounting and
12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
13 Procedures and Restrictions Act, or their successors, and other fiscal
14 control laws of this State, where applicable, and regulations promulgated by
15 the Department of Finance and Administration, as authorized by law, shall be
16 strictly complied with in disbursement of said funds.

17
18 SECTION 12. LEGISLATIVE INTENT. It is the intent of the General
19 Assembly that any funds disbursed under the authority of the appropriations
20 contained in this act shall be in compliance with the stated reasons for
21 which this act was adopted, as evidenced by the Agency Requests, Executive
22 Recommendations and Legislative Recommendations contained in the budget
23 manuals prepared by the Department of Finance and Administration, letters, or
24 summarized oral testimony in the official minutes of the Arkansas Legislative
25 Council or Joint Budget Committee which relate to its passage and adoption.

26
27 SECTION 13. EFFECTIVE DATE. This act is effective on and after July 1,
28 2022.
