HB24-1173 be amended as follows:

1 Amend printed bill, page 6, after line 16 insert:

2 "(d) IF THE BOARD OF COUNTY COMMISSIONERS OF A COUNTY
3 ADOPTS THE EV CHARGER PERMITTING MODEL CODE PURSUANT TO
4 SUBSECTION (2)(a)(I) OF THIS SECTION, THE REQUIREMENTS OF
5 SUBSECTIONS (4), (5), AND (6) OF THIS SECTION DO NOT APPLY TO THE
6 COUNTY."

7 Page 7, after line 19 insert:

8 "(e) THE REQUIREMENTS OF THIS SUBSECTION (4) DO NOT APPLY TO
9 COUNTIES THAT ADOPT THE EV CHARGER PERMITTING MODEL CODE
10 PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION."

11 Page 8, after line 11 insert:

12 "(e) THE REQUIREMENTS OF THIS SUBSECTION (5) DO NOT APPLY TO
13 COUNTIES THAT ADOPT THE EV CHARGER PERMITTING MODEL CODE
14 PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION."

15 Page 9, after line 21 insert:

16 "(e) THE REQUIREMENTS OF THIS SUBSECTION (6) DO NOT APPLY TO
17 COUNTIES THAT ADOPT THE EV CHARGER PERMITTING MODEL CODE
18 PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION."

19 Page 12, after line 27 insert:

20 "(d) IF THE GOVERNING BODY OF A MUNICIPALITY ADOPTS THE EV
21 CHARGER PERMITTING MODEL CODE PURSUANT TO SUBSECTION (2)(a)(I)
22 OF THIS SECTION, THE REQUIREMENTS OF SUBSECTIONS (4), (5), AND (6) OF
23 THIS SECTION DO NOT APPLY TO THE MUNICIPALITY."

24 Page 14, after line 5 insert:

25 "(e) THE REQUIREMENTS OF THIS SUBSECTION (4) DO NOT APPLY TO
26 MUNICIPALITIES THAT ADOPT THE EV CHARGER PERMITTING MODEL CODE
27 PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION."

28 Page 14, after line 24 insert:

29 "(e) THE REQUIREMENTS OF THIS SUBSECTION (5) DO NOT APPLY TO
30 MUNICIPALITIES THAT ADOPT THE EV CHARGER PERMITTING MODEL CODE
31 PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION."

32 Page 16, after line 7 insert:

33 "(e) THE REQUIREMENTS OF THIS SUBSECTION (6) DO NOT APPLY TO
34 MUNICIPALITIES THAT ADOPT THE EV CHARGER PERMITTING MODEL CODE
35 PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION."
