

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB23-1246 be amended as follows:

1 Amend the printed bill, page 5, line 14, after "TRANSPORTATION," insert
2 "CHILD OR DEPENDENT CARE,".

3 Page 10, after line 23 insert:

4 "SECTION 4. In Colorado Revised Statutes, 23-1-104, **amend**
5 (1)(b)(I); and **add** (1)(c.5) as follows:

6 **23-1-104. Financing the system of postsecondary education -**
7 **report.** (1) (b) (I) For the 2010-11 fiscal year and for fiscal years
8 beginning on or after July 1, 2016, the general assembly shall make
9 annual appropriations of general fund money, of cash funds received from
10 tuition income, and of money that is estimated to be received by an
11 institution, under the direction and control of the governing board, as
12 stipends, as defined in section 23-18-102, and through fee-for-service
13 contracts, as authorized in section 23-1-109.7 or 23-18-303.5, whichever
14 is applicable, as a single line item to each governing board for the
15 operation of its campuses; except that, if the general assembly
16 appropriates money, as described in subsection (1)(c) of this section, to
17 the Colorado state forest service, the agricultural experiment station
18 department of the Colorado state university, ~~or~~ the Colorado state
19 university cooperative extension service, OR TO THE STATE BOARD FOR
20 COMMUNITY COLLEGES AND OCCUPATIONAL EDUCATION AS DESCRIBED IN
21 SUBSECTION (1)(c.5) OF THIS SECTION, such money shall not be included
22 within the single line item appropriations described in this subsection
23 (1)(b).

24 (c.5) IN ADDITION TO ANY APPROPRIATIONS MADE PURSUANT TO
25 SUBSECTION (1)(b) OR (1)(c) OF THIS SECTION, THE GENERAL ASSEMBLY
26 MAY MAKE ANNUAL APPROPRIATIONS OF GENERAL FUND MONEY AS
27 SEPARATE LINE ITEMS TO THE STATE BOARD FOR COMMUNITY COLLEGES
28 AND OCCUPATIONAL EDUCATION FOR THE IN-DEMAND SHORT-TERM
29 CREDENTIALS PROGRAM CREATED IN SECTION 23-60-1201.

30 **SECTION 5.** In Colorado Revised Statutes, 23-3.3-103, **add** (12)
31 as follows:

32 **23-3.3-103. Annual appropriations - repeal.** (12) (a) THE
33 PROVISIONS OF SUBSECTION (1) OF THIS SECTION CONCERNING
34 APPROPRIATIONS FOR STUDENT FINANCIAL ASSISTANCE UNDER THIS
35 ARTICLE 3.3 DO NOT APPLY TO APPROPRIATIONS MADE PURSUANT TO
36 SECTION 23-60-1201 FOR THE IN-DEMAND SHORT-TERM CREDENTIALS
37 PROGRAM.

38 (b) THIS SUBSECTION (12) IS REPEALED, EFFECTIVE JULY 1, 2027."

2 Page 11, after line 26 insert:

3 "SECTION 7. In Colorado Revised Statutes, 25-1.5-102, **amend**
4 (1)(e) as follows:

5 **25-1.5-102. Epidemic and communicable diseases - powers and**
6 **duties of department - rules - definitions.** (1) The department has, in
7 addition to all other powers and duties imposed upon it by law, the
8 powers and duties provided in this section as follows:

9 (e) For fiscal year 2022-23, the general assembly shall appropriate
10 ten million dollars from the economic recovery and relief cash fund
11 created in section 24-75-228 to the department. The department shall use
12 this appropriation for recruitment and re-engagement efforts of workers
13 in the health-care profession with current or expired licenses and staffing.
14 ANY MONEY REMAINING AT THE END OF THE 2022-23 STATE FISCAL YEAR
15 FROM THIS APPROPRIATION IS FURTHER APPROPRIATED TO THE
16 DEPARTMENT FOR THE PURPOSES OF THIS SECTION. ANY MONEY THAT IS
17 NOT EXPENDED OR OBLIGATED BY DECEMBER 30, 2024, REVERTS TO THE
18 "AMERICAN RESCUE PLAN ACT OF 2021" CASH FUND CREATED IN SECTION
19 24-75-226 (2) IN ACCORDANCE WITH SECTION 24-75-226 (4)(d). ANY
20 MONEY OBLIGATED BY DECEMBER 30, 2024, MUST BE EXPENDED BY
21 DECEMBER 31, 2026.

22 **SECTION 8.** In Colorado Revised Statutes, 25-1.5-406, **amend**
23 (9) as follows:

24 **25-1.5-406. School nurse grant program - creation - eligibility**
25 **- award of grants - rules - report - legislative declaration - definitions.**
26 (9) The general assembly shall appropriate three million dollars from the
27 economic recovery and relief cash fund created in section 24-75-228 to
28 the department for the GRANT program. ANY MONEY REMAINING AT THE
29 END OF THE 2022-23 STATE FISCAL YEAR FROM THIS APPROPRIATION IS
30 FURTHER APPROPRIATED TO THE DEPARTMENT FOR THE PURPOSES OF THIS
31 SECTION. ANY MONEY THAT IS NOT EXPENDED OR OBLIGATED BY
32 DECEMBER 30, 2024, REVERTS TO THE "AMERICAN RESCUE PLAN ACT OF
33 2021" CASH FUND CREATED IN SECTION 24-75-226 (2) IN ACCORDANCE
34 WITH SECTION 24-75-226 (4)(d) . ANY MONEY OBLIGATED BY DECEMBER
35 30, 2024, MUST BE EXPENDED BY DECEMBER 31, 2026."
