HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB24-1352 be amended as follows:

1 Amend printed bill, page 4, line 11, after "CONFIGURE" insert
2 "RESIDENTIAL".

3 Page 4, line 12, strike "OR BUILDING".

4 Page 4, lines 15 and 16, strike "MAKE FOR A NEGATIVE INCREMENTAL
5 COST FOR THIS NEW TECHNOLOGY;" and substitute "CAN MAKE THIS
6 TECHNOLOGY LESS EXPENSIVE THAN A COOLING-ONLY SYSTEM;".

7 Page 5, strike lines 2 through 4 and substitute:

8 "(2) "COLD-CLIMATE HEAT PUMP" HAS THE MEANING SET FORTH
9 IN SECTION 39-22-554."

10 Page 5, lines 11 and 12, strike "A SINGLE-FAMILY, DUPLEX, TRIPLEX, OR
11 QUADPLEX HOME;" and substitute "ONE- AND TWO-FAMILY DWELLINGS
12 AND TOWNHOUSES AS DEFINED IN THE INTERNATIONAL RESIDENTIAL
13 CODE;".

14 Page 6, line 3, strike "INSTALL,".

15 Page 6, line 4, strike the first "LEASE," and after the second "LEASE,"
16 insert "INSTALL,".

17 Page 6, line 18, strike "COLD-CLIMATE" and substitute
18 "COLD-TEMPERATURE".

19 Page 6, strike lines 19 through 25 and substitute:

20 "(II) THE COVERED HVAC UTILIZES A STANDARD,
21 NON-COLD-CLIMATE HEAT PUMP WITH SUPPLEMENTAL ELECTRIC
22 RESISTANCE HEAT THAT IS ACCOMPANIED WITH AN AFFIDAVIT SIGNED BY
23 THE PROPERTY OWNER ACKNOWLEDGING THE POTENTIAL FOR HIGHER
24 HEATING BILLS DURING TIMES WHEN THE SUPPLEMENTAL ELECTRIC
25 RESISTANCE HEAT IS IN USE;

26 (III) THE COVERED HVAC UTILIZES A STANDARD,
27 NON-COLD-CLIMATE HEAT PUMP WITHOUT SUPPLEMENTAL ELECTRIC
28 RESISTANCE HEAT THAT IS ACCOMPANIED WITH AN AFFIDAVIT SIGNED BY
29 THE PROPERTY OWNER ACKNOWLEDGING THAT THE HEAT PUMP MAY NOT
30 PROVIDE FULL HEATING IN COLD TEMPERATURES; OR

31 (IV) IF ALLOWED BY FEDERAL, STATE, OR LOCAL LAW, THE
32 COVERED HVAC OPERATES ALONGSIDE A FURNACE, WOOD STOVE, OR
33 FIREPLACE FOR SUPPLEMENTAL HEAT; AND

- 1 Page 6, line 26, strike "INFORMATION" and substitute "INFORMATION,
2 PROVIDED TO THE PROPERTY OWNER AND ATTACHED TO THE HEAT PUMP,".
- 3 Page 8, line 6, strike "SECTION." and substitute "SECTION, INCLUDING A
4 GRACE PERIOD BEFORE ENFORCEMENT PURSUANT TO SECTION 25-7-1604
5 FOR ALL OR A SUBSET OF COVERED HVAC.".
- 6 Page 8, line 17, after "(1)" insert "(a)".
- 7 Page 8, after line 21 insert:
8 "(b) THE EXECUTIVE DIRECTOR SHALL INVESTIGATE ANY CREDIBLE
9 REPORT OF AN ALLEGED VIOLATION OF SECTION 25-7-1603 (1).".
- 10 Page 9, line 7, after "25-7-1603 (1)," insert "AFTER TWO WARNING
11 LETTERS,".
- 12 Page 9, line 10, strike "COOLING," and substitute "THERMAL ENERGY,".
- 13 Page 9, lines 19 and 20, strike "STATE- OR UTILITY-MAINTAINED" and
14 substitute "STATE-MAINTAINED".
- 15 After "SOURCE" insert "FOR THE AFFECTED ROOM, ZONE, OR HOME" on:
16 **Page 6**, lines 11 and 12.
