PURPOSE: Increases the appropriation to the Department of **Higher Education** for the public institutions of higher education and financial aid by \$70,000,000 General Fund. The increases include (1) \$56,811,608 allocated to the governing boards using the performance funding (step 2) component of the higher education funding formula; and (2) \$13,188,392 for aligned financial aid increases in Need Based Grants.
