**J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$29,120 General Fund to the Office of the Governor for FY 2024-25.

## JBC Staff Analysis

**J.002** Bill sponsor amendment **J.002** (attached) adds an additional appropriation of \$400,000 cash funds from the Colorado Office of Film, Television, and Media Operational Account Cash Fund.

### Points to Consider

#### *General Fund Impact*

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund appropriation of \$29,120 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.

#### *TABOR/ Excess State Revenues Impact*

The March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast projects a TABOR surplus liability of \$1.3 billion for FY 2024-25 and \$1.8 billion for FY 2025-26 to be refunded to taxpayers out of the General Fund. These sums must be refunded to taxpayers out of the General Fund. This bill is estimated to decrease General Fund revenues by \$2.5 million in FY 2024-25 and by \$5.0 million in FY 2025-26, which will result in a decrease in the TABOR surplus liability of equal amounts.
