#### **Current Appropriations Clause in Bill**

The bill includes multiple appropriation clauses that provide, for FY 2023-24 and FY 2042-25, centrally-appropriated personal services appropriations totaling \$1.6 billion to the Departments of Corrections, Human Services, and the Judicial Department of money that originates as federal Coronavirus State Fiscal Recovery Funds (ARPA funds) and *reduces* General Fund appropriations in these departments for personal services by the same amount. The bill also changes the originating source of multiple program appropriations from being entirely ARPA funds to originating as a

combination of ARPA funds and General Fund or entirely General Fund.

# **Description of Amendments in This Packet**

**L.001** Bill Sponsor amendment **L.001** (attached) inserts a reference to "H.B. 24-1465" in place of blank references in multiple locations in the bill. The blank reference was included when the bill number for H.B. 24-1465 was unknown. This amendment does not change the bill's fiscal impact.

#### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee (JBC) has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting revenue forecast. The JBC has included as part of its FY 2024-25 budget package a net *reduction* of \$210,558,431 General Fund that results from the appropriations and transfers in this bill.
