commission (commission) authorize the creation of a regional tourism authority (authority) in connection with an approved application for a regional tourism project. The composition of the board that would govern an authority (board) is specified in statute and depends on the number of local governmental entities that will be included on the board.

The bill changes the composition of a board when the board would be comprised of more than 2 local governmental entities that are also counties. In this case, the board will be comprised of a single member who is an elected official and a single member who represents the county at large appointed by each county governmental entity and an equal number of commercial property owners within the regional tourism zone appointed by the commission.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 24-46-306 (2) (c), Colorado Revised Statutes, is  
3 amended, and the said 24-46-306 (2) is further amended BY THE  
4 ADDITION OF A NEW PARAGRAPH, to read:

5 **24-46-306. Regional tourism authority - board - creation -**  
6 **powers and duties.** (2) A regional tourism authority, if authorized, shall  
7 be governed by a board consisting of the following members:

8 (c) EXCEPT AS OTHERWISE PROVIDED IN PARAGRAPH (d) OF THIS  
9 SUBSECTION (2), if the applicant is more than two local governmental  
10 entities, a single member who is an elected official and a single member  
11 who represents the community at large appointed by each local  
12 governmental entity and ONE LESS THAN an equal number of commercial  
13 property owners within the tourism zone APPOINTED BY THE COMMISSION.

14 (d) IF THE APPLICANT IS MORE THAN TWO LOCAL GOVERNMENTAL  
15 ENTITIES THAT CONSIST OF MORE THAN TWO COUNTIES, A SINGLE MEMBER  
16 WHO IS AN ELECTED OFFICIAL AND A SINGLE MEMBER WHO REPRESENTS  
17 THE COUNTY AT LARGE APPOINTED BY EACH COUNTY GOVERNMENTAL  
18 ENTITY AND ONE LESS THAN AN EQUAL NUMBER OF COMMERCIAL  
19 PROPERTY OWNERS WITHIN THE REGIONAL TOURISM ZONE WHO ARE

1 APPOINTED BY THE COMMISSION.

2 **SECTION 2. Safety clause.** The general assembly hereby finds,  
3 determines, and declares that this act is necessary for the immediate  
4 preservation of the public peace, health, and safety.
