A BILL FOR AN ACT

101 **CONCERNING INCREASED AUTHORITY TO USE BROADCAST BURNING AS**
102 **A TOOL TO PROMOTE WATERSHED RESTORATION.**

Bill Summary

Wildfire Matters Review Committee. The bill adds broadcast burning, the method by which fire is applied generally to most or all of an area within well-defined boundaries, to the types of projects and methods for which the state forest service may award grants from the healthy forests and vibrant communities fund and the forest restoration program cash fund to help restore community watersheds.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 23-31-313, **amend**
3 (3) (g) introductory portion, (3) (g) (IV), (3) (g) (V), and (6) (a) (II) as
4 follows:

5 **23-31-313. Healthy forests - vibrant communities - funds**
6 **created - repeal.** (3) **Definitions.** As used in this section, unless the
7 context otherwise requires:

8 (g) "Wildfire risk mitigation" or "fuel ~~mitigation~~ REDUCTION
9 treatments" means preventive forest management projects or actions,
10 which meet or exceed forest service standards or any other applicable
11 state rules, that are designed to reduce the potential for unwanted impacts
12 caused by wildfires, including:

13 (IV) The secondary treatment of woody fuels by lopping and
14 scattering, piling, chipping, removing from the site, BROADCAST
15 BURNING, or prescribed burning; and

16 (V) Other nonemergency preventive activities designed to reduce
17 the unwanted impacts caused by wildfires that the forest service may
18 deem to be risk reduction or fuel ~~mitigation~~ REDUCTION treatments.

19 (6) **Community watershed restoration.** (a) In order to support
20 communities and land managers in moving from risk reduction to
21 long-term ecological restoration so that the underlying condition of
22 Colorado's forests supports a variety of values, particularly public water
23 supply and high-quality wildlife habitat, the forest service shall:

24 (II) Facilitate and work collaboratively with the division of fire
25 prevention and control, landowners, local governments, including
26 conservation districts created pursuant to article 70 of title 35, C.R.S., and

1 county noxious weed program administrators and other appropriate
2 parties, including any electric, gas, and water utilities in the affected area,
3 to design prescribed fire AND FUEL REDUCTION TREATMENT projects and
4 to encourage increased responsible use of prescribed fire AND FUEL
5 REDUCTION TREATMENTS as a tool for restoring healthy forest conditions
6 consistent with programs established pursuant to section 25-7-106 (7) and
7 (8), C.R.S., and section 24-33.5-1217, C.R.S. The forest service shall
8 emphasize providing training and technical assistance for landowners,

9 **SECTION 2. Applicability.** This act applies to conduct occurring
10 on or after the effective date of this act.

11 **SECTION 3. Safety clause.** The general assembly hereby finds,
12 determines, and declares that this act is necessary for the immediate
13 preservation of the public peace, health, and safety.
