**A BILL FOR AN ACT**

101      **CONCERNING THE STATE STOCKPILE OF ESSENTIAL MATERIALS, AND,**  
102                    **IN CONNECTION THEREWITH, BROADENING THE CIRCUMSTANCES**  
103                    **IN WHICH DISTRIBUTIONS FROM THE STOCKPILE ARE ALLOWED.**

**Bill Summary**

The state maintains a stockpile of essential materials (stockpile), including personal protective equipment, that the division of homeland security and emergency management (division), in consultation with the department of public health and environment, is authorized to distribute in response to a declared disaster emergency to any state agency, school,

local public health agency, hospital, primary care provider, other health-care provider, or any other entity or individual (eligible recipient) that the director of the division (director) determines is in need as a result of a declared disaster emergency. The bill broadens the authority of the director over the stockpile so that the director or the director's designee may distribute essential materials from the stockpile:

- Without formal consultation with the department of public health and environment; and
- After the governor has declared a disaster emergency;
- When the director or the director's designee determines that there are other circumstances in which there is a need for or benefit to distribution; or
- When the director or the director's designee determines that their distribution will enhance the ability of eligible recipients and their community partners to respond to future disaster emergencies or other circumstances in a way that would help protect public health or safety, including the distribution of essential materials for the purposes of ensuring that they can be used in normal, nonemergency times before their useful life ends. While included under current law as "any other entity", the bill also explicitly adds "nonprofit organizations" and "faith-based organizations" to the statutory list of eligible recipients.

The bill also requires the department of public safety to annually include, as part of its presentation during its "SMART Act" hearing, specified information concerning the acquisition of essential materials for and distribution of essential materials from the stockpile.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1621,  
3 **amend** (2)(b) and (3); and **add** (9) as follows:

4 **24-33.5-1621. Essential materials - stockpile - rotation -**  
5 **emergency stockpile rotation cash fund - creation - annual report -**  
6 **legislative declaration - definitions.** (2) As used in this section, unless  
7 the context otherwise requires:

8 (b) "Essential materials" means personal protective equipment,  
9 ventilators, and any other items that the director OR THE DIRECTOR'S  
10 DESIGNEE determines are necessary to respond to a disaster emergency OR

2 DISTRIBUTION OR THAT ENHANCE THE ABILITY OF STATE AGENCIES,

10 (3) (a) The division shall procure and maintain a stockpile of  
11 essential materials that are available for distribution after the governor  
12 has declared a disaster emergency in accordance with section 24-33.5-704  
13 (4), WHEN THE DIRECTOR OR THE DIRECTOR'S DESIGNEE DETERMINES THAT  
14 THERE ARE OTHER CIRCUMSTANCES IN WHICH THERE IS A NEED FOR OR  
15 BENEFIT TO DISTRIBUTION, OR WHEN THE DIRECTOR OR THE DIRECTOR'S  
16 DESIGNEE DETERMINES THAT THEIR DISTRIBUTION WILL ENHANCE THE  
17 ABILITY OF STATE AGENCIES, SCHOOLS, LOCAL PUBLIC HEALTH AGENCIES,  
18 HOSPITALS, PRIMARY CARE PROVIDERS, NONPROFIT ORGANIZATIONS,  
19 FAITH-BASED ORGANIZATIONS, TRIBAL GOVERNMENTS WITH JURISDICTION  
20 IN COLORADO, OR OTHER ENTITIES OR INDIVIDUALS AND THEIR  
21 COMMUNITY PARTNERS TO RESPOND TO CURRENT OR FUTURE DISASTER  
22 EMERGENCIES OR OTHER CIRCUMSTANCES IN A WAY THAT WOULD HELP  
23 PROTECT PUBLIC HEALTH OR SAFETY. DISTRIBUTION OF ESSENTIAL  
24 MATERIALS FOR THE PURPOSE OF ENSURING THAT THEY CAN BE USED IN  
25 NORMAL, NONEMERGENCY TIMES BEFORE THEIR USEFUL LIFE ENDS IS A USE  
26 OF SUCH MATERIALS IN A WAY THAT WOULD HELP PROTECT PUBLIC  
27 HEALTH OR SAFETY. Subject to available appropriations, the division shall

1 attempt to ensure that, in the event of a national public health emergency,  
2 the stockpile has a sufficient supply of personal protective equipment to  
3 bridge the gap until the national supply chain can increase production to  
4 meet the demand for such items.

5 (b) The division, in consultation with the department of public  
6 health and environment, may distribute the essential materials to state  
7 agencies, schools, local public health agencies, hospitals, primary care  
8 providers, ~~or~~ other health-care providers, NONPROFIT ORGANIZATIONS,  
9 FAITH-BASED ORGANIZATIONS, TRIBAL GOVERNMENTS WITH JURISDICTION  
10 IN COLORADO, or any other ~~individual~~ or entity OR INDIVIDUAL OR  
11 COMMUNITY PARTNER OF ANY OF THE FOREGOING that the director OR THE  
12 DIRECTOR'S DESIGNEE determines is in need as a result of ~~the~~ A disaster  
13 emergency, IN OTHER CIRCUMSTANCES IN WHICH THE DIRECTOR OR THE  
14 DIRECTOR'S DESIGNEE DETERMINES THAT THERE IS A NEED FOR OR BENEFIT  
15 TO SUCH DISTRIBUTION, OR WHEN THE DIRECTOR OR THE DIRECTOR'S  
16 DESIGNEE DETERMINES THAT DISTRIBUTION WILL ENHANCE THE ABILITY  
17 OF ANY SUCH ENTITY, INDIVIDUAL OR COMMUNITY PARTNER TO RESPOND  
18 TO CURRENT OR FUTURE DISASTER EMERGENCIES OR OTHER  
19 CIRCUMSTANCES IN A WAY THAT WOULD HELP PROTECT PUBLIC HEALTH OR  
20 SAFETY.

21 (9) BEGINNING IN JANUARY 2027, AND IN JANUARY EVERY YEAR  
22 THEREAFTER, THE DEPARTMENT SHALL INCLUDE, AS PART OF ITS  
23 PRESENTATION DURING ITS "SMART ACT" HEARING REQUIRED BY  
24 SECTION 2-7-203, INFORMATION CONCERNING THE ACQUISITION OF  
25 ESSENTIAL MATERIALS FOR AND DISTRIBUTION OF ESSENTIAL MATERIALS  
26 FROM THE STOCKPILE OF ESSENTIAL MATERIALS PROCURED AND  
27 MAINTAINED BY THE DIVISION PURSUANT TO SUBSECTION (3)(a) OF THIS

1 SECTION. THE REPORT SHALL INCLUDE THE FOLLOWING INFORMATION FOR  
2 EACH ACQUISITION OR DISTRIBUTION:

3 (a) THE DATE OF THE ACQUISITION OR DISTRIBUTION;

4 (b) THE TYPE AND QUANTITY OF ESSENTIAL MATERIALS ACQUIRED  
5 OR DISTRIBUTED;

6 (c) THE ENTITY OR INDIVIDUAL THAT PROVIDED OR RECEIVED A  
7 DISTRIBUTION OF ESSENTIAL MATERIALS;

8 (d) IN THE CASE OF AN ACQUISITION, THE REASON OR REASONS FOR  
9 AND COST OF THE ACQUISITION;

10 (e) IN THE CASE OF A DISTRIBUTION, THE REASON OR REASONS FOR  
11 THE DISTRIBUTION; AND

12 (f) ANY OTHER INFORMATION THAT THE DEPARTMENT OR THE  
13 DIRECTOR OR DIRECTOR'S DESIGNEE DEEMS APPROPRIATE.

14 **SECTION 2. Safety clause.** The general assembly finds,  
15 determines, and declares that this act is necessary for the immediate  
16 preservation of the public peace, health, or safety or for appropriations for  
17 the support and maintenance of the departments of the state and state  
18 institutions.
