A BILL FOR AN ACT

101 CONCERNING THE POSTING OF INFORMATION ON THE DANGERS OF
102 MARIJUANA TO A FETUS AT MEDICAL MARIJUANA CENTERS.

Bill Summary

The bill requires the department of revenue to promulgate rules regarding a requirement that a licensed medical marijuana center display in a conspicuous location a sign that warns pregnant women about the dangers to fetuses caused by smoking or ingesting marijuana while pregnant. The rules shall include the specific language regarding the warning that must be included on the sign. The bill prohibits a medical

marijuana center agent or employee from recommending medical marijuana to a pregnant woman.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-43.3-202, **add** (4)
3 as follows:

4 **12-43.3-202. Powers and duties of state licensing authority.**

5 (4) (a) RULES PROMULGATED PURSUANT TO PARAGRAPH (b) OF
6 SUBSECTION (1) OF THIS SECTION SHALL INCLUDE A REQUIREMENT THAT
7 A LICENSED MEDICAL MARIJUANA CENTER DISPLAY IN A CONSPICUOUS
8 LOCATION A SIGN THAT WARNS PREGNANT WOMEN ABOUT THE DANGERS
9 TO FETUSES CAUSED BY SMOKING OR INGESTING MARIJUANA WHILE
10 PREGNANT. THE RULES SHALL INCLUDE THE SPECIFIC LANGUAGE
11 REGARDING THE WARNING THAT MUST BE INCLUDED ON THE SIGN.

12 (b) THE COST OF THE SIGN AND DISPLAY OF THE SIGN REQUIRED BY
13 THE RULE DESCRIBED IN PARAGRAPH (a) OF THIS SUBSECTION (4) SHALL BE
14 BORNE BY THE MEDICAL MARIJUANA CENTER.

15 (c) A MEDICAL MARIJUANA CENTER AGENT OR EMPLOYEE SHALL
16 NOT RECOMMEND MEDICAL MARIJUANA TO A PREGNANT WOMAN.

17 **SECTION 2. Safety clause.** The general assembly hereby finds,
18 determines, and declares that this act is necessary for the immediate
19 preservation of the public peace, health, and safety.
