A BILL FOR AN ACT

101 **CONCERNING THE ESTABLISHMENT OF A CONTINUING PROFESSIONAL**
102 **DEVELOPMENT PROGRAM FOR LICENSED PSYCHOLOGISTS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires a licensed psychologist to complete continuing professional development and educational hours to maintain his or her license as a psychologist. The state board of psychologist examiners (board) is required to adopt rules establishing a continuing professional development program that includes:

- learning plan;
- ! A requirement that every 2 years a psychologist complete at least 40 hours of continuing professional development; and
- ! A requirement that the psychologist maintain documentation of the continuing professional development hours.

The bill allows the board to audit up to 5% of licensed psychologists each 2-year cycle to determine compliance with the requirements. The bill clarifies that the records of assessments or other documentation in connection with the continuing professional development are confidential.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** The general assembly
3 finds and declares that although there may be a shortage of mental health
4 professionals in this state to serve the needs of the people who seek their
5 help, it is important that licensed psychologists are involved in
6 professional development activities that enhance their knowledge and
7 skills in order to best meet the needs of Colorado. Therefore, it is the
8 intent of the general assembly to require continuing professional
9 development and education for licensed psychologists. In doing so, the
10 general assembly encourages each psychologist to consider the current
11 mental health needs or issues facing Colorado at the time when he or she
12 is working on his or her professional development and education.

13 **SECTION 2.** In Colorado Revised Statutes, **add** 12-43-307 as
14 follows:

15 **12-43-307. Continuing professional development - rules.** (1) IN
16 ACCORDANCE WITH SECTION 12-43-304, THE BOARD ISSUES A LICENSE TO
17 PRACTICE AS A PSYCHOLOGIST BASED ON WHETHER THE APPLICANT
18 SATISFIES MINIMUM EDUCATIONAL AND EXPERIENCE REQUIREMENTS THAT
19 DEMONSTRATE COMPETENCY TO PRACTICE AS A PSYCHOLOGIST. AFTER A

1 LICENSE IS ISSUED TO AN APPLICANT, THE LICENSED PSYCHOLOGIST SHALL
2 COMPLETE CONTINUING PROFESSIONAL DEVELOPMENT AND EDUCATIONAL
3 HOURS TO MAINTAIN HIS OR HER LICENSE AS A PSYCHOLOGIST.

4 (2) THE BOARD SHALL ADOPT RULES ESTABLISHING A CONTINUING
5 PROFESSIONAL DEVELOPMENT PROGRAM THAT INCLUDES, AT A MINIMUM,
6 THE FOLLOWING ELEMENTS:

7 (a) THE DEVELOPMENT, EXECUTION, AND DOCUMENTATION OF A
8 LEARNING PLAN;

9 (b) A REQUIREMENT THAT EVERY TWO YEARS A LICENSED
10 PSYCHOLOGIST COMPLETE AT LEAST FORTY HOURS OF CONTINUING
11 PROFESSIONAL DEVELOPMENT HOURS THAT INCLUDE A COMBINATION OF
12 THE FOLLOWING ACTIVITIES CHOSEN BY THE LICENSED PSYCHOLOGIST:

13 (I) ATTENDING WORKSHOPS; SEMINARS; SYMPOSIA; COLLOQUIA;
14 INVITED SPEAKER SESSIONS; POSTDOCTORAL INSTITUTES; OR SCIENTIFIC OR
15 PROFESSIONAL PROGRAMS OFFERED AT MEETINGS OF LOCAL, STATE,
16 REGIONAL, NATIONAL, OR INTERNATIONAL PROFESSIONAL OR SCIENTIFIC
17 ORGANIZATIONS. AT LEAST THIRTY-FIVE HOURS OF REQUIRED CONTINUING
18 PROFESSIONAL DEVELOPMENT HOURS COMPLETED PURSUANT TO THIS
19 SUBPARAGRAPH (I) MUST BE CONTINUING EDUCATION UNITS OR
20 CONTINUING MEDICAL EDUCATION CREDIT APPROVED BY THE AMERICAN
21 PSYCHOLOGICAL ASSOCIATION, STATE MEDICAL ASSOCIATION, OR
22 ACCREDITATION COUNCIL FOR CONTINUING MEDICAL EDUCATION, OR A
23 REGIONALLY ACCREDITED INSTITUTION OF HIGHER EDUCATION. A
24 LICENSED PSYCHOLOGIST MUST RETAIN A CERTIFICATE OF ATTENDANCE OR
25 A TRANSCRIPT AS DOCUMENTATION OF COMPLETION.

26 (II) DEVELOPING AND TEACHING AN ACADEMIC COURSE IN
27 PSYCHOLOGY AT AN INSTITUTION ACCREDITED BY A REGIONAL

1 ACCREDITING ASSOCIATION. CREDIT IS GIVEN FOR THE FIRST TIME THE
2 LICENSED PSYCHOLOGIST TEACHES THE COURSE, AS DOCUMENTED BY THE
3 DEAN OR HEAD OF THE DEPARTMENT OF THE INSTITUTION IN WHICH THE
4 COURSE WAS TAUGHT, AND IS BASED ON THE NUMBER OF CREDIT HOURS,
5 UNITS, OR HOURS ASSIGNED BY THE INSTITUTION. ONE ACADEMIC CREDIT,
6 UNIT, OR HOUR IS EQUIVALENT TO TEN CONTINUING PROFESSIONAL
7 DEVELOPMENT HOURS.

8 (III) SATISFACTORILY COMPLETING A GRADUATE COURSE IN
9 PSYCHOLOGY OFFERED BY AN INSTITUTION ACCREDITED BY A REGIONAL
10 ACCREDITING ASSOCIATION AND DOCUMENTED BY AN ACADEMIC
11 TRANSCRIPT SHOWING THE GRADUATE CREDITS EARNED. ONE ACADEMIC
12 CREDIT, UNIT, OR HOUR IS EQUIVALENT TO TEN CONTINUING PROFESSIONAL
13 DEVELOPMENT HOURS.

14 (IV) DEVELOPING AND PRESENTING FOR THE FIRST TIME A
15 WORKSHOP, SEMINAR, SYMPOSIUM, COLLOQUIUM, INVITED SPEAKING
16 SESSION, OR MEETING OF A PROFESSIONAL OR SCIENTIFIC ORGANIZATION
17 OR A POSTDOCTORAL INSTITUTE, DOCUMENTED BY A PRINTED PROGRAM
18 OR AGENDA. ONE HOUR OF WORKSHOP, SYMPOSIUM, OR COLLOQUIAL
19 PRESENTATION IS EQUIVALENT TO THREE CONTINUING PROFESSIONAL
20 DEVELOPMENT HOURS.

21 (V) AUTHORIZING, EDITING, OR REVIEWING A PSYCHOLOGY
22 PUBLICATION IN THE FIRST YEAR OF THE PUBLICATION OR DISTRIBUTION,
23 DOCUMENTED BY A PUBLICATION COVER SHEET, MASTHEAD, OR TABLE OF
24 CONTENTS. THE MAXIMUM HOURS MAY BE EARNED AS FOLLOWS:

25 (A) AUTHORIZING A PROFESSIONAL OR SCIENTIFIC BOOK IS
26 EQUIVALENT TO FORTY HOURS OF CONTINUING PROFESSIONAL
27 DEVELOPMENT HOURS;

1 (B) AUTHORIZING A PROFESSIONAL OR SCIENTIFIC BOOK CHAPTER OR
2 JOURNAL ARTICLE IS EQUIVALENT TO TWENTY HOURS OF CONTINUING
3 PROFESSIONAL DEVELOPMENT HOURS;

4 (C) EDITING A PROFESSIONAL OR SCIENTIFIC BOOK OR JOURNAL IS
5 EQUIVALENT TO THIRTY HOURS OF CONTINUING PROFESSIONAL
6 DEVELOPMENT HOURS;

7 (D) REVIEWING A JOURNAL ARTICLE IS EQUIVALENT TO ONE HOUR
8 OF CONTINUING PROFESSIONAL DEVELOPMENT PER MANUSCRIPT;

9 (c) A REQUIREMENT THAT EACH LICENSED PSYCHOLOGIST
10 MAINTAIN ALL DOCUMENTATION FOR HIS OR HER CONTINUING
11 PROFESSIONAL DEVELOPMENT HOURS.

12 (3) A LICENSED PSYCHOLOGIST IS NOT REQUIRED TO RECEIVE
13 PREAPPROVAL FROM THE BOARD OR OTHER ENTITY PRIOR TO THE
14 COMPLETION OF A CONTINUING PROFESSIONAL DEVELOPMENT ACTIVITY IN
15 ORDER TO RECEIVE CREDIT FOR THE CONTINUING PROFESSIONAL
16 DEVELOPMENT HOURS.

17 (4) THE BOARD MAY AUDIT UP TO FIVE PERCENT OF LICENSED
18 PSYCHOLOGISTS EACH TWO-YEAR CYCLE TO DETERMINE COMPLIANCE
19 WITH CONTINUING PROFESSIONAL DEVELOPMENT REQUIREMENTS.

20 (5) (a) RECORDS OF ASSESSMENTS OR OTHER DOCUMENTATION
21 DEVELOPED OR SUBMITTED IN CONNECTION WITH THE CONTINUING
22 PROFESSIONAL DEVELOPMENT PROGRAM ARE CONFIDENTIAL AND NOT
23 SUBJECT TO INSPECTION BY THE PUBLIC OR DISCOVERY IN CONNECTION
24 WITH A CIVIL ACTION AGAINST A LICENSED PSYCHOLOGIST. THE RECORDS
25 OR DOCUMENTS SHALL BE USED ONLY BY THE BOARD FOR THE PURPOSE OF
26 DETERMINING WHETHER A LICENSED PSYCHOLOGIST IS MAINTAINING
27 CONTINUING PROFESSIONAL DEVELOPMENT NECESSARY TO ENGAGE IN THE

1 PROFESSION.

2 (b) SUBJECT TO THE REQUIREMENTS OF PARAGRAPH (a) OF THIS
3 SUBSECTION (5), NOTHING IN THIS SECTION SHALL BE CONSTRUED TO
4 RESTRICT THE DISCOVERY OF INFORMATION OR DOCUMENTS THAT ARE
5 OTHERWISE DISCOVERABLE UNDER THE COLORADO RULES OF CIVIL
6 PROCEDURE IN CONNECTION WITH A CIVIL ACTION AGAINST A LICENSED
7 PSYCHOLOGIST.

8 **SECTION 3. Act subject to petition - effective date.** This act
9 takes effect at 12:01 a.m. on the day following the expiration of the
10 ninety-day period after final adjournment of the general assembly (August
11 5, 2015, if adjournment sine die is on May 6, 2015); except that, if a
12 referendum petition is filed pursuant to section 1 (3) of article V of the
13 state constitution against this act or an item, section, or part of this act
14 within such period, then the act, item, section, or part will not take effect
15 unless approved by the people at the general election to be held in
16 November 2016 and, in such case, will take effect on the date of the
17 official declaration of the vote thereon by the governor.
