**Committee on Legal Services.** This bill enacts the softbound volumes of Colorado Revised Statutes 2012 and the 2012 special supplement as the positive and statutory law of the state of Colorado and establishes the effective date of said publications.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 2-5-126, **add** (2) (p)  
3 as follows:

4           **2-5-126. Annual enactment of Colorado Revised Statutes -**  
5 **validation - effective date.** (2) The annual statutes, copies of which shall  
6 be delivered to each member of the general assembly, together with a  
7 listing of the revisor's changes, constitute the official report of the  
8 committee on legal services and are hereby enacted in accordance with  
9 this section as follows:

10           (p) **Colorado Revised Statutes 2012.** COLORADO REVISED  
11 STATUTES 2012, INCLUDING THE 2012 SPECIAL SUPPLEMENT, WHICH  
12 CONSISTS OF ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL  
13 AND PERMANENT NATURE ORIGINALLY ENACTED IN "COLORADO REVISED  
14 STATUTES 1973", INCLUDING SUBSEQUENT ENACTMENTS MADE PURSUANT  
15 TO SECTION 2-5-125, AND ALL OF THE LAWS OF THE STATE OF COLORADO  
16 OF A GENERAL AND PERMANENT NATURE ENACTED AT THE SECOND  
17 REGULAR SESSION AND THE FIRST EXTRAORDINARY SESSION OF THE  
18 SIXTY-EIGHTH GENERAL ASSEMBLY AND AT THE GENERAL ELECTION ON  
19 NOVEMBER 6, 2012. THE EFFECTIVE DATE FOR COLORADO REVISED  
20 STATUTES 2012 IS FIXED AS THE FIRST DAY THAT IS NOT A SATURDAY,  
21 SUNDAY, OR LEGAL HOLIDAY FOLLOWING THE EFFECTIVE DATE OF THIS  
22 PARAGRAPH (p).

23           **SECTION 2. Safety clause.** The general assembly hereby finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, and safety.
