Bill Summary

The bill prohibits a judgment against a board of county commissioners arising solely from an act of the board from being enforced against an individual member of the board.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, amend 30-11-105 as
3	follows:
4	30-11-105. Suits by or against county. (1) In all suits or
5	proceedings by or against a county, the name in which the county shall
6	sue or be sued shall be, "The board of county commissioners of the
7	county of; but this provision shall not prevent county officers.
8	when authorized by law, from suing in their name of office for the benefit
9	of the county.
10	(2) ANY JUDGMENT AGAINST A BOARD OF COUNTY
11	COMMISSIONERS ARISING SOLELY FROM AN ACT OF THE BOARD EXERCISING
12	ITS AUTHORITY AS THE GOVERNING BODY OF A COUNTY SHALL NOT BE
13	ENFORCED AGAINST ONE OR MORE INDIVIDUAL MEMBERS OF THE BOARD.
14	NOTHING IN THIS SUBSECTION (2) PREVENTS THE JOINDER OF ONE OR MORE
15	INDIVIDUAL MEMBERS OF A BOARD OF COUNTY COMMISSIONERS IN THE
16	SAME OR A SEPARATE ACTION OR APPLIES TO A CASE WHERE AN
17	INDIVIDUAL MEMBER OF A BOARD OF COUNTY COMMISSIONERS IS FOUND
18	INDIVIDUALLY LIABLE FOR A VIOLATION OF LAW.
19	SECTION 2. Act subject to petition - effective date. This act
20	takes effect at 12:01 a.m. on the day following the expiration of the
21	ninety-day period after final adjournment of the general assembly (August
22	5, 2015, if adjournment sine die is on May 6, 2015); except that, if a
23	referendum petition is filed pursuant to section 1 (3) of article V of the
24	state constitution against this act or an item, section, or part of this act
25	within such period, then the act, item, section, or part will not take effect
26	unless approved by the people at the general election to be held in
