101 **CONCERNING THE INCLUSION OF LIQUEFIED PETROLEUM GAS**
102 **CONVERSION VEHICLES IN THE LIST OF QUALIFIED VEHICLES**
103 **AVAILABLE FOR EFFICIENT MOTOR VEHICLE INCENTIVES.**

Bill Summary

The bill clarifies that liquefied petroleum gas (also known as propane) conversion vehicles are already included in the definition of category 4 motor vehicles that qualify for the income tax credit for purchases of vehicles using alternative fuels and the rebate for motor

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 39-22-516 (2.6) (a) (VI), Colorado Revised
3 Statutes, is amended to read:

4 **39-22-516. Tax credit for purchase of vehicles using**
5 **alternative fuels - repeal.** (2.6) (a) As used in this subsection (2.6),
6 unless the context otherwise requires:

7 (VI) "Category 4" means light duty passenger vehicle, light duty
8 truck, and medium duty truck compressed natural gas OR LIQUEFIED
9 PETROLEUMGAS conversions certified by the United States environmental
10 protection agency and original equipment manufacturer compressed
11 natural gas vehicles.

12 **SECTION 2.** 39-22-516.5 (1) (f), Colorado Revised Statutes, is
13 amended to read:

14 **39-22-516.5. Tax credit for innovative motor vehicles - repeal.**

15 (1) As used in this section, unless the context otherwise requires:

16 (f) "Category 4" means light duty passenger vehicle, light duty
17 truck, and medium duty truck compressed natural gas OR LIQUEFIED
18 PETROLEUMGAS conversions certified by the United States environmental
19 protection agency and original equipment manufacturer compressed
20 natural gas vehicles.

21 **SECTION 3.** 39-33-101 (6), Colorado Revised Statutes, is
22 amended to read:

23 **39-33-101. Definitions - repeal.** As used in this article, unless
24 the context otherwise requires:

25 (6) "Category 4" means light duty passenger vehicle, light duty

1 truck, and medium duty truck compressed natural gas OR LIQUEFIED
2 PETROLEUMGAS conversions certified by the United States environmental
3 protection agency and original equipment manufacturer compressed

5 **SECTION 4. Applicability.** This act shall apply to the tax years
6 commencing on or after January 1, 2011.

7 **SECTION 5. Safety clause.** The general assembly hereby finds,
8 determines, and declares that this act is necessary for the immediate
9 preservation of the public peace, health, and safety.
