Acute treatment units (ATU) provide medically supervised behavioral health treatment services to individuals who suffer from psychiatric disorders. Current law does not allow an ATU to have an onsite stock of medications. The bill allows an ATU to procure, store,

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-42.5-102, **amend**  
3 (25) (a) introductory portion as follows:

4 **12-42.5-102. Definitions.** As used in this article, unless the  
5 context otherwise requires or the term is otherwise defined in another part  
6 of this article:

7 (25) "Other outlet" means:

8 (a) A hospital that does not operate a registered pharmacy, A rural  
9 health clinic, A federally qualified health center, as defined in section  
10 1861 (aa) (4) of the federal "Social Security Act", 42 U.S.C. sec. 1395x  
11 (aa) (4), A family planning clinic, AN ACUTE TREATMENT UNIT LICENSED  
12 BY THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT, A school, A  
13 jail, A county or district public health agency, A community health clinic,  
14 A university, or A college that:

15 **SECTION 2.** In Colorado Revised Statutes, 12-42.5-118, **amend**  
16 (5) (a) (III) (B) and (5) (a) (III) (C); and **add** (5) (a) (III) (D) as follows:

17 **12-42.5-118. Compounding - dispensing - sale of drugs and**  
18 **devices - rules.** (5) (a) A registered prescription drug or licensed hospital  
19 other outlet may:

20 (III) Supply an emergency kit or starter dose, as defined by the  
21 board by rule, to:

22 (B) Any home health agency licensed by the department of public  
23 health and environment and approved by the board for receipt of an  
24 emergency kit; and

1           (C) Any licensed hospice approved by the board for receipt of an  
2 emergency kit in compliance with subsection (12) of this section; AND

3           (D) ANY ACUTE TREATMENT UNIT LICENSED BY THE DEPARTMENT  
4 OF PUBLIC HEALTH AND ENVIRONMENT AND APPROVED BY THE BOARD FOR  
5 RECEIPT OF AN EMERGENCY KIT.

6           **SECTION 3. Safety clause.** The general assembly hereby finds,  
7 determines, and declares that this act is necessary for the immediate  
8 preservation of the public peace, health, and safety.
