Bill Summary

With certain exceptions, a local government is currently required to obtain voter approval and meet other requirements before providing internet access (advanced service) to the public. The bill specifies that these requirements do not apply to a school district providing advanced service that enables students, teachers, and staff members of the district

to access a school-owned and operated network to facilitate remote learning.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 29-27-302, add (5) 3 as follows: 4 **29-27-302.** Scope of article. (5) NOTHING IN PART 1 OR PART 2 5 OF THIS ARTICLE 27 SHALL BE CONSTRUED TO APPLY TO A SCHOOL 6 DISTRICT OR BOARD OF COOPERATIVE SERVICES, CREATED PURSUANT TO 7 ARTICLE 5 OF TITLE 22, PURCHASING, LEASING, CONSTRUCTING, 8 MAINTAINING, OR OPERATING FACILITIES THAT ARE DESIGNED TO 9 EXCLUSIVELY PROVIDE ADVANCED SERVICE THAT ENABLES STUDENTS, 10 TEACHERS, AND STAFF MEMBERS OF THE DISTRICT, THE BOARD OF 11 COOPERATIVE SERVICES, OR THE MEMBER DISTRICTS OF THE BOARD OF 12 COOPERATIVE SERVICES, TO ACCESS A SCHOOL-OWNED AND OPERATED 13 NETWORK TO FACILITATE REMOTE LEARNING. 14 **SECTION 2.** Safety clause. The general assembly hereby finds, 15 determines, and declares that this act is necessary for the immediate
